| <p>TE TORO PEARL (M Coleman) – Raced ungenerously in the early stages and was obliged to race three wide without cover throughout.</p> <p>COMEBACK (R Elliot) – Began awkwardly. Restrained off heels near the 1000 metres.</p> <p>SOCIALLY EXCITED (M Cameron) - When questioned regarding performance rider M Cameron could offer no tangible excuses. A subsequent veterinary examination could find no obvious abnormality.</p> | |

| Race 2 | AONGATETE COOLSTORES LIMITED PREMIER (1200 metres) |
| <p>MIGHTY ME (T Thornton) – Steadied passing the 900 metres when racing in restricted room to the outside of PERFECT HARMONEE which made the bend awkwardly.</p> | |
| Race 3 | SEEKA PREMIER (1600 metres) |
| <p>CALL ME ROYAL (T Newman) – Began awkwardly.</p> <p>VALANTE (S Collett) - Slow to begin.</p> <p>TIME BOMB (M Tanaka) - Began awkwardly.</p> <p>ST SATURNIN (D Danis) – Began awkwardly. Raced keenly approaching the 800 metres.</p> <p>T Thornton (PADRAIG) - Spoken to regarding the manner in which she used her whip.</p> <p>M Tanaka (TIME BOMB) - Spoken to regarding the manner in which he used his whip.</p> <p>GRAND RIO - (M Cameron) – When questioned regarding performance M Cameron advised that the gelding may be better suited when there is rain on the day. A post-race veterinary examination could find no obvious abnormalities.</p> | |

| <p>ONAWING (M Tanaka) – Slow away.</p> <p>SUGGESTIVE HEIGHTS (E McCall) - Bounded leaving the barriers losing ground. Raced keenly in the early stages then crowded and steadied approaching the 1700 metres and made the bend awkwardly, forcing EL DISPARO wider.</p> <p>J Riddell (PESO) - Issued with warning after allowing PESO to shift in passing the 1700 metres when insufficiently clear of SUGGESTIVE HEIGHTS which was hampered and steadied.</p> <p>SULIMAN (S Collett) - Raced in restricted room 1700 metres and the commenced to race ungenerously making the bend awkwardly.</p> <p>EL DISPARO (D Danis) - Forced wide 1700 metres.</p> <p>PRINCESS EL JAY (M Cameron) – Failed to respond when placed under pressure from near the 800 metres and was not persevered with in the final straight. Rider M Cameron advised the mare may be feeling the effects of recent racing. A post-race veterinary examination could find no obvious abnormalities.</p> <p>CENTURY MISS (M Coleman) – Rider M Coleman could offer no excuses for the performance.</p> | |

| <p>COSSACK WARRIOR (J Riddell) – Began awkwardly.</p> <p>I'MA SHYGIRL (R Elliot) - Began awkwardly then crowded.</p> <p>FALKIRK LASS (K Cowan) - Began awkwardly.</p> <p>TWEEDLEDEE (C Lammas) – Commenced to over race when being restrained for a distance from near the 1200 metres shifting out to avoid heels.</p> <p>IT'S A KINDA MAGIC (A Calder) – Raced in restricted room near the 900 metres then hampered to the outside of FALKIRK LASS which made the bend awkwardly.</p> <p>A Calder (IT'S A KINDA MAGIC) - Reminded of his obligations regarding whip use on a runner that is out of contention.</p> <p>S Rusof (OUTSIDER) - Reminded of his obligations of his whip use on a runner that is out of contention.</p> | |

| <p>UNDERTHEMOONLIGHT (C Lammas) – Began awkwardly losing ground.</p> <p>ODISHA (S Collett) – Crowded shortly after the start having to be steadied.</p> <p>T Harris (TOMELILLA) - Was reminded of his obligations in that he must fully ride his mounts out to the end of the race when circumstances permit him to do so.</p> <p>C Lammas (UNDERTHEMOONLIGHT) - Stood down following the race after becoming dehydrated and feeling the effects of a cold.</p> | |

| <p>SECONDS OUT (D Danis) – Crowded shortly after the start and clipped heels, blundering losing ground (5L). Steadied near the 50 metres when in restricted room to the inside of TRUEMAN (J Parkes) which shifted in and away from BRANSOME which shifted in before being corrected by its rider. J Parkes was advised he must exercise greater care in a similar circumstance.</p> <p>BLACKJACK MAN (T Harris) - Began awkwardly.</p> <p>SOUND WORKS (S McKay) - Steadied when awkwardly placed on heels passing the 450 metres.</p> <p>IMPULSIVE HABIT (T Thornton) – When questioned rider T Thornton could offer no tangible excuses.</p> | |
