**RACE COMMENTS:**

<b>Race 1</b>	<b>RAYNER BULDING 2YO (1200 metres)</b>
<p><b>LINCOLN HANOVER</b> (R Hannam) – Awkwardly away settling back.</p> <p><b>RIPSOMEMORE</b> (D Bradley) – Raced keenly in the early stages and when being restrained shifted inwards contacting MERYACE near the 1000 metres. Held up, having to be restrained near the 350 metres.</p> <p><b>B Grylls</b> (MERYACE) was reminded of her obligations to ride her mounts fully to the finish when able to do so after she was seen to relax her ride over the final stages.</p>	
<b>Race 2</b>	<b>RANGITIKEI TYRE CENTRE 3YO (1200 metres)</b>
<p><b>PLATINUM VOLOS</b> (J Riddell) – Slow away.</p> <p><b>BELLA PADOZA</b> (M Singh) – Returned to the enclosure with blood present in both nostrils. After undergoing a veterinary inspection, the filly was confirmed to have bled. BELLA PADOZA is now unable to be in training for two months and is unable to trial or race for three months with a veterinary clearance required prior to racing or trialling next.</p> <p><b>SWISS HAZE</b> (B Grylls) – When questioned into performance rider advised the gelding had not appreciated today's heavy track conditions. A subsequent veterinary inspection was clear.</p> <p><b>BACK IN A FLASH</b> (R Myers) - Returned to the enclosure with blood present in a nostril. A subsequent veterinary examination revealed a minor laceration to the nasal area.</p>	
<b>Race 3</b>	<b>COOMBE SMITH RANGITIKEI HANDICAP (1200 metres)</b>
<p><b>CARSON RIVER</b> (W Pinn) – Raced keenly for a distance passing the 1000 metres.</p> <p><b>SMOKEN' ACE</b> (R Hannam) – Finished last. When questioned into the performance rider advised the gelding may not have appreciated today's holding track conditions. A subsequent veterinary inspection revealed the gelding to have fibrillated. Connections were advised that SMOKEN' ACE will be required to gallop not less than 1000 metres in the presence of a veterinary surgeon and a clearance received prior to racing next.</p>	
<b>Race 4</b>	<b>KELLY &amp; ASSOCIATES MAIDEN (1400 metres)</b>
<p><b>BEN JOVI</b> (J Riddell) – Bounded at the start losing ground.</p> <p><b>TALK BACK</b> (W Pinn) – Gave ground quickly approaching the 600 metres so was not persevered with when out of contention. Returned to the enclosure with blood present in both nostrils. After undergoing a veterinary inspection, the gelding was confirmed to have bled. TALK BACK is now unable to be in training for two months and is unable to trial or race for three months with a veterinary clearance required prior to racing or trialling next.</p> <p><b>MASTER BEN</b> (R Hannam) – Finished well back. When questioned into the performance rider advised the gelding had not appreciated today's track conditions, which he described as holding.</p> <p><b>CASSINO TO TRIESTE</b> (L Allpress) – Held up for a short distance approaching the 400 metres.</p> <p><b>R Jones</b> (SOUND THE SIREN) – Was spoken to regarding his whip use prior to the 100 metres.</p>

**SYLVESTER** (C O’Beirne) – Lay inwards early in the home straight.

**L Latta** (PLATINUM EDITION) –Issued with a warning under Rule 616(2) after presenting the gelding in non-notified blinkers.

**THE HUNTSMAN** (S MacNab) – Awkwardly away.

**MAGIC IVAN** (C O’Beirne) – Slow away.

**MASTER PATRICK** (D Bradley) – Slow away.

**AVASTIN** (L Allpress) - Raced keenly in the early stages. Held up for a distance from the 600 metres.

**CORNERSTONE** (J Parkes) – Had to be restrained off heels near the 1700 metres. When questioned into performance rider had no excuses. A post-race veterinary inspection was clear.

**PLATINUM COMMAND** (R Myers) – Slow away.

**DARCI MAC** (D Turner) – Raced ungenerously for a short distance when being restrained early in the race. Lay out under pressure in the home straight.

**OUR BANDIT** (B Grylls) – When questioned into performance rider could offer no excuse. A subsequent veterinary inspection was clear.

**GORBACHEV** (C O’Beirne) – Slow away.

**TIPICAL** (B Grylls) – Raced keenly in the early stages.

**DIRECT CAPITAL** (T Allan) – Raced keenly in the early stages.

**DEZ** (J Parkes) – Held up approaching the 600 metres having to be angled back towards the inside to improve near the 450 metres. Held up for a short distance near the 150 metres.

**S O’Malley** (HIG QUALITY) – Issued with a warning regarding the use of his whip prior to the 100 metres.

**C O’Beirne** (GORBACHEV) – Issued with a warning regarding the use of her whip prior to the 100 metres.

**FINN** (D Turner) When questioned into performance rider advised the gelding did not appreciate today’s track conditions.

**CRAFTY JESS** (J Riddell) - When questioned into performance rider advised that after working hard in the early stages the mare had little left at the finish. A post-race veterinary inspection showed a slow post-race recovery.
