RACE COMMENTS:

Race 1	NZB INSURANCE PEARL SERIES RACE (800 metres)
SUGAR BOMB (R Elliot) - Jumped away awkwardly.	

MEXICAN TYCOON (J Riddell) - Jumped away awkwardly.

ANNEAL (R Myers) – Raced ungenerously rounding the bend near the 600 metres. Held up near the 350 metres and was unable to obtain clear running for the remainder of the race.

POSH POROTENE (J Parkes) - Raced ungenerously rounding the bend near the 600 metres. Inclined to lay inwards in the final straight proving reluctant to improve into a tight run then being held up until inside the final 100 metres.

SWEET ELVIRA (T Allan) – Had difficulty obtaining clear running throughout the final straight.

ATROPOS (T Yanagida) - Raced in restricted room for much of the final straight.

ROMANOV GIRL (L Allpress) - Placed in restricted room approaching the 100 metres to the inside of SOMEWHERE MAN which lay in and away from EASTERN WARRIOR, then being inclined to lay in for the remainder of the race.

CALL ME JACK (T Allan) – Underwent and passed a veterinary inspection prior to the start after making contact with a rail in the enclosure.

REKOHU DIVA (D Turner) – Lay in after jumping away making contact with the hind quarters of CALL ME JACK having to be steadied losing ground.

EUROSTAR (L Allpress) – Over-raced when being restrained in the early stages.

DONTGIVEADAM (S Collett) - Raced three wide without cover throughout.

A Jones (GOODNIGHT IRENE) – Defended a charge in that she failed to ride her mount out to the end of the race when a chance of finishing in a higher placing. After viewing films and hearing submissions the Judicial Committee found the charge proven suspending A Jones licence to ride in races from the conclusion of racing on Wednesday, 25 July up to and including racing on Wednesday, 8 August (2 weeks).

C Lammas (SURPRISEUS) - Spoken to regarding his whip use prior to the 100 metres.

MY TOMMY (L Allpress) – Slow away.

CAMEAHOTFRIDAY (S Collett) - Jumped away awkwardly. Lay in under pressure over the final stages.

BELLE CANTO (C O'Beirne) - Jumped away awkwardly.

LINCOLN HILLS (J Riddell) – Rider could offer no excuse. Underwent a post-race veterinary examination which was clear.

Race 4	JIMMY RURAL 3YO (1200 metres)

T Johnson - Fined \$200 under the minor infringement schedule after being unable to make the contracted weight for ETOILE D'AMOUR.

ETOILE D'AMOUR – M Singh replaced T Johnson who was unable to make the agreed weight.

PINK GRAFFITI (B Grylls) - Underwent and passed a veterinary check prior to the start after kicking a rail. Made the bend approaching the 800 metres awkwardly, having to be steadied near the 700 metres.

MR AXLE (L Allpress) – Crowded leaving the barriers, over-raced in the early stages having to be firmly restrained to avoid heels going into the bend near the 800 metres and shifted outwards hampering MEDAGLIA VELOCE which was forced across heels having to be checked, continued to over-race then made the bend awkwardly shifting outwards across heels racing wide and improving forward from that point.

MEDAGLIA VELOCE (C Lammas) - Checked when hampered 800 metres.

NEBRASKA (C-M Waddell) - Raced wide without cover.

GOLDILICIOUS (R Elliot) – Disappointed for a run approaching the 200 metres having to steady and shift inwards across heels.

KIRKLAND (J Parkes) – Raced wide without cover.

CANDY CROSS (C-M Waddell) – Raced keenly in the early and middle stages.

BELLA ROCCIA (S Collett) – Raced ungenerously when being restrained passing the 1000 metres.

MY ZED (L Allpress) – Raced keenly in the early and middle stages.

BELINDABELLA (T Johnson) – Blundered near the 400 metres.

C O’Beirne (NO TIP) – Issued with a warning after permitting her mount to shift inwards shortly after the start when not sufficiently clear of THEDEVILWEARSPRADA and continuing to shift inwards when not fully clear of WITCH HAZEL, which had to be steadied. Stewards also took into account some outward movement from SHADY LADY forcing VANNOSS out on to WITCH HAZEL with THE HEIRESS also being hampered.

THEDEVILWEARSPRADA (S MacNab) - Checked leaving the barriers when NO TIP shifted inwards, continued to race ungenerously for a distance.

THE HEIRESS (S Collett) - Hampered shortly after the start.

WITCH HAZEL (M Singh) – Hampered shortly after the start.

CASTLE BLACK (C Johnson) - When questioned rider could offer no excuse.

Race 7	FARMERS TRANSPORT 1650 (1650 metres)

OBRIGADO (R Myers) - Slow away.

ELAMO (J Riddell) – Slow away.

STEVIE’S SURPRISE (C Johnson) – Raced keenly when wide going into the first turn being restrained to the rear to obtain cover, had difficulty obtaining clear running in the home straight before being angled outwards across heels to gain clear running approaching the 100 metres.

C-M Waddell (HANDYMAN) – Issued with warning under Rule 638(3)(b)(ii) for excessive use of her whip prior to the 100 metres.

J Riddell was issued with a warning after permitting his mount to shift inwards when not sufficiently clear.</p> <p>GORBACHEV (C O'Beirne) - Lay out under pressure in the final straight.</p> <p>ANGELINE (L Allpress) - When questioned rider could offer no excuse. A subsequent veterinary inspection was clear.</p>
