LOWRIDER (R Smyth) - Contacted leaving the barrier. Crowded over the final 50 metres and steadied.

AMEN CORNER (J Fawcett) - Crowded soon after leaving the barriers.

CLARIOS (M Coleman) – Made the turn approaching the 800 metres awkwardly shifting out across heels. Steadied approaching the 250 metres when becoming awkwardly placed on heels and then shifted in to obtain clear running.

PACO LAD (J Riddell) - Crowded over the final 50 metres and steadied, when improving into a marginal run to the inside of SHEEZNOTEASY which shifted in slightly.

Race 6 COLIN WEST PANELBEATERS 1200

ROUGH CONDUCT (B Grylls) - Over raced early and middle stages.

SIMPLY IMPECCABLE (M Coleman) – Not persevered with from near the 200 metres after failing to respond when placed under pressure. Rider M Coleman advised that the gelding had felt to have choked down making abnormal noises. A post-race veterinary examination could find no obvious abnormalities.

Race 7 NORWOOD FARM MACHINERY 2000

ROCKING GOOD TIME (J Riddell) - Began awkwardly losing ground.

R Elliot (DEFER) - Issued with a warning for using his whip excessively prior to the 100 metres.

Race 8 FAIRVIEW MOTORS 2000

RAY'S LEGACY (R Elliot) – Became tailed off and was not persevered with from near the 600 metres. A post-race veterinary examination could find no obvious abnormalities.

HORSEY HORSE HORSE (R Novall) – Crowded shortly after the start.

TWIN SPINNER (G Cooksley) – Began awkwardly. Crowded and steadied passing the 150 metres.

J Waddell (LOTHBROK) - Issued with a warning after allowing LOTHBROK to shift in passing the 150 metres when insufficiently clear of TWIN SPINNER which was crowded and steadied with Stewards taking into account outward movement from CASSIO.

C Lammas (CASSIO) – Issued with a warning for using his whip excessively prior to 100 metres.
