## **GENERAL:**

## SUPPLEMENTARY:

Race 1HIGGINS CONCRETE HURDLES (2500 Metres)PRIZE LAD (B Lammas) – Put in a poor jump at the second fence losing ground.

**ST RANSOM** (G Walsh) - Hit the fence near the 400 metres.

**ONEFORTHEDITCH** (A Kuru) –Poor jump second to last fence.

**C Studd** – Rider of ZED LEPPELIN was shown a video of the concluding stages where he had relaxed his ride approximately 7 strides from the finish when clearly in 3<sup>rd</sup> position and was beaten by THATZ DAVID with the margin being a short neck. The gelding underwent a post-race veterinary examination which did not reveal any abnormalities. C Studd defended a charge under Rule 636(1)(d) in that he failed to ride his mount out to the finish of the race.After hearing submissions from the Stipendiary Stewards and connections, of the gelding the Judicial Control Authority found the charge proved and C Studd had his licence to ride in races suspended from the conclusion of racing on Saturday, 28 July up to and including Friday, 24 August 2018.

#### Race 2 MANAWATU ITM STEEPLECHASE (4000 Metres)

**PERRY MASON** (A Kuru) - Put in a poor jump at the third fence on the first occasion. Ran down the fence near the 1100 metres inconveniencing YIPSON.

**YIPSON** (I Lupton) - Raced keenly in the middle stages.

**MAILLY** (M Cropp) - Pulled up prior to the second to last fence when out of contention. Rider reported the gelding had felt indifferent in its action. A post-race veterinary inspection revealed no obvious abnormalities.

#### Race 3 THE HANLEY FORMULA MAIDEN STEEPLECHASE (3200 Metres)

**CRIKEY CRON** (S Higgins) - Misjudged the first fence.

**COUNTER ATTACK** (M Cropp) – Jumped the first fence poorly.

**MR DAVINCI** (D Jensen) – Jumped indifferently throughout.

**MY MAGICIAN** (C Studd) - Misjudged the fifth fence.

**WAIKIRIKIRI** (B Lammas) - Pulled up prior to jumping the final fence when out of contention. A subsequent veterinary examination revealed a tendon injury to right foreleg and will require a veterinary clearance prior to racing next.

**ZEDACE** (G Walsh) Misjudged the fence near the 600 metres losing ground inconveniencing COCONUT which became awkwardly placed on the heels of that runner having to be steadied and shift inwards.

Race 4 LAWNMASTER AMATEUR (2100 Metres)

MEDINI (H Parkes) – Jumped outwards at the start crowding BAD BOY BROWN having to be steadied losing ground.

BAD BOY BROWN (J-L Lupton) – Inconvenienced at start losing ground.

EDDIE GILBERT (S MacNab) - Slow away

**ADEQUACY** (L Wheeler) - Raced wide throughout.

**B Rogerson** (FORT KNOX) – Issued with a warning under Rule 638(1)(d) in that she shifted out into a marginal run passing the 1200 metres making contact with the hind quarters of PIERIAN SPRING which became briefly unbalanced with FORT KNOX then being placed in restricted room for a distance.

**S C MacNab** – The rider of EDDIE GILBERT admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres and had his licence to ride in races suspended from the conclusion of racing today, Thursday, 26 July up to and including racing on Saturday, 25 August (3 amateur days).

E Nicholas (REVOLUTION) – Was spoken to in regard to the way she used her whip prior to the 100 metres.

## Race 5 BRAMCO GRANITE & MARBLE HANDICAP (1400 Metres)

**EM KAY POPS** (D Turner) – Began awkwardly.

**DO YA** (M Singh) – Lay in under pressure over the final stages.

SOPHIA MAGIA (C O'Beirne) - Briefly steadied when in restricted room passing the 100 metres.

#### Race 6 COURTESY FORD MAIDEN (2100 Metres)

**CARTAGENA** (D Hirini) – Slow away.

OUR CHUCKY (T Allan) – Steadied when becoming awkwardly placed on heels shortly after the start.

**COG KNISH** (R Myers) – Was under pressure passing the 400 metres and was not persevered with for the remainder of the race. When questioned rider advised the mare failed to handle today's existing track conditions. A subsequent veterinary examination was clear.

**ELAMO** (S MacNab) – Gave ground quickly near the 800 metres. When questioned into performance rider advised the gelding had not appreciated today's heavy track conditions.

**Z Moki** (RED AURORA) – Issued with a warning under Rule 638(3)(b)(ii) for the use of her whip prior to the 100 metres.

**D** Bradley (PARTY AT AROA) – Spoken to regarding the use of his whip prior to the 100 metres.

**CASHEL** (D Turner) – Was not persevered with in the final straight when out of contention. Rider advised the gelding may not have appreciated today's heavy track conditions.

Race 7 KAMADA PARK MAIDEN (1200 Metres)

**F Stammers** (MADAM MAKFI) – Issued with a warning under Rule 616(4) for presenting runner without notified gear (Side Winkers).

**WHOSAYS IMPERFECT** (S O'Malley) - Began awkwardly shifting out forcing MADAM MAKFI out on to ZEDUZZI which was crowded having to be steadied.

**ZEDUZZI** (D Hirini) - Tightened at the start then steadied losing ground.

**LORDE HAVE MERCY** (T Johnson) - Held up for a short distance near the 400 metres.

Race 8 THE OAKS STUD HANDICAP (1000 Metres)

**SON OF SURF** (C-M Waddell) -Began awkwardly making contact with MR DARCEE'S GOLD which became briefly unbalanced.

**MISS INTERPRETED** (R Myers) – Began awkwardly.

**OUTSTANDING** (D Turner) – Slow away.
