Race 1	WEONA FAMILY TRUST HURDLE
	KIDDO (W Gordon) - Slow away.
	GEORGETHEFIFTH (L Douglas) - Jumped indifferently throughout.
	HERE TO STAY (S Phelan) - Put in a poor jump at the third and fourth fences.
	RAISEDINASANDPIT (G Walsh) - Had to steady shortly after jumping the fourth fence when becoming awkwardly placed on heels.
	BOSTON HAVOC (M Cropp) - Raced ungenerously in the early stages, misjudged the fourth fence landing awkwardly, retired from the race prior to the second last fence when well beaten.

SENASSY (M Roustoby) - Put in a poor jump at the second to last fence

DONTBREAKMYHEART (A Kuru) - Badly misjudged the final fence, went amiss shortly after passing the finishing line and fell dislodging its rider who was un-injured. **DONTBREAKMYHEART** was immediately attended to by the Veterinarian having to be humanely euthanised as it was found to have suffered a fracture to the left foreleg.

Race 2 | **HARCOURTS TAUMARUNUI HURDLE**

RAAJ (M Roustoby) - Misjudged the third fence, hampered by fallen runner at the fourth fence.

EL CORBY (G Walsh) - Put in a poor jump at the fourth fence dislodging its rider who was un-injured, hampered by the fallen runner were **RAAJ**, **SUFFICE TO SAY** and **NEK MINNIT**.

SUFFICE TO SAY (R Elliot) - Hampered by fallen runner at the fourth fence, misjudged the fence near the 1100 metres.

NEK MINNIT (E Farr) - Hampered by fallen runner at the fourth fence, hit the fence near the 250 metres on the first occasion, put in a poor jump at the second to last fence dislodging its rider who was un-injured.

BANBURY LAD (S Higgins) - Hit the final fence landing awkwardly.

Race 3 | **KEANO SIRE of 80% WINNERS to STARTERS 3YO**

C Lammas - Issued with a warning after permitting his mount to shift inwards under pressure when not fully clear of **BACK IN A FLASH** approaching the 100 metres.

BACK IN A FLASH (A Calder) - Had to shift ground inwards across heels to obtain clear running approaching the 100 metres.

Race 4 | **TAUMARUNUI & DISTRICTS RSA 1400**

IRISH MIST (A Calder) - Began awkwardly, crowded going into the bend near the 900 metres when **BLACKJACK MAN** lay in.

TABARD (R Elliot) - Slow away.

BLACKJACK MAN (T Yanagida) - Rider reported that the gelding had felt a little indifferent in its action with a post-race veterinary examination revealing no abnormalities.

AMBITIOUS WINNER (M Coleman) - When question regarding performance, rider advised that the gelding had struggled in today's heavy track conditions under its top weight.

Race 5 | **BOB BROWN 1215**

BENAUD (R Elliot) - Jumped away awkwardly, commenced to over-race for a short distance when being steadied off heels passing the 1000 metres.

Race 6 | **PATRONS 1215**

SANTA MONICA (T Thornton) - Raced wide throughout.

Race 7 | **TAUMARUNUI RACING CLUB MEMBERS 1400**

NEXT UP (G Cooksley) - Began awkwardly losing ground, raced keenly in the early to middle stages, raced in restricted room rounding the final turn near the 300 metres.

MR BIG (C Dell) - Began awkwardly losing ground, rider reported that the gelding had failed to handle today's track conditions.

ARTIC STORM (A Calder) - Over-raced in the early to middle stages, when questioned regarding performance rider advised that the gelding had failed to handle today's holding track conditions.

Race 8 | **WOODS CONTRACTING TAUMARUNUI GOLD CUP**

SHE'S ALL CLANG (R Elliot) - Began awkwardly losing ground.

EL LUCHADOR (M Coleman) - Began awkwardly making solid contact with MAJOR TOM.

MANGAROA FLO JO (L Satherley) - Slow away.

STORMING THE TOWER (S Rusof) - Briefly steadied shortly after the start when placed in restricted room.

MAJOR TOM (J Fawcett) - Bumped start, raced keenly in the early stages, steadied and shifted outwards when becoming awkwardly placed on heels passing the 1500 metres, when questioned regarding performance rider advised that the gelding had not been suited by today's holding track conditions. A post-race veterinary examination was clear.

S Spratt - Spoken to regarding her whip use prior to the 100 metres.

C Lammas - Was attended to by Ambulance personnel following the race after becoming unwell, being stood down from his remaining rides.

Race 9 | **KING COUNTRY RUGBY SUPPORTERS 2200**

KINGTIDE (T Yanagida) - Shifted outwards abruptly on jumping away hampering LUCKY TONIGHT.

LUCKY TONIGHT (J Nason) - Hampered at the start losing ground.

SUMMER WARRIOR (S Spratt) - Steadied when in restricted room shortly after the start.

VELVETEEN (M Coleman) - Began awkwardly, when questioned regarding performance rider advised that the mare had failed to see out the distance of today's race in the testing track conditions adding that the mare may have been better suited to being ridden more quietly with cover early in the race.

MASTER POET (A Calder) - Steadied and shifted inwards to obtain clear running after improving onto the heels of IN A MINUTE near the 200 metres inconveniencing WILIJONMCBRIDE and BARBWIRE without outward movement from KINGTIDE also contributing.

WILIJONMCBRIDE (R Elliot) - Inconvenienced passing 200 metres.

KINGTIDE (T Yanagida) - Inconvenienced passing 200 metres.

Race 10 | **RACING ROTORUA 1560**

YORKSHIRE DALES (S Rusof) - Slow away before being further hampered when crowded, made the first bend awkwardly having to be restrained to avoid heels, commenced to over-race for a distance passing the 1200 metres.

PASABAHCE (R Elliot) - Held up near the 250 metres and did not obtain clear running until approaching the 100 meters.

S Rusof (YORKSHIRE DALES) - Admitted a charge in that he used his whip excessively prior to the 100 metres with the Judicial Committee imposing a fine of \$300.
