RACE COMMENTS:

Race 1 JOY BENNETT MEMORIAL (2100 metres)

LOTHBROK (J Waddell) – Began awkwardly losing ground.

MITJAVILE (J Riddell) – Crowded and steadied approaching the 1600 metres to the inside of GUTSY GUSSIE which was forced inwards by LOTHBROK who had become awkwardly placed inside the heels of JOLLY ZAM (T Yanagida) which shifted in.

T Yanagida (JOLLY ZAM) – Issued with a warning after allowing JOLLY ZAM to shift in passing the 1600 metres when insufficiently clear of LOTHBROK, which was dictated inwards crowding GUTSY GUSSIE on to MITJAVILE which was crowded and steadied. Stewards took into account the racing manners of LOTHBROK and the pace steadying.

Race 2 SSANGYONG (2100 metres)

LETMEBY (M Hashizume) – Slow to begin.

HESALLJAZZ (R Scott) – Slow to begin. Steadied passing the 1700 metres when crowded to the inside of BLACKMAGICWOMAN (E McCall) which had shifted in abruptly after improving on to the heels of SMEDLEY (J Nason) which shifted in. J Nason and Apprentice Rider E McCall were both reprimanded by Stewards and advised to exercise greater care in a similar circumstance.

WOODEN EDGE (T Yanagida) – Shifted out abruptly approaching the 200 metres.

SHE'S ALL CLANG (S Spratt) - Inconvenienced approaching the 175 metres.

E McCall (BLACKMAGICWOMAN) - Reprimanded by Stewards after shaking hands prior to weighing in.

Race 3 PUKEKOHE PLUMBING (1200 metres)

TIN SOLDIER (C Dell) – Began awkwardly losing ground.

SOLMIZATION (K Chowdhoory) – Crowded leaving the barriers.

SANTA MONICA (T Thornton) – Crowded leaving the barriers.

CALL ME BOB (W Pinn) - Slow to begin.

MIDNIGHT RUNNER (T Yanagida) – Became awkwardly placed on the heels of SELLWOOD approaching the 900 metres shifting out and making heavy contact with JUST FOR KICKS.

JUST FOR KICKS (J Waddell) – Crowded and unbalanced 900 metres.

IT'S BEN AGAIN (T Miles) – Steadied when crowded passing the 100 metres to the outside of SELLWOOD who was dictated outwards by MIDNIGHT RUNNER (T Yanagida) which shifted out under pressure. T Yanagida was advised to exercise greater care in a similar circumstance.

Race 4 MOUNT SHOP (1400 metres)

XPECTHEUNXPECTED (T Thornton) – Slow to begin.

LANGBEIN (D Johnson) – Slow to begin. Inconvenienced 25 metres when laying in across heels.

CROSSED MY MIND (S Rusof) – Began awkwardly then crowded shortly after, having to be steadied.

ITSRIOBABE (L Satherley) – Steadied approaching the 1000 metres when in restricted room to the inside of LADY DAY which had shifted in after making contact with TED TALKS. Contributing was slight outward movement from THEONLYWAY. Crowded 100 metres to the outside of ODD MAN OUT which was dictated out by LADY DAY which shifted out abruptly despite the efforts of its rider.

THEONLYWAY (L Innes) – When questioned regarding performance Rider L Innes could offer no tangible excuses. Trainer N Tiley advised that he may give consideration to dropping back in distance and would consider gear changes.

Race 5 MARTIN "SMOKEY" MORGAN MEMORIAL (1400 metres)

TATTYBOGLER (S Rusof) - Slow to begin.

CRITICS CHOICE (C Dell) – Slow to begin.

MOUNT MIDORIYAMA (J Waddell) – Raced ungenerously when being steadied in the early stages. Crowded 100 metres.

CANCELLARA (D Danis) – Crowded and checked approaching the 800 metres. Crowded passing the 400 metres.

J Riddell (TWO THIRTY) – Issued with a warning after permitting TWO THIRTY to shift out passing the 400 metres when insufficiently clear of CANCELLARA which was crowded.

ASTON PARK (S Spratt) - Crowded and checked 850 metres.

T Miles (TOODALOO) – Admitted a breach of Careless Riding in that she allowed TOODALOO to shift in approaching the 850 metres when insufficiently clear of ASTON PARK which was checked shifting back on to CANCELLARA which was also checked. After hearing submissions the Judicial Committee suspended T Miles' licence to ride in races from the conclusion of racing today 11 August up to and including racing on 23 August 2018, 5 national riding days.

TWO THIRTY (J Riddell) – Inconvenienced passing the 100 metres making contact with MOUNT MIDORIYAMA when briefly crowded by SUN GENES which shifted out when struck with the whip.

LOWRIDER (T Newman) - Rider dropped whip near 500 metres.

D Mansour (MUTECHI) – Admitted a breach in that he used his whip excessively prior to the 100 metres with the Judicial Committee imposing a fine of \$300.00.

Race 6 HAUNUI (1600 metres)

WAIPIPI LAD (K Chowdhoory) - Began awkwardly losing ground. Shifted in over the concluding stages making contact with DELUXE EDITION.

Race 7 DENNIS & LEO BRADY CONSTRUCTION (1600 metres)

MR BIG (C Dell) – Began awkwardly losing ground.

HEEZA DREIMER (W Pinn) – Began awkwardly after being fractious in its barrier stall.

CHACHI ARCOLA (R Smyth) – Slow to begin.

FLY TO THE MOON (S Rusof) – Began awkwardly. When questioned regarding the performance Rider S Rusof advised the mare may not have been suited to the existing track conditions which he described as holding.

ARMAGUARD (J Nason) – Began awkwardly. Rider dropped whip passing the 200 metres.

C Dell (MR BIG) – Issued with a warning after using his whip unnecessarily on a horse which was out of contention.
