#### **RACE COMMENTS:**

Race 1	WAIPA HOME OF CHAMPIONS 1150				
TACHIBANA (A Calder) - Crowded leaving the barrier losing ground.					
SCANTILY CLAD (A Goindasamy) – Crowded leaving the barrier losing ground.					
UNCLE ERN (S McKay) - Raced ungenerously through the middle stages.					

**COURT CHA** (D Mansour) - Dictated outwards passing the 300 metres by UNCLE ERN which had made the bend awkwardly.

**DUBLIN ROSE** (S Rusof) - Held up entering the final straight.

**PINUPMAN** (R Elliot) - Inconvenienced 150 metres by SCANTILY CLAD (A Goindasamy) which shifted in under pressure. Apprentice A Goindasamy was advised to exercise care when in similar circumstances.

**SOLEIL DORE** (S Spratt) - When questioned regarding performance rider S Spratt could offer no tangible excuses.

Race 2 VILAGRAD WINERY 2000

**CHARRED** (L Satherley) – Trainer P Mirabelli reported that CHARRED had escaped when being loaded for transportation to the races and was cleared to race by the on-course veterinarian. Jumped away awkwardly losing ground.

DISRAELI (B Grylls) - Crowded shortly after jumping away losing ground.

**SHADZE OF BLUE** (R Smyth) - Raced fiercely in the early to middle stages.

WHITE RIVER (S Rusof) - Lay out when making the bend passing the 600 metres running wide.

FLYING FANTASIA (A Calder) - Raced wide without cover from near the 1100 metres.

**MAMBA** (M Cameron) - When questioned regarding the performance, rider M Cameron could offer no tangible excuses.

Race 3 DUNSTAN SPEEDFEED 1400

T Da Cruz (OLLIE) - Issued with a warning after presenting OLLIE to race in gear which had not been notified (blinkers).

DAY DREAMER (L Satherley) – Crowded soon after leaving the barriers.

**RAZOR** (A Calder) – Raced ungenerously in the early to middle stages.

**CROWN PROSECUTOR** (D Johnson) – Held up for a distance passing the 400 metres. Changed ground passing the 150 metres to obtain clear running then improved into a marginal run passing the 100 metres.

VERBIER (V Colgan) - Had to briefly steady passing the 400 metres.

**SUNNY ROSE** (C Lammas) – Raced greenly when placed under pressure shifting out abruptly approaching the 200 metres.

**MASTER HERB** (C Dell) - Returned to the enclosure with blood present in the nasal area. A veterinary examination found the blood to be from the top of pharynx. Connections advised the gelding would now be spelled.

**SCOMADI** (J Bayliss) - J Bayliss advised that the filly had not been comfortable in the existing track conditions.

Race 4PIC INSURANCE 1400LIL' ROKA (S Spratt) – Slow away. Commenced to over-race near the 1150 metres making the bend awkwardly.

**TAWNY WAY** (J Bayliss) – Raced wide without cover for the majority of the race.

**NIGEL'S WORLD** (L Satherley) - Commenced to over-race passing the 1150 metres shifting out forcing THE LAST TSUNAMI wider on the track.

**D** Hain (MR LINSKI) - Issued with a warning after permitting MR LINSKI to shift in passing the 1100 metres when insufficiently clear of THE MATRIX and CAVALLO ECCELLENTE which were both crowded.

**CAVALLO ECCELLENTE** (S Collett) - Crowded and hampered 1100 metres then raced ungenerously for a distance. Raced in restricted room for a distance passing the 300 metres.

THE MATRIX (D Johnson) - Crowded and hampered 1100 metres.

**J Bayliss** (TAWNY WAY) – Admitted a breach in that he changed his riding boots after weighing out and was fined \$250 by the Judicial Committee.

Race 5 VERNON & VAZEY 1400

**TILDY** (L Satherley) - Late scratched at 2.53pm after refusing to enter the barriers. Trainer D Weatherley was advised that the filly would be required to barrier trial to the satisfaction of the Stewards prior to racing next.

**VALMUR** (D Danis) – Hampered leaving the barriers.

**ON THE DOT** (S Collett) – Over-raced in the early stages. Crowded and checked 1100 metres then racing ungenerously shifting out to avoid heels, racing wide for the remainder of the race.

**A Goindasamy** POKER QUEEN - Admitted a breach of careless riding in that he permitted POKER QUEEN to shift in near the 1100 metres when insufficiently clear of ON THE DOT which was checked with the hearing being adjourned.

PATCH MAN (C Lammas) - Hampered when improving onto heels 850 metres.

**LORD BUFFALO** (R Jones) - Shifted in when placed under pressure approaching the 250 metres making contact with SPECTRA on a number of occasions over the final 200 metres.

# Race 6 MAKUCH ROOFING 1580

AZAREEL (B Grylls) - Began awkwardly losing ground.

**MOTUMAN** (D Danis) - Began awkwardly losing ground.

KING'S SECRET (S McKay) - Inclined to lay out throughout

**NIGHT CAPTAIN** (C Lammas) - Raced wide for the majority of the race.

**EXPRESS CALL** (R Elliot) - Had to steady passing the 500 metres racing in restricted room to the inside of NIGHT CAPTAIN which shifted away from CANCELLARA. Hampered passing the 300 metres when improving onto heels. Hampered passing the 200 metres then lay in across the heels of AZAREEL which sifted out to avoid heels.

**PRINCESS ORIGAMI** (M Cameron) – When questioned regarding the performance Rider M Cameron advised that he would be recommending to connections to apply blinkers. A post-race veterinary examination could find no obvious abnormalities.

Race 7 NZB INSURANCE PEARL SERIES RACE

**MADAM ACE** (H Parkes) - Began awkwardly with the rider becoming unbalanced. Hampered 800 metres then run off by the rider-less horse and took no further part in the race.

HAVANA HEIGHTS (D Danis) - Began awkwardly.

JAKAMA JILL (A Calder) - Began awkwardly.

**CASTLEREIGH** (A Goindasamy) - Clipped a heel and blundered passing the 800 metres dislodging rider A Goindasamy who was transported to hospital for further evaluation. Hampered as a result was MADAM ACE. An enquiry was opened and adjourned into the incident.

BELLE SOUTH (E McCall) - Inconvenienced when in restricted room passing the 500 metres.

POLLY GREY (B Grylls) - Help up passing the 300 metres.

**LITTLE SHIRLEY** (D Hain) - Improved into a marginal run approaching the 200 metres and then was hampered for a distance when racing in restricted room.

**SHESONFIRE** (D Johnson) - Rider D Johnson advised that the mare had not travelled comfortably throughout the race. A post-race veterinary examination found a small cut to the right hind pastern and a slow recovery.

#### Race 8 CAL ISUZU TE AWAMUTU CUP 2000

**ROGER THAT** (S Collett) – Steadied shortly after jumping away when placed in restricted room.

**GOBSTOPPER** (D Johnson) - Raced three wide without cover until passing the 1100 metres. When questioned regarding the performance Rider D Johnson could offer no tangible excuse.

YOUWANTMORE (B Grylls) - Made the bend near the 1600 metres awkwardly.

**STACEY ANN** (D Hain) - Raced wide for the majority of the race.

Race 9 MAGNUM BUILD 1150

**COLORADO BAY** (A Calder) – Slow away.

**PACIFIC COAST** (C Burdan) – The saddle commenced to shift passing the 600 metres placing Apprentice Rider C Burdan at a disadvantage for the remainder of the race.

ASTOR (S Collett) – Lay in when placed under pressure passing the 300 metres having to be corrected by its rider.
