#### **Race 7 SIGNATURE HOMES 1400**

**TOKYO LIL** (T Yanagida) – Trainer D Williams advised Stewards that she was satisfied with the recovery of the mare and it is their intention to continue on with its current preparation.

**MR TRUMP** (M Coleman) – Trainer S Marsh advised Stewards that he was satisfied with the recovery of the gelding, adding that connections would be considering adding blinkers and a step up in distance for its next start.

#### RACE COMMENTS:

### Race 1 FELL ENGINEERING

MERCY HILL (A Calder) - Raced in restricted room shortly after leaving the barrier and steadied.

**STITCH** (S Collet) – Raced in restricted room to the inside of NOPELE (D Danis) which shifted in when not fully clear near the 1300 metres Rider D Danis was advised to exercise care when shifting ground. then raced ungenerously through the early to middle stages.

**LADY LIRA** (M Cameron) – When questioned into the performance of the favourite, rider advised the mare was unsuited to the firmer track conditions and also felt it would be better suited over a shorter distance. A Post race veterinary examination revealed no abnormalities.

**SEDUTTORE** (D Johnson) – When placed under pressure passing the 400 metres, was unable to quicken with rider not persevering with the gelding and advised that SUDUTTORE had failed to hit out throughout with a post-race veterinary examination revealing no abnormalities.

## Race 2 TEE CAFÉ @ RUAKAKA RACES

**NOTHINGLEFTTOLOSE** (R Smyth) – Slow to begin.

BEYOND DISPUTE (M Cameron) - Shifted out under pressure inconveniencing ERIDANI near the 75 metres.

**ERIDANI** (D Johnson) - Inconvenienced 75 metres.

### Race 3 THE HOMESTEAD SPORTS BAR

MOON SHADOW (A Jones) - Crowded start losing ground.

BRUNO MAGILE (S Rusof) - Crowded start losing ground.

**SHEZTHEWONFORUS** (L Satherley) - Slow to begin.

MARKLE (R Elliot) -Slow to begin, held up near the 300 metres having to shift in to obtain clear running.

**WAY ABOVE** (D Danis) - Began awkwardly losing ground.

SIR AGLOVALE (S Collett) - Began awkwardly.

**TROUBLE** (J Fawcett) – Became awkwardly placed on heels when making the bend near the 900 metres, then shifted out racing wide without cover for the majority of the race.

**TIGER SILK** (A Calder) - Made the 800 metre bend awkwardly, shifted out to obtain clear running passing the 400 metres making slight contact with BRUNO MAGILE.

**R Smyth** CAPTAIN NOVA - Dropped her whip passing the 150 metres.

## Race 4 INTERISLANDER SUMMER FESTIVAL 5 JAN

**TANTALISING** (D Johnson) - Removed from the barrier after becoming fractious to undergo a veterinary examination and was cleared fit to race, Slow away.

**TAV IT UP** (S Collett) - Began awkwardly shifting in having to be steading when becoming awkwardly placed on heels losing ground.

**FULL SERVICE** (S Spratt) – Stumbled when placed in restricted room shortly after the start, commenced to over-race through the middle stages.

QUINTUPLE TWINS (M Cameron) - Made the 800 metre bend awkwardly.

**BOUNDTOBEHONOURED** (S Rusof) - Made contact with the running rail passing the 800 metres. Fell near the 250 metres dislodging rider S Rusof who was transported to hospital for further evaluation.

**MISSMAISING** (T Yanagida) - Had to be firmly restrained near the 500 metres when becoming awkwardly placed on heels.

**TANTALISING** (D Johnson) - Bought down passing the 250 metres when unable to avoid the fallen runner with D Johnson suffering a shoulder injury and was transported to hospital for further evaluation.

An enquiry was adjourned into the reasons why BOUNDTOBEHONORED fell near the 250 metres bringing down TANTALISING as a result.

### Race 5 LION RED

LUCETTA (M Cameron) - Slow to begin.

**LADY HENRIETTA** (R Smyth) - Over-raced for a distance passing the 1500 metres then becoming awkwardly placed on heels approaching the 1300 metres shifting out hampering MI SKY.

**MI SKY** (S Collett) - Hampered approaching the 1300 metres, then raced wide without cover for the remainder of the race.

**LAKE SUPERIOR** (R Elliot) - Held up early in the final straight then shifted out approaching the 250 metres inconveniencing ZENNTARI which was forced wider. R Elliot was issued with a warning.

**ZENNTARI** (D Danis) - Inconvenienced when forced wider approaching the 250 metres.

#### Race 6 DA

#### DARGAVILLE RACING CLUB'S NORTHLAND CUP

FLORENCE IVY (K Cowan) - Raced wide in the early stages.

**EL FERNANDO** (S Collett) - Raced wide without cover from near the 1200 metres. Lost the off hind plate during the race.

FAWN (J Bayliss) - Held up early in the final straight.

**GREENCAST** (M Cameron) - Held up early in the final straight, inconvenienced 250 metres having to shift in to obtain clear running.

**SMEDLEY** (A Jones) - Raced wide without cover through the middle stages shifting out under pressure passing the 150 metres inconveniencing GREENCAST.

**SHERRIF** (R Elliot) – Had to be restrained when becoming awkwardly placed on heels passing the 1100 metres.

### Race 7

### **CHRISTMAS AT THE RACES 18 DEC**

**R Collett** - Issued with a warning after presenting MIDNIGHT COUNTESS without gear which had been notified (blinkers).

**GWENDOLINE ROSE** (J Bayliss) - Began awkwardly. When questioned into the filly's improved performance, stable representative advised that the improved track conditions and also that the filly had been working well leading into today's race.

TRIOMPHE (D Danis) - Began awkwardly. Shifted out abruptly to avoid heels 300 meters.

I'M MURPHY (A Goindasamy) - Began awkwardly.

**PERSISTENCE** (S Collett) - Began awkwardly.

THEE MADAME (A Jones) - Raced wide without cover throughout.

VIOLA VEGA (J Fawcett) – Lay out when making the final bend. Shifted out concluding stages.

**MIDNIGHT COUNTESS** (A Calder) Lay in approaching the 300 metres when commencing to give ground shifting back on to TRIOMPHE which shifted out abruptly to avoid heels.

**QUICK PREVIEW** (S Spratt) - Inconvenienced and had to shift out passing the 200 metres when improving onto the heels of THEE MADAME which shifted out under pressure. Shifted in under pressure concluding stages.

**HONFLEUR** (K Cowan) – Steadied shortly after the start when becoming awkwardly placed on heels. Crowded and steadied close to the finishing line between QUICK REVIEW (S Spratt) and VIOLA VEGA (J Fawcett) which both shifted ground under pressure. Both riders were advised to exercise care.

**HAVANA HEAT** (L Satherley) – Raced ungenerously in the early stages.
