Rider D Turner advised he was unwell and was unable to attend today's meeting. D Turner is to provide a medical clearance prior to riding next.

RACE COMMENTS:

Race 1	TAURANGA HARDWARE AND PLUMBING 3YO 1400
G Cooksley (MAGIC CONDOR) – Attended to by the ambulance staff after being struck in the face during the preliminary and was cleared fit to ride.	

MASETTO (T Thornton) – Slow away. Had to be restrained when becoming awkwardly placed on heels passing the 800 metres. Held up in the final straight and when shifting out to obtain clear running near the 150 metres made brief contact with **BOCCE** which was forced wider on the track. Rider T Thornton was advised to exercise care in a similar circumstance.

SPIRITS AUBEER (R Smyth) – Raced wide without cover throughout.

SACRED ACCORD (L Innes) – Lay out around the bend passing the 900 metres. L Innes advised that the gelding was feeling the firm nature of today's track.

BOCCE (O Bosson) – Inconvenienced 150 metres when forced wider.

L Innes (**SACRED ACCORD**) – Reminded of his obligations in that he must ride his mounts out fully to the finish when circumstances permit him to do so.

Race 2

O'CONNOR WARREN INSURANCE BROKERS MAIDEN 1600

ARROGANT (O Bosson) – Removed from the barriers after becoming fractious and was declared a late scratching on veterinary advice at 1.06 pm. Co-trainer P Gerard was advised that the colt is required to barrier trial to the satisfaction of Stewards prior to racing next.

SPECTRA (J Parkes) – Contacted soon after leaving the barrier becoming unbalanced.

OXYMORON (B Grylls) – Hampered leaving the barriers.

NOBLE STAR (D Prastiyou) – Over-raced when being restrained in the early to middle stages.

COME BACK TIGER (R Elliot) – Raced wide in the early stages.

I WALK ALONE (A Calder) – Became unbalanced approaching the 350 metres when contacted by **BARZELLAR** (T Yanagida) which had improved into a marginal run.

T Yanagida (**BARZELLAR**) – Issued with a warning after permitting his mount to improve into a marginal run approaching the 350 metres making contact with the hind quarters of **I WALK ALONE** which became unbalanced.

LAURAMIA (A Goindasamy) – Made contact soon after leaving the barrier becoming unbalanced. Raced wide without cover. Shifted out soon after entering the final straight when placed under pressure dictating **OUT OF THE PARK** outwards until near the 250 metres.

OUT OF THE PARK (J Waddell) – Dictated outwards early in the final straight.

A Goindasamy **LAURAMIA** – Issued with a warning after permitting **LAURAMIA** to shift out under pressure early in the final straight until near the 250 metres dictating **OUT OF THE PARK** wider on the track.

Following the race the connections of the second placed horse **OUT OF THE PARK** lodged a protest against the first placed horse **LAURAMIA** alleging interference in the final straight. After considering submissions the Judicial Committee dismissed the protest.

Race 3

IXOM HANDICAP 1200

RICH BILLIE MARSH (J Fawcett) – Began awkwardly shifting in abruptly with rider becoming unbalanced hampering **MAHALO** and **LAAFFAIRE** with both those runners losing considerable ground.

MAHALO (T Thornton) – Hampered start losing considerable ground.

LAAFFAIRE (S McKay) – Hampered start losing considerable ground.

RESURRECT (T Newman) – Raced wide from near the 700 metres.

CHICANE (D Danis) – Lay in early in the final straight making contact with RESURRECT.

Race 4 | **ILINE CONSTRUCTION HANDICAP 2100**

SUNBURST (J Parkes) – Dictated outwards passing the 1700 metres by BATTLE ROYAL which had become awkwardly placed on the heels of TRYFAN. As a result SUNBURST then made the bend awkwardly forcing WOODEN EDGE wider on the track.

WOODEN EDGE (A Goindasamy) – Forced wide passing the 1700 metres. Raced wide without cover for the majority of the race.

SARABANDE (R Elliot) – Held up entering the final straight and had to steady passing the 250 metres when improving into restricted room.

TRYFAN (L Satherley) – Had difficulty obtaining clear running until shifting out passing the 150 metres.

EL JODI (S McKay) – When questioned regarding performance rider S McKay advised that the mare had travelled well, but when the pace had quickened from near the 600 metres the mare had been caught flat footed but had made ground well late in the race.

Race 5 | **DOMINATOR GARAGE DOORS TAURANGA HANDICAP 1600**

VOLER POUR MOI (A Calder) – Crowded and hampered leaving the barrier losing ground. Held up until near the 300 metres.

CHA SIU BAO (L Innes) – Crowded and hampered leaving the barrier losing ground.

JUSTAMAIZ (J Waddell) – Crowded and hampered leaving the barrier losing ground.

STACCATO (R Elliot) – Began awkwardly losing ground.

PASABAHCE (H Parkes) – Became awkwardly placed passing the 1500 metres. Ran wide making the final bend.

PURSUED (D Danis) – Raced wide without cover from near the 800 metres. Underwent a post-race veterinary examination after the gelding was suffering a slow recovery which could find no significant abnormality.

Race 6 | **WALKER & HALL HANDICAP 1400**

SENSIBLE PRINCESS (J Parkes) – When questioned regarding performance rider J Parkes advised the mare would prefer some easing of the ground.

EMBELLISH (O Bosson) – Blundered passing the 75 metres. When questioned regarding performance rider O Bosson advised that the entire had travelled well but had failed to respond once placed under pressure in the final straight. A post-race veterinary examination could find no obvious abnormality.

SULTAN OF SWING (J Waddell) – Was uninjured after making contact with the running rail following the race.

Race 7	GARTSHORE TAURANGA STAKES 1600
<p>DARSCAPE PRINCESS (J Parkes) – Began awkwardly losing ground, then over-raced through the middle stages.</p> <p>CONSENSUS (L Innes) – Over-raced through the middle stages.</p> <p>WOODSMAN (A Jones) – Raced wide without cover for the majority of the race. Hampered 375 metres when racing in restricted room when weakening to the inside of ALL ROADS which stepped in slightly, and then further crowded by OCEAN EMPEROR (L Satherley) which shifted out to obtain clear running.</p> <p>L Satherley OCEAN EMPEROR – Issued with a warning after permitting OCEAN EMPEROR to shift out near the 375 metres when insufficiently clear of WOODSMAN which was hampered.</p> <p>OCEAN EMPEROR (L Satherley) – Raced keenly in the early stages and raced in restricted room to the inside of NICOLETTA for a distance passing the 1000 metres.</p> <p>T Thornton EL COOLIO – Reminded of her obligations with the whip on a runner that is out of contention.</p>	
Race 8	DEVAN PLASTICS HANDICAP 1600
<p>EASY WALKING (T Yanagida) – Began awkwardly losing ground.</p> <p>KAMIKAZE REBEL (D Danis) – Slow away.</p> <p>POPPY STAR (J Parkes) – Began awkwardly losing ground.</p> <p>HOOF HEFNER (A Goindasamy) – Raced keenly in the early stages, the racing in restricted room when making the bend passing the 900 metres.</p> <p>CODECRACKER (O Bosson) – Shifted in under pressure passing the 150 metres placing SKAABOOM in restricted room when that runner was improving to its inside with SKAABOOM then laying out under pressure making contact with CODECRACKER which was hampered and steadied.</p> <p>L Innes (SKAABOOM) – Issued with a warning for permitting SKAABOOM to shift out over the concluding stages crowding CODECRACKER which was hampered and steadied.</p>
