RACE COMMENTS:**Race 1** | **WANGANUI STEELFORMERS 2YO JUVENILE PLATE 800m**

FIRST ROCK (B Grylls) – Crowded leaving the barriers when **ALTO POTENZA** was taken inwards by **SAI FAH** with **FIRST ROCK** then making contact with **ROYAL CHARTER** which was unbalanced. Hampered near the 700 metres losing ground. Held up approaching the 400 metres then when shifting out to obtain clear running near the 250 metres made contact with **DASH** which became unbalanced and shifted outwards.

ROYAL CHARTER (M Cameron) - Unbalanced when bumped shortly after leaving the barriers then having to be steadied to avoid the heels of **SAI FAH** which shifted inwards with **ROYAL CHARTER** then shifting outwards hampering **FIRST ROCK** near the 700 metres. Made the final bend awkwardly running outwards across the heels of **DASH** near the 300 metres. When questioned, the rider advised the filly had raced greenly throughout.

D Johnson (SAI FAH) – Issued with a warning after permitting her mount to shift inwards near the 700 metres when not fully clear of **ROYAL CHARTER**.

DASH (L Allpress) – Raced greenly and lay out rounding the bend. Unbalanced when contacted near the 250 metres.

Race 2 | **WANGANUI CHRONICLE 1200m**

PLATINUM VOLOS (J Riddell) – Very slow to begin losing considerable ground and effectively its chance in the race. Connections were advised the gelding is now required to barrier trial to the satisfaction of the Stewards prior to racing again.

BELLE CANTO (A Shin) – Slow away

PLAY THE FIELD (W Pinn) – Bumped leaving the barriers when **HUNDYAMONTH** lay out with **PLAY THE FIELD** losing ground.

PURE DAZE (B Grylls) - Raced three-wide without cover.

HUNDYAMONTH (Z Moki) - When questioned into the disappointing run of **HUNDYAMONTH** which finished well back Z Moki was of the opinion the gelding may be better suited to more rain affected going.

Race 3 | **CORO ANGEL SYNDICATE 1200m**

RED SIERRA (C O'Beirne) – Slow away. When questioned C O'Beirne advised that after getting back at the start the mare was unable to recover in today's improved track conditions.

SCAPOLO (T Taiaroa) – Jumped away awkwardly making contact with **MANHATTAN STREET** which had also begun awkwardly.

MANHATTAN STREET (M Cameron) - Made contact with **SCAPOLO** when beginning awkwardly.

PETTIT EN JEU (L Allpress) - Raced three-wide without cover. Hampered near the 450 metres.

W Pinn (ART DECO) - Admitted a charge of careless riding in that he directed his mount outwards near the 450 metres when not sufficiently clear and making solid contact with **SHADOWS CAST** which was unbalanced and forced outwards hampering **PETTIT EN JEU**. After hearing submissions the Judicial Committee imposed a suspension from the conclusion of racing on 8 September until the close of racing on 20 September – 7 riding days.

SHADOWS CAST – (T Johnson) - Unbalanced when receiving solid contact near the 450 metres. T Johnson was spoken to regarding his whip use prior to the 100 metres.

ART DECO (W Pinn) – Rider dropped his whip near the 50 metres.

Race 4	THE O'LEARYS FILLIES STAKES 1200m
<p>BEAM OF LIGHT (M Hills) - Underwent a veterinary inspection after being kicked behind the barriers and passed fit to run.</p> <p>TUTTA LA CLASSE (L Allpress) – Slow away</p> <p>SWEET ELVIRA (T Allan) - Jumped away awkwardly then having to be steadied shortly after the start when racing in restricted room.</p> <p>M Hills (BEAM OF LIGHT) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear causing crowding to FLAUNT IT GIRL, EXEMPLAR and PEACEFUL near the 1050 metres with FLAUNT IT GIRL and EXEMPLAR being checked. After hearing submissions the Judicial Committee imposed a suspension from the conclusion of racing on 8 September until the close of racing on 21 September – 8 riding days.</p> <p>FLAUNT IT GIRL (S McKay) – Checked when crowded near the 1050 metres. Had difficulty in obtaining clear running in the final straight.</p> <p>EXEMPLAR (B Grylls) - Checked when crowded near the 1050 metres then raced ungenerously for a distance.</p> <p>PEACEFUL (M Cameron) - Buffeted when crowded near the 1050 metres.</p> <p>RITZY SPARKLE (D Johnson) - Underwent a post-race veterinary inspection which did not reveal any obvious abnormality. Trainer J Richards indicated that the filly was now likely to be spelled.</p> <p>THE REAL BEEL (J Waddell) - Trainer J Richards indicated that the filly was likely to be spelled.</p>	
Race 5	TAKE IT EASY TOURS 2040m
<p>DUELLICIOUS (W Pinn) - Raced three-wide without cover</p> <p>TIME BOMB (R Myers) – Held up passing the 200 metres</p>	
Race 6	ST JOHNS 125 YEAR JUBILEE CLUB 2040m
<p>HAMILTONIAN (L Allpress) – Slow to begin losing several lengths then appeared reluctant to hit out losing further ground. When questioned rider advised the gelding had felt indifferent in its action with a post-race veterinary examination not revealing any obvious abnormality. Trainer W Marshment was advised that HAMILTONIAN is required to barrier trial prior to racing again. Mr Marshment advised that he would remove the blinkers prior to HAMILTONIAN'S next start.</p> <p>SAMPSON (C O'Beirne) – Steadied when crowded near the 1800 metres when DUFFERS CREEK lay in away from YOUWANTMORE.</p> <p>DUFFERS CREEK (Z Moki) – Steadied when placed in restricted room to the inside of YOUWANTMORE (B Grylls) near the 1750 metres then having to be firmly restrained to avoid the heels of YOUWANTMORE which shifted inwards when not fully clear then steadied near the 1700 metres. B Grylls was advised to exercise greater care.</p> <p>YOUWANT MORE (B Grylls) - Steadied to avoid the heels of STROLLING VAGABOND (W Pinn) which shifted outwards near the 500 metres. W Pinn was advised to exercise greater care.</p> <p>WOODSMAN (T Newman) – Underwent a post-race veterinary inspection with no abnormality detected.</p>	
Race 7	DAVE HOSKIN CARRIERS 1600m
<p>BOBBY DAZZLER (D Johnson) - Jumped away awkwardly hampering TUIGIRL. D Johnson was issued with a warning after allowing her mount to shift inwards near the 1100 metres when not fully clear of NOTABADIDEA which had to be steadied.</p>	

TUIGIRL (T Allan) - Hampered at start

NOTABADHARADA (S McKay) – Slow away

NOTABADIDEA (J Waddell) – Steadied when crowded near the 1100 metres

HATTIE BEE (J Nason) – Rider reported that the filly had failed to handle today's track conditions.

RED BEACH (L Allpress) – When questioned regarding performance rider advised the filly had felt indifferent in its action. A subsequent veterinary inspection revealed the filly was lame in right-fore. Connections were advised that a veterinary certificate of fitness would be required prior to racing next.

Prior to the authorisation of dividends an objection was lodged by the rider of the 2nd placed **NOTABADIDEA** against the winner **BOBBY DAZZLER** alleging interference near the 1100 metres. After considering submissions the Judicial Committee dismissed the protest.

Race 8

LECTIO DIVINIA was declared a late scratching at 12.50pm on veterinary advice.

EN SUITE (T Taiaroa) – Slow away

MONSIEUR (S Collett) - Raced three-wide without cover throughout.

KIRKLAND (J Parkes) – Was inclined to shift in under pressure in the home straight and had to be straightened.
