#### RACE COMMENTS:

#### Race 1 DAFFODIL RACEDAY MAIDEN (1200m)

**J Lowry** (ARISTOTLE) was replaced by A Calder when he was .5 kg over the contracted weight. J Lowry was spoken to and reminded of his obligations.

**B Morgenrood** (NIFTY) was replaced by B Grylls when he failed to make the contract weight and as a result admitted a breach of Rule 330(3)(c) and was fined \$200.

**SHOW 'N' GO** (T Moseley) - Began awkwardly making contact with AQUATTACK, raced keenly and lay inwards through the early stages.

AQUATTACK (J Fawcett) - Hampered between runners at the start.

**MUSEE D'ORSAY** (R Mudhoo) - Hampered between runners at the start, blundering and unbalancing the rider for a short distance.

**UPSCALE** (D Turner) - Restrained in the early stages.

NIFTY (B Grylls) -Raced keenly in the early stages.

**JESSIE JANET** (L Callaway) - Raced keenly in the early stages.

**PUBLICIST** (J Laking) - Raced keenly for a distance passing the 800 metres.

**UBETIAM** (G Jogoo) - Raced wide throughout, lay inwards over the concluding stages with the rider swapping whip hands.

ARISTOTLE (A Calder) - Raced in restricted room early in the run home.

**CARDRONA** (K Cowan) - Lay outwards over the concluding stages shifting wider on the track.

#### Race 2 NZ CUP MEETING TICKETS ON SALE NOW MAIDEN (1200m)

B Morgenrood was replaced by **A Morgan** as the rider of LET HER RIP RILEY when he was unable to make the contracted weight.

**SACRED QUARTZ** (B Grylls) was a late scratching at 12.02 pm on veterinary advice after becoming fractious in the barriers. The connections were advised that the gelding must barrier trial to Stewards' satisfaction prior to racing next. Rider B Grylls was attended to by St John Paramedics and cleared to fulfil her remaining rides.

The start of this race was delayed due to the late scratching.

**SHE'S GALLANT** (K Mudhoo) - Fractious in the barriers on a number of occasions, began awkwardly.

CELTIC WONDER (T Jonker) - Fractious in the barriers, buffeted and crowded passing the 300 metres losing momentum

**FAUX PAS** (T Moseley) - Heavily contacted and checked at the start when BELLAROSINA shifted in abruptly, buffeted and unbalanced passing the 350 metres losing momentum.

**YIPPIEYIOH** (S Muniandy) - Over raced badly through the early to middle stages, buffeted and unbalanced passing the 350 metres when over-reacting after being crowded for room between LAPHROAIG and FAUX PAS which was taken in by ZURAFAA which was laying in.

**VIVA LA BURGUNDY** (K Kwo) - Raced keenly in the early stages, placed in restricted room and had to check passing the 250 metres.

LAPHROAIG (J Laking) - Held up in the early stages of the home straight.

MISS SCANDINAVIA (N Bakar) - Raced keenly in the early stages, held up in the early stages of the run home and shifted outwards making contact with CELTIC WONDER passing the 350 metres.

Apprentice **N Bakar** (MISS SCANDINAVIA) admitted a breach of the careless riding rule in that he permitted his mount to shift out passing the 300 metres crowding CELTIC WONDER which made contact with SEVERINE which was forced outwards resulting in the trailing LET HER RIP RILEY and VIVA LA BURGUNDY both being checked. After hearing evidence the Judicial Committee suspended N Bakar's licence to ride at national meetings for 7 days effective from the conclusion of racing on 26 September up to and including 5 October.

**ZURAFAA** (L Callaway) -Lay in throughout the run home.

**SEVERINE** (K Williams) - Buffeted at the 300 metres and forced wider on the track, lay inwards near the 100 metres and had to be straightened.

LET HER RIP RILEY (A Morgan) - Checked at the 250 metres.

## Race 3 GROUP ONE RACEDAY EVENT RATING 72 (2000m)

**SPIDER LILY** (T Comignaghi) - Restrained to the rear on jumping.

SHOCKTILLYOUDROP (A Calder) - Got its head up in the early stages when being restrained.

**SMILING ASSASSIN** (C Campbell) - Got its head up in the early stages when being restrained, lay inwards through the final straight and had to be straightened on a number of occasions.

LIN (G Jogoo) - Raced keenly through the middle stages when leading.

### Race 4 CANTERBURY WESTLAND RACING OWNERS ASSOCIATION RATING 65 (2000m)

BATTLE KAT (L Callaway) - Began awkwardly and got back, raced keenly in the early stages.

**O'KIWI** (B Grylls) - Raced keenly in the early stages, held up from the 500 metres having to be restrained off a tiring runner passing the 350 metres and only gaining clear racing room inside the final 300 metres.

**FLYING AGENT** (C Campbell) - Raced wide in the early stages with the rider reporting that the gelding would appreciate tracks with more moisture.

**GOLDEN BAY** (K Williams) - Raced wide in the early stages.

WHISKEY IN THE JAR (J Morris) - Raced keenly in the early stages, raced wide without cover from the 1000 metres.

**YAMATO NADESHIKO** (T Jonker) - Taken forward from the 1600 metres to lead near the 1000 metres. When questioned regarding the improved performance, trainer J Burrows advised that the mare had taken natural benefit from recent racing and appreciated the firm nature of today's track.

**THE KRAKEN** (S Muniandy) - Over raced for a distance passing the 1400 metres and had to be restrained resulting in the trailing BATTLE KAT also having to be restrained passing the 1250 metres.

**HATRICK BOYS** (T Comignaghi) - Held up on the heels of a tiring runner near the 400 metres and when being steadied away from heels hampered SULCIFERA which also had to be steadied at this point.

**SULCIFERA** (G Saejorhor) - Awkwardly placed between runners near the 400 metres having to be restrained.when hampered

#### Race 5 THE CRAIC IRISH BAR ON RICCARTON ROAD MAIDEN (1600m)

BELLISSIMA BELLE (T Jonker) - Slow to begin.

BAL HARBOUR (T Moseley) - Began awkwardly.

**SEKATIA** (G Jogoo) - Blundered on jumping losing ground, awkwardly placed between runners near the 250 metres when ALBUT ME (K Mudhoo) shifted out looking for clear racing. K Mudhoo was advised to exercise greater care.

ALBUT ME (K Mudhoo) - Raced keenly in the early stages, shifted outwards over the concluding stages.

**PAMIR** (R Mudhoo) - Raced wide in the early stages.

MISS DIORELLA (C Campbell) - Raced wide throughout.

**HEAD OFFICE** (S Muniandy) - Not afforded clear running for a distance passing the 500 metres.

**TO LOVE YOU** (B Murray) - When spoken to regarding the disappointing performance, the rider advised that in his opinion the mare would be suited to tracks with more moisture.

# Race 6 JANET FRANCIS RATING 65 (1600m)

**BULLY BOY** (K Cowan) - Began awkwardly.

AHYUM (G Saejorhor) - Raced wide throughout.

**REAL SAVVY** (A Calder) - Heavily restrained and checked passing the 1000 metres.

**K Cowan** (BULLY BOY) defended a charge of careless riding in that she allowed per mount to shift in passing the 1000 metres when insufficiently clear of REAL SAVVY which had to be firmly restrained and checked. After hearing from all parties the Judicial Committee upheld the charge and suspended K Cowan's licence to ride at national meetings for 10 days effective from the conclusion of racing on 26 September up to and including 10 October.

**GIFTED** (T Jonker) - Gave ground from the 800 metres. A post race veterinary inspection did not reveal any obvious abnormalities. Rider reported that the mare was feeling the firm nature of today's track. The trainer reported that the mare will be sent for a spell.

**SACRED DELIGHT** (B Grylls) - Held up when placed in restricted room passing the 225 metres when awkwardly placed to the inside of BRIDGET TOWN (J Fawcett) which shifted inwards when laying in under pressure and was immediately corrected, then had to be shifted wider on the track to obtain clear racing room.

BRIDGET TOWN (J Fawcett) - Lay in under pressure in the run home and had to be straightened passing the 225 metres.

**SHARP ELLE** (K Asano) - Lay outwards passing the 150 metres and had to be straightened.

### Race 7 CHRISTCHURCH CASINO NEW ZEALAND CUP TRIAL (1800m)

Trainers P Corbett and T Charles were questioned regarding the late rider declaration for SHOW MACCOOL, with the Stewards accepting their explanation.

**WHO DARES WINS** (K Williams) - Raced keenly in the early to middle stages and was obliged to race wide from the 800 metres.

THE MAN (C Campbell) - Raced wide without cover throughout.

**ELFEE** (T Comignaghi) - Had to be restrained passing the 1650 metres when placed in restricted room by GENTIL TONTON which was taken in by BLUE LAGOON which shifted in when only marginally clear. B Grylls was advised to exercise care. Held up rounding the final bend and early in the run home.

**DEE AND GEE** (T Jonker) - Crowded and checked passing the 700 metres.

**T Comignaghi** (ELFEE) admitted a breach of careless riding in that she allowed her mount to shift out at the 700 metres crowding and checking DEE AND GEE. After hearing submissions the Judicial Committee suspended T Comignaghi's licence

to ride at national meetings for 5 days effective from the conclusion of racing on 22 September up to and including 30 September.

### Race 8 STRATEGY CREATIVE OPEN HANDICAP (1200m)

**SENSEI** (T Comignaghi) - Raced fiercely when in restricted room in the early stages and continued to race fiercely through the middle stages contacting heels and blundering on at least two occasions rounding the bend between the 600 and 500 metres, shifted outwards over the concluding stages.

SIGNIFY (K Cowan) - Raced keenly in the early stages.

**HE KIN FLY** (T Moseley) - Raced wide without cover throughout.

**BOOTS 'N' ALL** (S Jamie) - Had to be steadied in the shadows of the post when becoming awkwardly placed on the heels of SENSEI which had shifted ground outwards.

**T Comignaghi** (SENSEI) admitted a breach of excessive use of the whip prior to the 100 metres, with the Judicial Committee imposing a fine of \$500.

# Race 9 NEW ZEALAND BLOODSTOCK CANTERBURY BELLE STAKES (1200m)

NORMA JEAN (T Moseley) - Crowded and lost ground at the start when EXCLAIM shifted out on jumping away.

MIROSLAVA (J Morris) - Shifted out abruptly at the start hampering outside runner.

SUFFRAGETTE (A Calder) - Hampered in the early stages, contacted from the inside and inconvenienced at the 200 metres.

**DREAMTESTA** (K Kwo) - Hampered passing the 1000 metres when QUATTRO KATIE which was over racing shifted inwards to avoid the heels of PICK ME UP IN RIO.

**EASTERN WARRIOR** (T Comignaghi) - Raced wide throughout, shifted out and away from DREAMTESTA passing the 200 metres contacting EXCLAIM which was forced outwards contacting SUFFRAGETTE, placed in restricted room approaching the 100 metres when EXCLAIM lay inwards at this point.

**QUATTRO KATIE** (J Laking) - Over raced early stages and had to be steadied inwards away from heels passing the 1000 metres. Held up passing the 500 metres having to shift ground inwards to find clear racing room.

EXCLAIM (J Lowry) - Bumped by inside runner at the 200 metres, lay in passing the 100 metres and had to be straightened.

#### Race 10 PRYDE'S EASIFEED RATING 65 (1200m)

**MONZA CIRCUITO** (R Mudhoo) - Crowded at the start, crowded and buffeted passing the 1100 metres when IFFIDA was taken in by outside runners.

**RED RIVER ROCK** (T Moseley) - Crowded at the start and lost ground.

**IFFIDA** (C Campbell) - Crowded passing the 1100 metres when REMINGTON was dictated inwards by STROWAN which was laying in at this point.

**MAJOR ISH CHOUX** (K Williams) - Made firm contact with VISHNU passing the 1000 metres when both runners shifted ground. Bumped and inconvenienced passing 300 metres.

**VISHNU** (K Asano) - Made firm contact with MAJOR ISH CHOUX passing the 1000 metres when both runners shifted ground, shifted in abruptly passing the 900 metres crowding BENEFICIAL before being corrected by its rider, continued to race greenly across the crossing and had to be restrained off heels passing the 700 metres.

**DUTCH COURAGE** (K Mudhoo) - Crowded and buffeted losing some momentum passing the 900 metres when racing in tight quarters to the inside of STROWAN which was laying in and away from ST REGIS.

**BENEFICIAL** (K Cowan) - Crowded 900 metres. Held up early in the run home only gaining clear racing room inside the final 250 metres.

**SMOKE HOUSE BAY** (T Comignaghi) - Steadied when awkwardly placed on the heels of VISHNU passing the 400 metres, continued to be held up through the majority of the run home only gaining clear racing room inside the final 100 metres.

**PARVINA** (B Grylls) - Held up early in the run home and when shifting across heels to find clear racing room shifted out abruptly making contact with MAJOR ISH CHOUX passing the 300 metres.

**FIRE SHOW** (G Jogoo) - Gave ground over the concluding stages finishing a well beaten runner. A post race veterinary inspection did not reveal any obvious abnormalities other than signs of tying up. Stewards will follow up with connections in the coming days.

A Morgan (ST REGIS) was spoken to advisedly regarding her whip use outside the 100 metres.

#### Race 11 RACECOURSE HOTEL & MOTOR LODGE RATING 72 (1400m)

**RESPLENDENT GLORY** (D Turner) - Began awkwardly.

HEE'S OUR SECRET (S Muniandy) - Began awkwardly and restrained to the rear on jumping.

**HEBERITE** (C Campbell) - Slow to begin and further hampered by SHE'STOOHOTTOTROT which was dictated inwards by OPIHI RANGER, had to be heavily restrained passing the 750 metres when improving quickly onto the heels of RESPLENDENT GLORY, finished a distant last with the rider reporting that the gelding had been disappointing. A post race veterinary inspection did not reveal any obvious abnormalities.

**DIRECTOR** (J Laking) - Bounded as the start was effected, crowded and checked passing the 1000 metres, raced keenly in the early stages.

**N** Bakar (WIDE AWAKE) admitted a breach of the careless riding rule in that he allowed his mount to shift ground passing the 1000 metres crowding and checking THE DIRECTOR. After hearing submissions the Judicial Committee suspended N Bakar's licence to ride at national meetings for 6 days effective from the conclusion of racing on 5 October up to and including 13 October.

**RIDEITLIKEUSTOLEIT** (T Comignaghi) - Raced wide throughout.

SAVASON (B Grylls) - Buffeted and unbalanced 350 metres.

OPIHI RANGER (J Fawcett) - Crowded and buffeted 350 metres.

J Laking (DIRECTOR) admitted a charge of careless riding in that he allowed his mount to shift ground outwards passing the 350 metres crowding SAVASON and OPIHI RANGER. After hearing submissions the Judicial Committee suspended J Laking's licence to ride at national meetings for 6 days effective from the conclusion of racing on 22 September up to and including 3 October.

**FORGED** (K Mudhoo) - Raced in restricted room and steadied passing the 200 metres when LAKE CHALICE shifted outwards under pressure and WIDE AWAKE lay inwards

**K Cowan** (LAKE CHALICE) was issued with a warning in that she allowed her mount to shift out marginally passing the 200 metres crowding FORGED which had to be steadied.
