Trainer J Richards advised that following a disappointing performance RICHARD OF YORKE had undergone a change of training regime including beach work and they would be continuing with the gelding's current campaign and will also consider making gear changes.

Race 1 - COUNTRY JEWEL MAIDEN 1200m

Trainer **A Schwarz** advised that following a disappointing performance **SUPERTRAMP** had recovered well, has had a brief let up and the mare would now continue with its current campaign.

Race 1 - COUNTRY JEWEL MAIDEN 1200m

Trainer **S McKay** advised that in her opinion **MISSING HAZARD** had failed to handle the track conditions on the day. Ms McKay added the mare was still in work and would be waiting for more suitable track conditions.

Race 4 – TRAVELLERS REST CENTRAL SOUTHLAND CUP OPEN 1200m

Trainer **S McKay** advised that following the disappointing performance of **COURTE ZARINDI** she will be adding a bit lifter to the gear as in her opinion the mare had held its breath during the running.

RACE COMMENTS:

Race 1 VETSOUTH/ROOFCRAFT INDUSTRIES MAIDEN (1200m)

BUSTER BOLT (C Campbell) – Raced wide through the early and middle stages.

TRINOVANTES (T Moseley) – Raced wide through the early stages.

REMARKABLE KATE (J Laking) – Raced wide through the early stages. Weakened from the 300 metres. When spoken to regarding the performance rider J Laking advised the mare was less than genuine in its efforts today.

RING A ROSY (C Barnes) - Slow to begin.

Following this event the official track conditions were downgraded to Heavy 11.

Race 2 LONGFORD TAVERN & FALLS HOTEL HANDICAP (1200m)

DRUMSTORM (J Lowry) – When spoken to regarding the performance rider reported the gelding had hung throughout and had been unsuited by the testing nature of today's track conditions.

ROC LEONE (C Barnes) – Jostled near the 200 metres.

VERIFY (S Muniandy) – Over-raced when racing wide through the early stages. When spoken to regarding the performance rider reported the mare was unsuited by the Heavy 11 track conditions encountered today.

THE LIKELY LAD (K Mudhoo) – Bounded as the start was effected. Raced wide throughout. Bumped near the 200 metres.

Race 3 THE THOMAS GREEN & HOWL AT THE MOON MAIDEN (1335m)

THE DE BOY (C Campbell) – Raced wide throughout.

BEN DIAMOND (R Mudhoo) – Over-raced through the early stages and was steadied passing the 1000 metres when awkwardly placed to the inside of RUAKIWI BLAZE.

BENLACHIE (C Johnson) – Weakened from the 300 metres.

JIMMY RULES (C Barnes) – Shifted outwards near the 250 metres and made contact with OUR BOY RITCHIE on a number of occasions.

OUR BOY RITCHIE (K Kwo) – Began awkwardly, unbalancing its rider and got back as a result. Bumped with JIMMY RULES on a number of occasions near the 250 metres.

NIGELLA JAZZ (A Bohorun) – Raced wide through the middle stages. Not persevered with over the concluding stages with the rider reporting the mare had made abnormal breathing noises during the running. A post-race veterinary

examination revealed the mare to have a slow recovery. Trainer reported the mare had got its tongue over the bit during the running.

ENTIRELY (B Murray) – Rider lost his whip just prior to 200 metres.

GEMSTONE JEWELS (T Jonker) – Slow to begin. Raced in restricted room over the concluding stages when laying outwards.

Race 4 NZB INSURANCE PEARL SERIES RACE (1335m)

DARK SEQUOIA (T Jonker) – Raced ungenerously through the early stages when being restrained.

TAPILIZE (C Johnson) – Slow to begin. Raced wide from the 800 metres.

Race 5 SUPER LIQUOR GORE &TRAFFERS HANDICAP (1335m)

WILD JACK (A Bohorun) – When spoken to regarding the performance of favoured runner rider reported the gelding had failed to handle today's track conditions.

KATANGO (G Saejorhor) – Raced wide throughout and gave ground from the 400 metres. When spoken to regarding the performance rider reported the mare had failed to handle today's track conditions.

FRIAR TUCK (C Barnes) – Raced wide through the early stages.

THE BUMPER (B Murray) – Bounded as the start was effected. When spoken to regarding the improved performance trainer K Tyler advised the gelding had appreciated the prevailing track conditions and also derived benefit from racing in a smaller field today.

Race 6 HOKONUI SUZUKI / AON INSURANCE BROKERS MAIDEN (2000m)

MIDNITE KAOS (B Murray) – Steadied when awkwardly placed on the heels of a tiring runner near the 800 metres.

LITTLE BOSSING (L Callaway) - Raced wide until being taken forward to the lead at the 800 metres...

RIVIERA ROCK (J Lowry) – Bounded as the start was effected. Lay out throughout the run home shifting wider on the track.

RED ROSETTE (C Campbell) – Gave ground from the 800 metres finishing in a distant last placing. A post-race veterinary examination revealed no obvious abnormalities.

Race 7 PETERS GENETICS & GRANT FARMING PSHIP HANDICAP (2000m)

WHAT'S UP ALF (B Murray) - Began awkwardly.

SHANTAV (T Moseley) – When spoken to regarding the improved performance trainer B Verlinden reported the gelding had appreciated being on the pace in a race run with genuine tempo.

Rider **T Moseley** admitted a breach of Rule 638(3)(b)(ii) in that he used his whip in an excessive manner prior to the 100 metres. After viewing replays and hearing submissions on penalty the JCA imposed a suspension of Mr Moseley's licence to ride from the 7th November up to and including the 13th November (5 riding days)

SPIDER LILY (C Johnson) – Over-raced through the early stages.

THE QUIET MAN (A Bohorun) – Apprentice rider A Bohorun was reminded of his obligations with regards to use of the whip prior to the 100 metres.

Race 8 AB LIME / TED WINSLOE MEMORIAL HANDICAP (2000m)

KAURI COVE (K Mudhoo) – Shifted ground outwards from the 150 metres and continued to shift outwards for the remainder of the home straight making contact with MRS GEE EYE on a number of occasions and dictating that runner wider on the track.

Stewards lodged a Protest pursuant to Rule 642(1) against 1st placing being awarded to **KAURI COVE** alleging interference from the 150 metres had materially prejudiced the chances of **MRS GEE EYE** finishing in 1st placing. After viewing replays and hearing evidence from the Stewards and connections of both runners the JCA upheld the Protest and relegated **KAURI COVE** to 2nd placing and promoted **MRS GEE EYE** to 1st placing.

Apprentice rider **K Mudhoo** with the assistance of Mr D Walsh admitted a subsequent breach of the Careless Riding Rule. After hearing submissions on penalty the JCA imposed a suspension of Mr Mudhoo's licence to ride from the 7th November up to and including the 15th November (7 riding days.)

MINUE (T Moseley) – When spoken to regarding the performance rider reported the mare had been unsuited by the testing nature of todays track conditions.

MRS GEE EYE (C Campbell) – Bumped on a number of occasions and dictated wider on the track over the concluding stages.

LIL MISS SWISS (K Kwo) - Slow to begin.

COUNTESS RUBY (B Murray) – Raced wide without cover for the majority of the event.
