Waipukurau Jockey Club - 25 October 2018

Race 3 HATUMA LIME 1200 (1200 Metres)

VINNIE'S VOLLEY (J Waddell) – Trainer J Bary advised Stewards that in the days following this race the mare underwent further veterinary examination which did not reveal any abnormality. Mr Bary added that VINNIE'S

VOLLEY had received treatment from an equine chiropractor and it is his intention to continue on with its current preparation.

Counties Racing Club - 26 October 2018

Race 1 SSANGYONG 1200

LADY AMADEUS (M Coleman) – Trainer S Autridge advised Stewards that he was satisfied with the recovery of the mare and it is his intention to continue on with its current preparation.

Race 7 SPLICE CONSTRUCTION 1400

TIGER SILK (A Calder) – Trainer R Collett advised Stewards that he was satisfied with the recovery of the filly, adding that connections would be considering applying blinkers for its next start.

Auckland Racing Club - 27 October 2018

Race 1 Winger Maserati 2100

FINAL SUGGESTION (S Spratt) – Trainer C Gibbs advised Stewards in the days following this race the gelding underwent further veterinary examination including an endoscopic examination which revealed a small amount of mucus in the trachea which the gelding has now been treated for, adding that FINAL SUGGESTION would now be freshened prior to racing next.

Race 5 Logistics Group 1600

DEMONETIZATION (M Coleman) – Trainer N Tiley advised Stewards that in the days following this race the horse underwent further veterinary examination including blood tests which did not reveal any abnormality, adding it is his intention to continue on with its current preparation.

Race 6 Partners Life Soliloquy Stakes (1400 metres)

QUEEN OF THE AIR (D Danis) – Trainer J Richards advised Stewards that the filly has gone for a spell, adding that in his opinion the filly is better suited to a shorter distance and more give in the ground.

Race 7 South Auckland Racing Club Cup (1400 metres)

UGO FOSCOLO (M Coleman) – Trainer S Marsh advised Stewards that he was satisfied with the recovery of the gelding.

TIPTRONIC (T Thornton) – Trainer G Richardson advised Stewards that he was satisfied with the recovery of the gelding and it is his intention to continue on with its current preparation.

RACE COMMENTS:

Race 1	COMCAT MDN 2000M

POROTENE MHIA (J Parkes) – Slow away. (3L)

JAYPERNO (L Hemi) – Raced three wide without cover before improving forward to sit outside the leader near the 900 metres. Hampered near the 350 metres.

THE ROLLING STONE (S McKay) – Inconvenienced at the start when TROUBADOUR began awkwardly and shifted outwards. Raced ungenerously when being restrained in the early stages.

TROUBADOUR (L Satherley) – Began awkwardly.

SILVER SEAS (T Johnson) – Failed to respond when placed under pressure near the 800 metres, quickly becoming tailed off and was then not persevered with. SILVER SEAS was immediately attended to by the course veterinary having to be humanely euthanised after suffering a significant rupture of the superficial digital flexor tendon in the right foreleg.

MADAM MAKFI (D Hirini) – Lay out rounding the final turn hampering JAYPERNO near the 350 metres with SUPERBLUE becoming awkwardly placed on that runner's heels as a result. Also hampered was BLACK ANASTA.

BLACK ANASTA (W Pinn) – Hampered 350 metres.

SUPABLUE (R Elliot) – Crowded and forced wider passing the 350 metres.

Race 2 MEMBERS RACE A HORSE FOR \$1 1100M

THEWAYYOUADEME (R Hannam) – Slow away. Had to shift out approaching the 200 metres to obtain clear running.

IF WE MEET AGAIN (D Danis) – Jumped away awkwardly.

CASCADE DE LA VIE (L Allpress) – Raced three wide without cover throughout.

Race 3 WAIKATO EQUINE VETERINARY C 1200M

SINARAHMA (J Parkes) – Raced three wide without cover.

MANGAROA DIVA (L Satherley) – Held up entering the final straight near the 350 metres and did not obtain clear running until near the 150 metres. Inclined to lay in under pressure in the final straight.

HERE WE GO (S McKay) – Held up for a distance near the 200 metres when attempting a marginal run to the inside of STARRY SHIRAZ.

HABIT MY WAY (D Turner) – Was not persevered with after becoming tailed off in the middle stages, rider reported the gelding felt sore in the left foreleg. A post-race veterinary inspection did not reveal any obvious abnormality. Connections were advised a veterinary clearance would be required prior to racing next.

THE LAST WORD (D Johnson) – Had difficulty obtaining clear running early in the final straight.

WICKLOW (L Allpress) – When questioned regarding performance rider advised that in her opinion the gelding would now be better suited over more ground and possibly with the addition of blinkers.

Race 4 STELLA ARTOIS MDN 1600M

JUDITH GARDENIA (S Collett) – Crowded start.

BOBBY DEE (M Cameron) – Ran very wide when making the turn near the 1200 metres awkwardly hampering ROC YA SOX which was forced over extra ground. Lay inwards under pressure in the final straight.

ROC YA SOX (J Parkes) – Hampered when forced over extra ground rounding the turn near the 1200 metres.

ATLOBAZ (R Hannam) – Raced three wide without cover.

COLLINSTREET (J Parkes) – Steadied after improving on to heels near the 1100 metres.

VIVA LILLI (T Yanagida) – When questioned regarding his riding tactics T Yanagida advised that he was advised to sit second or third during the running and after being caught wide in the early stages he had elected to improve forward to lead, but then agreed with Stewards that once in front he allowed his mount to run along at an unsustainable pace, before then weakening over the concluding stages. Apprentice T Yanagida was advised that he would be expected to show far better judgment in future.

Race 5 | **LANDMARK HOMES MDN 1400M**

AUSTRIA (W Pinn) – Slow away. Held up until approaching the 100 metres and then shifted ground outwards with **MIDNIGHT SHOCKA** (B Grylls) shifting away from that runner hampering **WESTSIDE** (T Johnson). W Pinn and B Grylls were both advised to exercise care.

WESTSIDE (B Grylls) – Hampered approaching the 100 metres.

SPRING BLOSSOM (T Yanagida) – Commenced to over race when being restrained passing the 1200 metres, continuing to over race badly improving forward to sit outside the leaders three wide near the 700 metres.

CUIDADO CALIENTE (V Colgan) – Checked near the 1100 metres.

H Parkes – Admitted a breach of careless riding in that she permitted her mount **GREAT NORTH ROAD** to shift inwards when not sufficiently clear of **CUIDADO CALIENTE** which was checked near the 1100 metres. After hearing evidence and viewing footage the Judicial Committee imposed a suspension of Apprentice H Parkes licence to ride in races from the conclusion of racing on Thursday 8 November until the conclusion of racing on Thursday 15 November 2018 (5 national days).

Race 6 | **THE PLATINUM HOMES TARANAKI 1400M**

IGNORED (M Cameron) – Slow away after being hampered leaving the barriers when impeded by the outside gate which sprung back after not catching correctly. This issue was reported to the starter with the barriers being checked prior to the next race and found to be functioning correctly.

CANDY CROSS (T Taiaroa) – Hampered shortly after leaving the barriers.

SWIFT SAOIRSE (S McKay) – Crowded shortly after leaving the barriers.

MR JIMMY POCKET (T Newman) – Raced three wide without cover throughout.

Race 7 | **SEATON PARK 1400M**

RINGMASTER (S Collett) – Slow away.

TERRACOTTA WARRIOR (S Collett) – Raced wide without cover.

KING'S VEE (W Pinn) – Was unable to obtain clear running over the final 150 metres.

FIELD OF FIRE (J Parkes) – When questioned regarding the performance rider advised that the gelding had every chance today but, in his opinion, may be better suited being ridden in the open.

Race 8 | **ISABELLA SPIERS 1800M**

BATCHELOR BABE (W Pinn) – Had difficulty obtaining clear running early in the final straight.

Race 9 | **NEXT TWILIGHT FRIDAY NOV 23RD 2000M**

KORAKONUI (S Collett) – Crowded shortly after the start having to be steadied.

BRAHMARAHMA (W Pinn) – Crowded and checked 1600 metres. Was not persevered with in the final straight when well beaten.

PIERAN SPRING (R Elliott) – Hampered 1600 metres.

KIRKENES (B Grylls) – Held up for a distance approaching the 250 metres.

R Hannam – Admitted a breach of careless riding in that he permitted his mount VEGA to shift inwards when not sufficiently clear of BRAHMARAHMA which was checked near the 1600 metres. Also hampered as a result was PIERAN SPRING. After hearing evidence and viewing footage the Judicial Committee imposed a suspension of R Hannam's licence to ride in races from the conclusion of racing on Thursday 8 November until the conclusion of racing on Thursday 15 November 2018 (5 national days).
