### RACE COMMENTS:

<b>Race 1</b>	<b>CERVUS EQUIPMENT NZ LIMITED 2100 (2100 metres)</b>
<b>KAIRANGA LAD</b> (C O'Beirne) – Awkwardly away settling back.	

**VERACIOUS** (N Bakar) – Slow away.

**QIAN GUA** (L Allpress) – Over-raced in front in the early to middle stages despite the rider’s attempt to restrain it. When questioned into performance rider advised that after racing fiercely the gelding had little left at the finish. A subsequent veterinary inspection was clear.

**COMMANDING PRINCE** (M Singh) - Raced keenly in the middle stages.

**ANIMATOR** (C Johnson) – Held up behind the tiring QIAN GUA rounding the turn.

**OPHELIA LEE** (L Hemi) –Lugged throughout. When questioned into the disappointing run, rider said despite the mare’s tendency to lay in she was of the opinion OPHELIA LEE was better suited to more rain-affected going.

**Race 2** | **HIGGINS CONCRETE/BNZ PARTNERS 3YO (1300 metres)**

**LINCOLN FURY** (R Hannam) – Slow away.

**JUST FABULOUS** (L Allpress) – Raced keenly in the early stages.

**N Bakar** (TOTAL EXCESS) – Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres. After viewing footage and hearing submissions the JCA suspended Apprentice Bakar’s licence to ride in races from the conclusion of racing on Wednesday, 28 November up to and including racing on Friday, 14 December (12 days).

**Race 3** | **MCDONALDS PALMERSTON NORTH/PROPERTY BROKERS 1400 (1400 metres)**

**VICTOR VEGAS** (C Johnson) – Slow away. Contacted at start.

**PADDY BOURKE** (T Johnson) – Began awkwardly contacting VICTOR VEGAS. Got its head in the air for a distance near the 900 metres. Held up for a distance passing the 500 metres. T Johnson was issued with a warning under Rule 638(3)(b)(ii) with regards to his whip use prior to the 100 metres.

**CHOICE ATTITUDE** (C O’Beirne) - Raced keenly in front in the early and middle stages.

**JESSIEGEE** (D Hirini) - Raced three wide without cover throughout.

**Race 4** | **HAZLETT RURAL LIMITED/SMARTPHONE REPAIRS 1200 (1200 metres)**

**ELETTRA** (S O’Malley) – Charged its starting gate as the start was made, beginning very awkwardly, simultaneously as LAST CHANCE jumped inwards at the start contacting, tightening and hampering AL VANDAAM, which settled back.

**AL VANDAAM** (T Taiaroa) - Tightened and hampered at start.

**LAST CHANCE** (R Hannam) - When questioned into performance rider advised the mare may appreciate more rain-affected going.

**EXHIBIT** (L Hemi) – Bumped early in the home straight.

**MAGICO** (T Allan) - Jumped inwards at the start inconveniencing SATIN BELT which also began awkwardly.

**T Allan** (MAGICO) – Issued with warning until Rule 638(3)(b)(ii) with regards to his whip use prior to the 100 metres.

**SATIN BELT** (L Allpress) – Began awkwardly, raced keenly in the early stages.

**PLAY THE FIELD** (N Bakar) - Made the bend awkwardly near the 800 metres. Lay out under pressure early in the home straight, bumping EXHIBIT.

**S O'Malley** (ELETTRA) – Spoken to advisedly by the apprentice riding masters with respect to his whip action.

**Race 5** | **HUNTING AND FISHING/FARMLANDS CO-OPERATIVE SOCIETY LIMITED 2100 (2100 metres)**

**SERENITY** (T Johnson) – Connections advised the mare was coming into season, but were happy to start.

**GAME OVER** (M Singh) – Slow away. Returned to the enclosure with blood present in the nasal area. A post-race veterinary inspection revealed a small laceration to a nostril.

**ARTAXERXES** (T Taiaroa) – Awkwardly away.

**FRUITION** (Z Moki) - Became awkwardly placed on the heels of GAME OVER having to be restrained approaching the 1400 metres.

**PRINCE TURBO** (S O'Malley) - Raced three wide without cover in the early to middle stages before improving forward to sit outside the leaders approaching the 800 metres.

**STARRYBEEL** (C Johnson) - Held up for a distance approaching the 400 metres then raced in restricted room near the 200 metres.

**RED RASCAL** (C O'Beirne) - Became awkwardly placed on the heels of LECTIO DIVINIA near the 300 metres having to be angled outwards across heels to gain clear running.

**ATLANTA PEACH** (T Allan) - Lay inwards having to be straightened near the 200 metres.

**Race 6** | **JOHN TURKINGTON FORESTRY LIMITED/WAI PINE LTD BULLS COUNTRY CUP (1500 metres)**

**JACKSSTAR** (T Allan) - Awkwardly away settling back.

**SCANDALO** (C Johnson) – Slow away. Held up passing the 400 metres having to be angled outwards across heels near the 150 metres to improve.

**ZORRALI** (D Hirini) – Slow away.

**SOROC** (W Pinn) – Tightened and checked near the 200 metres. When questioned into performance rider advised the gelding may appreciate some easing in the track conditions. A subsequent veterinary inspection was clear.

**C Johnson** (SCANDALO) – Admitted a breach of Rule 638(1)(d) in that he angled his mount out when not clear of SOROC near the 200 metres. After deliberations C Johnson had his licence to ride in races suspended from the conclusion of racing on Sunday, 25 November up to and including Wednesday, 5 December (6 days).

**Race 7** | **MCVERRY CRAWFORD/HARRIS CONTRACTING 1550 (1550 metres)**

**BEFORE DAWN** (D Hirini) – Reared at the start, shifting inwards hampering CANDY CROSS. Raced ungenerously, getting its head in the air near the 800 metres.

**CANDY CROSS** (T Allan) – Hampered start.

**ORIGINAL GANGSTER** (L Allpress) – Raced three wide without cover throughout.

**L Allpress** (ORIGINAL GANGSTER) - Issued with warning until Rule 638(3)(b)(ii) with regards to her whip use prior to

the 100 metres.

**FATTORE OTTO** (N Bakar) – Held up for a short distance near the 350 metres.

**PERAZZO** (M Singh) – Shifted inwards under pressure early in the home straight.

**Race 8**

**TOD SEEDS/WENHAM GRAIN & SEEDS 1550 (1550 metres)**

**RUSTY IN MELBOURNE** (C Johnson) – Slow away.

**EDWARDIAN LADY** (L Hemi) - Raced greenly in the early stages.

**ALLURE** (T Tairaoa) - Raced three wide on the pace throughout.

**THAT'S AMORE** (T Allan) - Briefly held up near the 400 metres.
