NACE COMMENTS.			
Race 1	RIVERSTONE CAFÉ 1300 (1300 Metres)		
PLATINUM COMMAND (T Johnson) –Awkwardly away.			

PETITE EN JEU (L Allpress) – Raced keenly in the early stages having to be steadied near the 800 metres when SALAMANCA (D Hirini) shifted in when not entirely clear. D Hirini was advised to exercise more care. Held up rounding the turn before being restrained near the 300 metres when attempting a run to the inside of SALAMANCA, which did not eventuate, before angling outwards across heels to gain clear running passing the 200 metres.

M Singh (TAURUS) – Issued with a warning under Rule 638(1)(d) after allowing his mount to shift in approaching the 200 metres when not the required distance clear of SALAMANCA, which was inconvenienced.

SALAMANCA (D Hirini) – Inconvenienced approaching 200 metres.

Race 2 CAVALLO FARM & CHRIS RUTTEN BLOODSTOCK 1600 (About 1630 Metres)

OPHELIA LEE (S Collett) - Slow away.

SHADOW KING (D Hirini) – Slow away.

HIGH QUALITY (C Johnson) – Slow away.

MASTER PAT (R Hannam) - Raced keenly in the early to middle stages.

MAUNA KEA (H Schofer) - Raced three wide without cover in the early stages. – Lay in under pressure near the 50 metres before being straightened. H Schofer was issued with a warning under Rule 638(1)(d) and advised that she is expected to straighten her mount sooner than she did on this occasion.

SYLVESTER (B Ansell) – Restrained off heels near the 800 metres. Held up approaching the 400 metres gaining clear running near the 300 metres.

RICHARD OF YORKE (C Burdan) – Hampered near the 50 metres when becoming awkwardly placed on the heels of MASTER PAT, which was dictated inwards by MAUNA KEA, which lay in under pressure prior to being straightened.

DEZ (D Bradley) – Raced keenly in the early to middle stages when wide without cover. Gave ground entering the home straight and was not persevered with over the final stages when out of contention. D Bradley advised the gelding raced keenly throughout in the testing going and had little left at the finish under the 61.5kg. A post-race veterinary inspection revealed a mild increase in respiratory rate.

Race 3 EL CHEAPO CARS 1400 (1400 Metres)

DRAGON DANCER (M Singh) - Reared as the gates were opened losing ground then raced ungenerously in the early stages.

DO YA (C O'Beirne) – Gave ground quickly from the 600 metres and was not persevered with when well out of contention. When questioned, rider could offer no excuse. A subsequent veterinary examination was clear. Trainer K Lawrence advised the mare would no longer be considered a racing proposition from her stable.

Race 4 SUNRANS SPA 2100 (2100 Metres)

THE PUKETAPU LAD (T Johnson) Tightened at the start, settling back when WYNTHORPE jumped inwards. Finished some distance last. T Johnson could offer no tangible excuse. A subsequent veterinary examination was clear.

SPEED CALL (C Johnson) - Raced keenly in the early to middle stages.

ALL IN STITCHES (H Andrew) - Raced wide without cover throughout.

Race 5 VETS ON RIVERBANK 1400 (1400 Metres)

Trainers J Benner/H Wynyard (DEVINE LOVE) – Issued with a warning under Rule 537(a) for the late declaration of rider.

HE'S A FREAK (R Elliot) -Awkwardly away settling back. Finished well back. Rider could offer no excuse. Trainer advised the gelding would no longer be considered a racing proposition from her stable.

DEVINE LOVE (E Wright) - Raced keenly in the early stages. Saddle slipped forward rounding the turn placing the rider at a disadvantage.

Race 6 GARDNER HOMES 1600 (About 1630 Metres)

BAE CORP (B Ansell) - Slow away.

EN ZED FOXY (R Hannam) - Slow away.

KARIMA (M Singh) - Awkwardly away, settling back.

RIGEL (C Johnson) - Raced keenly in the early to middle stages.

DEPENDABLE MAN (R Elliot) –Rider could offer no excuse. A subsequent veterinary inspection proved clear.

Race 7 AQUASHIELD ROOFING 1400 (1400 Metres)

Trainer J Kiernan (RARE BREED) – Issued with a warning under Rule 616(2) after presenting his runner without the notified pre-race ear covers.

SANCTUM (R Hannam) – Slow away (3L). Steadied near the 1000 metres when RED MYSTIC (M Hudson) shifted in. M Hudson was advised to exercise care.

DETONATE (S Collett) - Began awkwardly contacting MY FATHER'S GUN, which settled back.

CHILLI JEAN (D Turner) - Slow away.

MY FATHER'S GUN (T Johnson) – Contacted start. Angled out shortly after the start making heavy contact with the hind quarters of JAW GEE, briefly unbalancing that runner. T Johnson was issued with a warning under Rule 638(1)(d) and advised to exercise greater care when shifting ground. Held up entering the home straight before being angled inwards to improve near the 300 metres, then had to be angled outwards across heels near the 200 metres to gain clear running.

TENNESSEE ROSE (L Allpress) Briefly tightened near the 200 metres when MY FATHER'S GUN shifted outwards.

VELOCE (H Andrew) - Raced wide without cover throughout.
