M McNab was stood down following Race 7 as he was unwell. M McNab is to provide a medical certificate to Stipendiary Stewards prior to riding next.	

RACE COMMENTS:

Race 1	SSANGYONG 2100
<p>DELEGATE (E Leighton) – Began awkwardly losing ground. Held up rounding the final turn before shifting out to obtain clear running passing the 350 metres.</p> <p>YATIMA (C Grylls) – Had to steady when in restricted room shortly after the start. Briefly steadied away from the heels of VERA DRAKE (M Coleman) near the 150 metres when that runner shifted out to obtain clear running. M Coleman was reprimanded and advised to exercise care in a similar circumstance. When questioned regarding performance rider C Grylls could offer no tangible excuse. Trainer S Marsh advised the mare was feeling the effects of recent racing and would now be spelled.</p> <p>ANIMATOR (C Dell) – Made contact soon after leaving the barrier jostling for a distance and then being steadied.</p> <p>WINKLEBELLE (S McKay) – Made contact and jostled soon after leaving the barrier.</p> <p>SKAABOOM (M McNab) – Raced keenly in the early stages shifting out when steadying away from heels near the 1800 metres. Raced wide without cover until improving forward near the 1200 metres to lead.</p> <p>MAV (A Calder) – Steadied when in restricted room to the inside of NULLI SECUNDUS which shifted in slightly passing the 1700 metres, then over-raced for a distance.</p> <p>R Scott (NULLI SECUNDUS) – Issued with a warning after permitting NULLI SECUNDUS to shift in near the 1700 metres when insufficiently clear of MAV which had to be steadied losing ground.</p> <p>BABOONSKI (R Smyth) – Had to be restrained off heels when over-racing passing the 1000 metres, and then continued to over-race for a distance.</p> <p>THE ICE KNIGHT (S Spratt) – Held up until near the 400 metres.</p>	
Race 2	NZB INSURANCE PEARL SERIES RACE 1200
<p>PEERLESS WARRIOR (D Mansour) – Began awkwardly losing ground.</p> <p>STARRING ROLE (C Lammas) – Slow to begin, then crowded shortly after having to be steadied.</p> <p>DARCEE QUE (M Coleman) – Began awkwardly, then shifted out making contact with RUBY NEGRONI.</p> <p>JUST A GIRL (R Scott) – Raced wide without cover when challenging for the lead throughout. Apprentice Rider R Scott was questioned regarding her riding tactics, and in particular why she had asked JUST A GIRL to continue to improve outside the leaders for a distance from near the 1000 metres while in a three wide position outside the leaders. R Scott explained that she had anticipated R Smyth (MACUSHLA) steadying affording her the opportunity to drop in a position one off the fence, further explaining that she had erred in her judgement when this had not eventuated.</p> <p>GUMPERT (A Calder) – Lay out under pressure in the final straight with rider A Calder reporting that the filly had hung outwards throughout.</p>	
Race 3	MALCOLM WRIGLEY INSURANCE SERVICES 1200
<p>FAST MOVER (S McKay) – Slow to begin. Inconvenienced 250 metres</p> <p>SARDONIA (C Grylls) – Slow to begin. Shifted out to obtain clear running passing the 150 metres inconveniencing the weakening BREAK THE RULES.</p>	

BREAK THE RULES (T Thornton) – Began awkwardly. Over-raced in the early and middle stages. Raced wide without cover.

DREAM (M McNab) – Crowded shortly after the start having to be steadied.

FIRMAMENT (R Smyth) – Crowded shortly after the start having to be steadied.

TANGODANZER (S Collett) – Crowded near the 700 metres by GIRL OF STEEL which shifted out to avoid heels.

SIR RALPH (C Lammas) – Raced wide without cover.

M Coleman (FROZEN) – Admitted a breach in that he used the whip excessively when riding FROZEN with the Judicial Committee imposing a fine of \$300.

Race 4	IRT 1200

MR BIG (C Dell) – Began awkwardly losing ground.

ICHIBAN (D Mansour) – Began awkwardly.

TINY TERROR (E McCall) – Began awkwardly shifting in making contact with the hind quarters of BITS AND PIECES, and then was crowded shortly after having to be steadied.

HUMORESQUE (M McNab) – Began awkwardly.

MAGNIFY (S Collett) – Lay out when making the bend near the 900 metres, and continued to hang out for the remainder of the bend. Shifted out to obtain clear running passing the 350 metres making contact with QUALITY PREVAILS which became briefly unbalanced. S Collet was advised to exercise care in a similar circumstance.

QUALITY PREVAILS (T Yanagida) – Contacted 350 metres, then raced in restricted room for a distance.

T Newman (RED TSUNAMI) – Reminded of her obligations that she must not shake hands prior to weighing in.

Race 5	MOUNT SHOP 1400

BLARACK (S Collett) – Began awkwardly. Held up near the 250 metres after improving on to heels. BLARACK was again held up passing the 100 metres when improving on to heels, and then continued to be held up for the remainder of the race.

VALMUR (D Danis) – Began awkwardly.

MAGDALA (C Grylls) – Began awkwardly.

HAVANA HEIGHTS (V Colgan) – Raced keenly in the early stages.

DAMESEL (S Spratt) – Raced wide without cover throughout.

R Elliot (VANILLA CHINCHILLA) – Issued with a warning for the manner in which he used the whip in the final straight (arm above shoulder).

Race 6	STELLA BACKDROPS 1400

COMPULSIVE (M McNab) – Presented to race without notified gear (blinkers). Trainer C Chipperfield was granted permission to remove the blinkers after it was found the gelding had never worked or trailed in blinkers and they had

been declared in error. C Chipperfield was fined \$50 for under the minor infringement schedule. Began awkwardly, then crowded shortly after having to be steadied.

SIGNOR DAL (K Chowdhoo) – Crowded shortly after leaving barrier.

OUR ELLIEMAY (C Grylls) – Began awkwardly, then crowded shortly after having to be steadied.

THREE SIXTY (A Collett) – Slow to begin, then crowded shortly after.

BARBARA (R Smyth) – Crowded shortly after the start having to be steadied.

SHANQUEEN (M Coleman) – Began awkwardly shifting in making contact with BARBARA.

ANGELICA (C Lammas) – Contacted and unbalanced shortly after the start losing ground as a result.

MANRICO (T Thornton) – Over-raced when being steadied approaching the 1000 metres.

HETTY (S Spratt) – Got its head up when being steadied passing the 1000 metres.

SYMBIO (J Riddell) – Raced greenly when placed under pressure in the final straight.

MAN POWER (E McCall) – Rider E McCall was reminded of her obligations in that she must ride her mounts out fully to the end of a race when circumstances permit her to do so.

SOUTHERN QUEEN (M McNab) – Began awkwardly losing ground. When questioned regarding performance rider M McNab explained that after a poor beginning the filly had failed to recover.

WHISPER ROCK (S Collett) – Began awkwardly losing ground.

LIVVY LASS (D Mansour) – Began awkwardly losing ground. Inconvenienced approaching the 400 metres.

SHEBRINGSMERUBIES (J Kamaruddin) – Began awkwardly.

GLOBAL DIAMOND (D Danis) – Held up early in the final straight.

COLOGNE (S Spratt) – Lay out approaching the 400 metres inconveniencing SODA.

Race 8	LONE STAR PUKEKOHE 1600

RIPPIN (S Collett) – Began awkwardly. Had difficulty obtaining clear running early in the final straight, and then was briefly steadied passing the 200 metres when improving onto the heels of RAAJ (K Chowdhoo) which shifted in. RIPPIN then shifted out to obtain clear running. K Chowdhoo was advised that he must exercise greater care in a similar circumstance.

GRAND RIO (J Riddell) – Steadied when awkwardly placed 900 metres shifting back on to INNAMINCKA which was steadied.

GOODWILL (R Beemud) – Raced wide without cover when challenging for the lead throughout.

Race 9	HAUNUI FARM 1600
---------------	-------------------------

L Saunders (MASTER GENIE) – Issued with a warning after MASTER GENIE was presented to race without notified gear (blinkers).

MASTER GENIE (D Danis) – Slow to begin.

MUELED (A Calder) – Slow to begin, then crowded shortly after.

UABASSO (R Smyth) – Began awkwardly. Had to be steadied away from heels passing the 1000 metres.

MY DAKOTA (S Spratt) – Slow to begin. Steadied 1350 metres losing ground.

ROBUSTO (A Goindasamy) – Crowded 1350 metres and steadied. Held up early in the final straight.

RED BEACH (D Mansour) – Crowded 1350 metres and steadied.

DEEJAY MAC (R Elliot) – Crowded 1350 metres and hampered losing ground. Became awkwardly placed on heels passing the 600 metres having to be steadied.

J Kamaruddin (KING'S SECRET) – Admitted a breach of careless riding in that he permitted his mount to shift in passing the 1350 metres crowding **ROBUSTO**, **RED BEACH** and **DEEJAY MAC** which were all hampered. After hearing all relevant evidence the Judicial Committee suspended J Kamaruddin's licence to ride in races from the conclusion of racing on 23 June up to and including racing on 6 July, 7 national riding days.

MONT VENTOUX (C Dell) – Held up early in the final straight.

BOJANGLES (A Collett) – Had difficulty obtaining clear running until near the 300 metres.

Race 10

ALF COLE MEMORIAL 1600

NICOLE ASHLEY (D Mansour) – Knuckled leaving the barrier. Rider D Mansour reported the filly had raced keenly throughout.

TEEN TITAN (A Jones) – Knuckled leaving the barrier. Shifted in passing the 400 metres making contact with **CAVALLI STORM**.

MIDNIGHT DUKE (T Thornton) – Hampered soon after leaving the barrier.

CAVALLI STORM (C Grylls) – Began awkwardly. Crowded 900 metres.

MY CALLISTO (A Calder) - Contacted 400 metres and shifted out passing the 300 metres inconveniencing **TEEN TITAN**, then continued to race greenly in the final straight

ZENNTARI (K Chowdhury) – Began awkwardly losing ground.

HUNUA HANK (S Collett) – Raced ungenerously when being steadied in the early stages.

WILD LIKE (R Elliot) – Raced keenly in the early to middle stages shifting out passing the 900 metres crowding **CAVALLI STORM**.

KEPELLA HEIGHTS (E McCall) – Had difficulty obtaining clear running until crowded when improving into a marginal run passing the 250 metres to the outside of **WILD LIKE** (R Elliot) which shifted out under pressure. R Elliot was advised to exercise greater care.

LADY AZAMOUR (M Coleman) – Inconvenienced and steadied passing the 200 metres when laying in on the heels of **TEEN TITAN** (A Jones) which shifted out slightly. A Jones was advised to exercise greater care.
