G Vile - Prior to the running of Race 2 Trainer G Vile requested a ruling under Rule 534 (2) (b) in that he be given permission to scratch his remaining runners due to the testing track conditions. After hearing submissions, the Committee dismissed this request on the grounds that there had been no material change in track conditions since the scratching deadline. G Vile then scratched his remaining three runners and admitted a breach of Rule 534 (1) G Vile was fined the sum of \$350.

SUPPLEMENTARY:

RACE COMMENTS:

Race 1 LIQUORLAND MDN HWT 1600m

CLASSCLOWN (D Turner) - Restrained off heels near the 1,100 metres.

THE REVENANT (R Elliot) - Disappointed finishing well back. When questioned R Elliot advised the gelding was unsuited to the very testing conditions. A subsequent veterinary inspection was clear.

T JOHNSON (MASTER BLACK JACK) – Was observed to relax his ride over the final stages. When questioned T Johnson advised he was feeling the effects of the flu and was unable to ride his mount out over the final stages. T Johnson was stood down for his remaining rides and will require a medical certificate prior to riding next.

Race 2 COMMDIVES NZ HWT 1600m

TALLYHO TWINKLETOE (T Moki) - Raced keenly in the early stages.

Race 3 B CONNORS FAMILY CLAN MDN 3YO 1600m

HALFASIXPENCE (M Hudson) – Awkwardly away and settled back.

EISENHOWER (S McKay) – Made the bend awkwardly near the 1,400 metres.

LAVA ROCK (R Elliot) - When questioned into the performance rider advised the gelding did not appreciate today's Heavy 11 track conditions. Trainer L Latta advised **LAVA ROCK** would now be sent for a spell.

JAKKIFROMTHENAKI (S Collett) – When questioned into the performance rider advised the filly was unsuited to today's heavy track.

Race 4 NZB INSURANCE PEARL SERIES RACE F&M 1340m

FULL SWING (D Hirini) – Underwent a pre-race veterinary inspection after making contact with the rail in the enclosure and was cleared to start. Finished well back. Trainer advised the mare would now be sent for a spell.

STYLE BY DESIGN (S McKay) - Began awkwardly settling back. Lay in under pressure over the final stages.

ALLURE (M Singh) – Tightened shortly after the start.

LADY RUDOLPH (S Collett) - When questioned into the performance rider advised the mare had not handled today's Heavy11 track conditions.

SAVANAH BELLE (L Allpress) - When questioned into the performance rider advised the filly was unsuited to today's Heavy11 track conditions.

Race 5 GUDSELL CLAN 1200m

SAPPHIRE SKY (H Andrew) - Began awkwardly settling back.

BROTHER ONE (S Macnab) - Restrained from an inside draw before being angled outwards across heels in search of better footing wide on the track.

H Andrew was issued with a warning under Rule 638 (3) (b) (ii) with regards her whip use prior to the 100 metres.

Race 6 THE WHANGAEHU O'LEARYS MDN 1200m

MAGIC INCANTO - T Johnson was initially replaced by D Turner who subsequently advised that he would be unable to make the weight, as there were no suitable senior replacements connections were given permission for Apprentice H Andrew to take the mount.

QUEEN OF FIRE (J Baillie) - Tightened at the start settling back.

DOLCE AMORE (C Burdan) - Raced keenly in the early stages then inconvenienced near the 1,000 metres.

M SINGH (GREAT NORTH ROAD) - Was issued with a warning under Rule 638 (1) (d) after allowing his mount to shift inwards near the 1,000 metres when not entirely clear of **DOLCE AMORE** which was inconvenienced.

HE'S DONE A RUNNER (J Parkes) - When questioned into the performance rider advised the gelding had been unsuited to today's Heavy11 track conditions.

J Baillie (QUEEN OF FIRE) – Admitted a breach of Rule 638 (3) (b) (ii) in that he used his whip excessively prior to the 100 metres and was fined \$300.

Race 7 MOORE-MCKINNON CLAN MDN 2040m

WHO BOY (D Hirini) – Began awkwardly then raced keenly in the early stages.

COG KNISH (H Andrew) – Rider dropped her whip near the 350 metres.

PASSING GLANCE (R Elliot) – Was not persevered with in the home straight when well out of contention. Rider advised the mare had ben unsuited by today's Heavy 11 track conditions.

KION (S McKay) – When questioned into the performance rider advised the gelding had not appreciated today's Heavy 11 track conditions.
