RACE COMMENTS:

Race 1	MCRORBIE CONTRACTING LTD 2100
ZENNTARI (J Riddell) - Began awkwardly losing ground.	
FIGEAMEOUT (R Elliot) - Began awkwardly losing ground. When questioned regarding performance rider was unable to offer any excuse.	
ANNALONE (S McKay) - Began awkwardly losing ground.	
KIPLING (A Goindasamy) - Made the bend near the 850 metres awkwardly.	
Race 2	KOPE TURF BAR 2YO

D Mansour (LOCHWINNOCH) - Was replaced on LOCHWINNOCH after his rider agent advised on race morning that he was unable to be on course in time to take his mount. D Mansour admitted a charge in that he broke a riding engagement without reasonable cause being fined \$150 by the Judicial Committee.

LOCHWINNOCH - S McKay replaced D Mansour. Underwent a pre-race veterinary inspection after suffering an abrasion to the right hind leg being passed suitable to race.

GLORY CHANCE (C Lammas) - Crowded and steadied losing ground shortly after the start. Got its head up and raced ungenerously when being steadied after being placed in restricted room to the outside of DARCI'S TUNE when that runner was taken out by ELECTROFYING near the 1000 metres.

COMING UP ROSES (A Calder) - Slow away.

LOVECHARM (L Allpress) - Placed in restricted room shortly after the start losing ground.

DARCI'S TUNE (M McNab) - Had to be steadied near the 1000 metres to avoid the heels of ELECTROFYING which shifted outwards when over-racing.

ELECTROFYING (S Spratt) - Commenced to over-race shortly after the start shifting outwards near the 1000 metres then racing wide without cover.

STATELINE (R Elliot) - Held up rounding the final bend before obtaining clear running near the 300 metres.

Race 3 | **GOLDEN GRAIN LTD 3YO**

J Riddell (JAMES DEAN) - Fined \$250 by the Judicial Committee after failing to make the weight for JAMES DEAN being replaced by S McKay.

PANGO (D Mansour) - Shifted outwards abruptly on jumping away hampering NOT USUAL DELIGHT which was forced outwards onto JAMES DEAN.

NOT USUAL DELIGHT (M McNab) - Hampered on jumping away losing ground. Steadied near the 500 metres. Inclined to lay out in the straight.

JAMES DEAN (S McKay) - Hampered and unbalanced on jumping away losing ground.

ANGEL DIVINE (A Calder) - Jumped outwards at the start hampering DAY DREAMER.

DAY DREAMER (T Thornton) - Hampered start.

DEPENDSONSITUATION (C Lammas) - Raced greenly under pressure in the final straight.

INTO THE DEEP (R Elliot) - Steadied over the concluding stages when improving onto heels.

Race 4 | **HR FISKEN & SONS LTD 1200**

POWALIGN (D Danis) - Began awkwardly losing ground.

DAISY DUKES (L Satherley) - Crowded and steadied at the start losing ground.

UP 'N' GONE (J Fawcett) - Held up rounding the final turn, and continued to have difficulty obtaining clear running until near the 300 metres.

Race 5	TEAM WEALLEANS 1200
<p>PERSWAYED (S Spratt) - Escaped riderless from the start and after being recaptured underwent a veterinary examination being passed as suitable to race. As a result the race ran approximately 4 minutes late.</p> <p>BALIOS (J Riddell) - Crowded leaving the barriers.</p> <p>RASPBERRY SWEET (C Lammas) - Crowded leaving the barriers.</p> <p>MUTECHI (R Elliot) - Had to be steadied just short of the finish when FASTELLIE (T Thornton) shifted outwards under pressure. T Thornton was advised to exercise care. Contributing was some inward movement from CAMEAHOTFRIDAY.</p> <p>A Goindasamy (CAMEAHOTFRIDAY) - Issued with a warning for his whip use prior to the 100 metres.</p> <p>Following this race several senior riders expressed concerns as to the conditions with the race having been run in heavy rain, and in particular a lack of visibility. A meeting was convened of Stipendiary Stewards, Rider, Trainer and Club representatives following which the decision was made to abandon the remainder of the programme on safety grounds predominantly due to visibility concerns, also taking into account an adverse weather forecast for the remainder of the afternoon.</p>
