T Johnson was given permission by Stewards on 5/6/2019 to forego his ride on BIG BEN (Race 3) and was replaced by D Turner.

# RACE COMMENTS:

Race 1 UNCLE RUSSELL GOES TO THE RACES 2000M

EL SENOR (S Karnicnik) – Began awkwardly, contacting BLACK ANASTA briefly unbalancing the rider, settling back.

BLACK ANASTA (D Turner) – Contacted at start settling back.

**DO THE TWIST** (K Veenendaal) – Restrained from a wide draw.

**BURDOCVELVETPRINCE** (M Roustoby) – Raced very keenly in the early stages shifting outwards to avoid heels near the 1600 metres inconveniencing SENOR PINYATA, then continued to race keenly throughout.

SENOR PINYATA (G Walsh) – Inconvenienced 1600 metres.

**ZABDI** (T Moki) – Hampered near the 1700 metres. Briefly inconvenienced behind the tiring DANGERMAN near the 500 metres.

**DANGERMAN** (E Farr) – When questioned into performance rider advised the gelding had not appreciated todays track conditions. A post race veterinary inspection was clear.

TWIN SPINNER (J Riddell) – Inconvenienced 1700 metres.

WEST COAST (A Kuru) - Checked near 1700 metres.

**E Farr** (DANGERMAN) – Admitted a breach of Rule 638(1)(d) in that she allowed her mount to shift in near 1700 metres when not clear of ZABDI which was hampered, shifting out inconveniencing TWIN SPINNER and checking WEST COAST. The JCA suspended Jockey Farr's license to ride from conclusion of racing on 8 June 2019 up to and including 14 June 2019 (2 days).

J Riddell (TWIN SPINNER) – Was issued with a warning under Rule 638(3)(b)(ii) with regard to his whip use prior to the 100 metres.

# Race 2 NZB INSURANCE PEARL SERIES RACE 1200 M DELLA SIRENA (D Danis) – Began awkwardly settling back. When questioned into performance rider advised the filly had not appreciated today's heavy 11 track conditions.

CHILLI JEAN (K Asano) – Raced keenly in the early stages.

**RARE BREED** (B Ansell) – Raced wide without cover throughout.

# Race 3 STABLE BOOKS SPARTA RACING HWT 1600 M

**INVERNESS** – Slow away.

**PYTHAGORUS** – Began awkwardly settling back.

**INDAH** (J Riddell) – Slow away.

**MOUNT VENTOUX** (C Dell) – Raced keenly for a distance near the 1000 metres. Raced in restricted room near the finish when ALVIN'S DREAM shifted out under pressure.

**R Elliott** (STACCATO) – Was reminded of his obligation to ride his mounts out fully to the line when circumstances permit.

# Race 4 STABLE BOOKS PIKE RACING MAIDEN 1600 M

**BAE CORP** (B Ansell) – Slow away. Ran up onto the heels of TUBTHUMPING which shifted out under pressure having to be angled inwards to improve near the 100 metres.

**LITTLEMISSPUNKY** – Slow away.

**DECLARADA** (A Goindasamy) – Made the bend awkwardly crossing the junction on to the course proper. When questioned into performance rider advised the filly did not handle the heavy 11 track conditions.

**RELIABLE FRIEND** (E Leighton) – Restrained off heels near the 900 metres, and again near the 1200 metres.

**TUBTHUMPING** (S O'Malley) – Shifted out under pressure in the home straight.

### Race 5 ZED AT GRANGEWILLIAM STUD 1100 M

LA FEELYA (H Schoefer) – Awkwardly away.

**FAST MOVER** (R Scott) – Raced keenly in the early stages.

**HONFLEUR** (A Goindasamy) – When questioned into performance the rider advised the mare had not appreciated today's heavy 11 track conditions.

**THISTLE DO** (J Fawcett) – Shifted in abruptly when struck with the whip near the 300 metres dictating and hampering OUR CHLOE inwards onto LA FEELYA which was inconvenienced, then continued to lay in bumping OUR CHLOE approaching the 100 metres.

**R Beemud** (GET UP) – Admitted a breach of Rule 638(2) in that he gave a victory salute prior to the finish and was fined the sum of \$200.

**S O'Malley** (OUR CHLOE) – S O'Malley admitted a breach of Rule 619(b) in that he was observed to have changed his riding boots after weighing out in an attempt to make the correct weight. S O'Malley was fined \$300.

### Race 6 STABLE BOOKS SUPPORTING NZ TRAINERS 1400 M

JAW GEE (R Elliot) – Began awkwardly settling back.

**TAV IT UP** (S Macnab) – Rider reported that the mare had hung throughout the race.

**OUR SHAMAN** (K Chowdhoory) – Raced keenly in the early stages. Lay out crossing the junction on to the course proper contacting and briefly unbalancing JAKAMA KRYSTAL. Lay out over the final stages having to be continually straightened, tightening JAKAMA KRYSTAL over the final 50 metres.

**JAKAMA KRYSTAL** (H Andrew) – Bumped and briefly unbalanced near the 1200 metres. Raced in restricted room over the final 50 metres.

Race 7 STABLE BOOKS 1400 M

**DEZELLE** (M Singh) – Was observed to have minor abrasion in the nasal area and underwent a pre race veterinary examination and was cleared to start.

**CONFESSIONAL (**S Johnson) – Began awkwardly contacting STRAIGHT SETS. Moved outwards under pressure in the final straight.

MERLOT (D Hirini) – Slow away. When questioned into performance rider could offer no excuse.

**COVER DRIVE** (S Macnab) – Raced keenly in the early to middle stages.

**STRAIGHT SETS** (R Elliot) – Shifted inwards near the 100 metres to avoid the heels of CONFESSIONAL (S Johnson) which shifted out under pressure. Rider S Johnson was reminded of her obligations to keep her mount straight.

Race 8STABLE BOOKS REMEMBERING HAROLD TUSON MDN 1400 MCARDELLI (D Danis) replaced S O'Malley – over weight.

**VAN WOLF** (H Andrew) – Awkwardly away settling back, then raced keenly in early to middle stages. Made the bend awkwardly near the 700 metres contacting DODGY KHAPERS.

**DODGY KHAPERS** (D Hirini) – Contacted near the 700 metres.

A Goindasamy (OUT OF THE PARK) – Was spoken to regarding his whip use prior to the 100 metres.
