GENERAL:

J Parkes was indisposed and did not attend the meeting and was replaced as above.

SUPPLEMENTARY:

Taranaki RI - Saturday 20th July 2019

Rider T Johnson was spoken to regarding his non-attendance at this meeting with Stewards initially having been told he was unwell. Whilst not taking the matter any further on this occasion, T Johnson was issued with a warning under Rule 330(3)(a) with breaking a riding engagement without reasonable cause and was advised that any repetition would result in charges being laid.

RACE COMMENTS:

Race 1	LJ HOOKER HURDLE (2750 Metres)
GUY FOX (K Veenendaal) - Slow away then was inclined to jump slowly at the rear in the early to middle stages.	

Inconvenienced jumping the last fence when BAY ROCKER ran down that fence and was taken out further by that runner approaching the 100 metres when BAY ROCKER continued to shift out under pressure before being straightened.

BAY ROCKER (S Phelan) - Was inclined to run down its fences throughout putting in a poor jump at the fence passing the 1200 metres.

MAX (J Seivwright) - Put in a poor jump at the final fence.

Race 2 MANAWATU ITM HURDLE (2750 Metres)

STARBRO (L Douglas) – Slow away. Jumped indifferently throughout. Went off stride near the 500 metres.

MR DAVINCI (M Cropp) – Put in a poor jump at the fence near the 900 metres then commenced to give ground, being retired from the race prior to the second last fence when well beaten.

TOODALOO (A Kuru) - Retired from the race prior to the second last fence when well beaten.

KIRKENES (E Farr) – When questioned into the disappointing run of KIRKENES, E Farr was of the opinion the gelding was unsuited to the testing track.

Race 3 CODY SINGER MEMORIAL STEEPLECHASE (4000 Metres)

INFOXICATED (J Seivwright) - Jumped the first fence awkwardly. Put in a poor jump at the fence near the 1400 metres.

POROTENE MAGNUM (B Lammas) – Blundered on landing after jumping the second fence then commencing to overrace. Retired from the race after the saddle shifted forward jumping the fence near the 150 metres on the second circuit.

LUCKY FRANK (L Douglas) - Badly misjudged the fence near the 1000 metres and was a beaten runner shortly after and was retired from the race prior to the second last fence.

Race 4 UNREAL GRASS & THE BNI HEARTLAND LEGENDS 2100 (2100 Metres)

MADAM ACE (S Rennie) – Delayed the start when reluctant to load with Trainer E Rennie being advised that MADAM ACE must now barrier trial satisfactorily before racing again. Ms Rennie was further advised that MADAM ACE would also be expected to be more competitive in any future start after being a beaten runner from near the 800 metres, dropping out to finish a distant last. Trainer E Rennie advised that MADAM ACE would no longer be considered a racing proposition from her stable.

DONARDO (S Fannin) -Slow away.

FORT STREET DANCER (L Phelan) – Jumped away awkwardly getting its head up, striking the rider L Phelan in the face, who required medical attention from ambulance personnel upon returning to the jockeys' room.

C Isdale (ROCKING GOOD TIME) – Advised to exercise greater care when shifting in near the winning post on first occasion when not clear of THE GREAT GURU and TELL ME MORE, which was steadied.

TELL ME MORE (F Lazet) – Bumped and forced inwards when THE GREAT GURU shifted in when not clear. L Myers was issued with a warning under Rule 638(1)(d). Steadied near the winning post on first occasion.

L Myers (THE GREAT GURU) – Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres and was suspended from the conclusion of racing today, 25 July, up to and including racing on Saturday,

14 August (2 riding days).

TABOO (J-L Lupton) - Inclined to shift out over the final stages.

Race 5 ABERDEEN ON BROADWAY 2100 (2100 Metres)

LUCQUIDE (M Singh) – Late scratched at 1.43pm due to transport difficulties.

GO VICTORIA (D Hirini) - Raced three wide without cover in the early stages.

DUNDEE STREET (T Johnson) - When questioned into the run of DUNDEE STREET, rider reported the gelding was unsuited to today's conditions, which he described as holding.

CAST IN BRONZE (R Hannam) - Galloped up on to the heels of VACATION near the 1400 metres and had to steady. Bumped with COUNTRY BUMPKIN when shifting out when in search of a run near the 700 metres.

COUNTRY BUMPKIN (M Hudson) - Bumped 700 metres.

Race 6 CAFÉ CUBA 2100 (2100 Metres)

REALLY HI PRINCESS (M Singh) - Began awkwardly making contact with PRINCESS JENNI, then being unbalanced when bumped by IN DREAMLAND.

PRINCESS JENNI (J Baillie) – Bumped start.

IN DREAMLAND (D Hirini) – Shifted outwards leaving the barriers making contact with REALLY HI PRINCESS, then being hampered by KION.

KION (M Hudson) - Held up for some distance behind the tiring THE FOT near the 800 metres. Apprentice M Hudson was shown footage of her ride in the presence of the Riding Master and advised that once clear of THE FOT in the Stewards opinion she should then have shown more urgency in her riding.

Race 7 DCPOWER 1200 (1200 Metres)

T Johnson (SALT 'N' PEPPER) - Fined \$200 under the Minor Infringement Schedule after failing to make the required weight, being 1kg overweight. Due to no suitable replacement rider being available T Johnson was permitted to retain the mount.

ST THERESA (M Singh) - Began awkwardly, losing ground.

THEWAYYOUMADEME (R Hannam) - Hampered start when OUR CHLOE jumped outwards.

WAR HERO (L Allpress) – Hampered start when contacted by BENSON.

MONKEY TOWN (H Andrew) - Lay out approaching the 1000 metres making contact with BEAUDZ WELL which was forced on to SILENT APPROACH.

BEAUDZ WELL (D Turner) - Contacted 1000 metres. Steadied when placed in restricted room passing the 800 metres.

SILENT APPROACH (S Collett) – Contacted 1000 metres.

Race 8 ROBERTSON PRESTIGE (1400 Metres)

D Turner (THAT'S FUNNY) – Admitted a breach of Rule 330(3)(c) in that he failed to make the required weight, being 1kg overweight and was fined \$450 by the Judicial Committee. D Turner was permitted to retain the mount due to

there being suitable replacement rider available.

CORNERSTONE (T Johnson) – Began awkwardly.

EM KAY POPS (B Ansell) – Slow away.

FACETIME (L Allpress) - Inclined to over-race in the run along the back straight.
