Race 1 RAYNER BUILDING 2YO 1200 (1200 Metres)

PLATINUM SPIRIT (J Parkes) – Trainer L Latta advised Stewards that she was satisfied with the recovery of the colt and it is her intention to continue on with its current preparation.

RACE COMMENTS:

Race 1 AJC.CO.NZ 1200

FLEURGUNDY (M Coleman) – Began awkwardly losing ground. Hampered near the 900 metres losing ground.

YOUKNOWHATIMEAN (M Kareem) – Slow to begin then crowded and steadied. Hampered near the 900 metres.

DUNDRUM (D Mansour) – Raced in restricted room near the 1000 metres to the inside of MANAVGAT (M Hashizume) which shifted in, and then was further crowded and hampered when MANAVGAT was taken in by RAZOR which was dictated in by HURRIAN (A Calder). Hampered as a result was FLEURGUNDY, JACINDERELLA and

YOUKNOWHATIMEAN. Apprentice Rider M Hashizume and Rider A Calder were both reprimanded and advised they must exercise greater care in a similar circumstance.

JACINDERELLA (C Burdan) – Hampered near the 900 metres.

LADY DE WINTER (T Thornton) – Held up entering the final straight until shifting in passing the 350 metres to obtain clear running.

Race 2 MULHOLLAND FOR A STRONGER VOICE (1400 metres)

THREE SIXTY (A Collett) – Began awkwardly losing ground. Inconvenienced near the 200 metres.

MEKELLE (C Grylls) – Checked approaching the 900 metres when crowded by DONTGIVEADAM which was forced inwards by SHOWCAT.

C Burdan (SHOWCAT) – Admitted a breach of careless riding in that she permitted her mount SHOWCAT to shift in near the 900 metres when not sufficiently clear of DONTGIVEADAM who was forced in onto MEKELLE which was checked. After considering submissions the Judicial Committee suspended her licence to ride in races from the conclusion of racing Saturday 13 July up to and including racing Wednesday 24 July, 5 national riding days.

HAERE UP (R Scott) – Raced in restricted room early in the final straight.

Race 3 AVONDALE SUNDAY MARKETS 1600

SWEET SURPRIZE (S Spratt) – Slow away

WE BE JAMMIN (A Collett) – Hampered leaving barrier.

PROGRESSIVE TRANCE (T Yanagida) – Crowded leaving the barrier, losing ground.

VAN BLANC (V Colgan) – Steadied when in restricted room near the 900 metres.

MILES BEYOND (A Jones) – Crowded near the 400 metres when weakening.

HUNUA HANK (M Cameron) – Approaching the 400 metres attempted to improve to the outside of CASSIO which simultaneously shifted out resulting in HUNUA HANK then racing in restricted room when making contact with MIANJO which lay in, and CASSIO which shifted out. Crowded and steadied approaching the 150 metres to the inside of MAINJO which shifted in under pressure.

A Calder (MAINJO) – Issued with a warning after permitting MAINJO to shift in when insufficiently clear of HUNUA HANK which was crowded then steadied.

Race 4 WEST BROOK WINES 1600

GENGHIS KHAN (L Satherley) – Began awkwardly then crowded.

WHOSHE'S GIRL (M Kareem) – Hampered when improving onto heels approaching the 400 metres and shifted out abruptly hampering ANGELICA. Apprentice rider M Kareem was reprimanded and advised to exercise greater care in a similar circumstance.

ANGELICA (C Grylls) - Hampered near the 400 metres.

ZEALAND (V Colgan) – Held up early in the final straight.

CHOUX A STAR (R Scott) - Held up entering the final straight.

DAY DREAMER (A Collett) – Underwent a post-race veterinary examination which revealed 1/5 lameness in the left hind leg. Trainer P Mirabelli advised that the filly would now be sent for a spell.

Race 5 ECHOES OF HEAVEN 2200

OUR CRAFTSMAN (A Calder) – Crowded soon after leaving the barriers and steadied.

MUELED (D Danis) – Hampered soon after leaving the barriers.

LADY AZAMOUR (M Coleman) – Contacted near the 500 metres and unbalanced by BABOONSKI which was taken out slightly by BLANCO BAY (R Smyth). R Smyth was advised to exercise care in similar circumstances.

Race 6 AUCKLAND ALARMS 1400

SPLENDIDO (M Hashizume) – Began awkwardly.

TIPICAL (C Budan) – Slow to begin. Had difficulty obtaining clear running in the final straight.

TOUCH OF SILVER (K Chowdhoory) – Slow to begin.

DELUXE EDITION (R Scott) – Slow to begin.

MOUNT MIDORIYAMA (S Spratt) – Crowded and hampered leaving the barriers.

THEE AULD CRUIZER (T Yanagida) – Crowded and hampered leaving the barriers. Steadied near the 900 metres when placed in restricted room.

Race 7 NEWMARKET STUD 1200

CRITICS CHOICE (C Dell) – Slow to begin.

IRISH MIST (E McCall) – Began awkwardly losing ground. Lay in under pressure in the final straight.

BRANSOME (J Kam) – Raced in restricted room shortly after the start having to be steadied.

CONCLUSION (C Burdan) – Raced ungenerously when being restrained in the early to middle stages.

RED TSUNAMI (V Colgan) – Inconvenienced for a distance passing the 200 metres when attempting to improve to the outside of SOLMIZATION which was dictated outwards slightly by FORTUNE PATCH. T Yanagida was advised to exercise care.

CONCLUSION (C Burdan) – Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 8 MIKE BROWN 60TH BIRTHDAY 1400

SPEED AND EXPEL (D Mansour) – Began awkwardly, losing ground.

SIR MAGGIO (E McCall) – Began awkwardly, losing ground.

EACH WAY (L Satherley) – Began awkwardly.

PIGGY MALONE (V Colgan) – Hampered near the 900 metres after improving onto heels.

MANRICO (T Thornton) – Underwent a post-race veterinary examination which found the gelding to have suffered cardiac arrhythmia. Connections were advised the appropriate veterinary clearance would be required prior to racing or trialing next.
