### RACE COMMENTS:

<b>Race 1</b>	<b>Dunstan Feeds Stayers Championship Qualifier 2100</b>
<b>AUGUST EDITION</b> (E McCall) - Crowded leaving the barriers. Raced in restricted room passing the 2000 metres being steadied.	
<b>SUNBURST</b> (C Lammas) - Shifted outwards under pressure over the final 100 metres.	
<b>BLUE BREEZE</b> (S Spratt) - When questioned regarding performance rider advised that the gelding may prefer looser track conditions, also adding that its top weight of 60 kilograms may have been a factor.	
<b>Race 2</b>	<b>SNG Media 1100</b>
<b>O'CHARM</b> (S Spratt) - Began awkwardly unbalancing its rider and losing ground then shortly after the start clipped a heel of STATELINE and blundered when STATELINE lay in away from CHIARETTA. Raced ungenerously in the early	

stages when racing keenly. When questioned regarding performance rider advised that the filly had felt indifferent in its action once placed under pressure in the final straight. A post-race veterinary examination found the filly to be 1/5 lame in the left hind receiving veterinary treatment with a veterinary certificate of fitness now required prior to racing again.

**BLACKROCKSDETOX** (V Colgan) - Slow to begin. Raced greenly when shifting out to obtain clear running entering the final straight passing the 400 metres running wide. Bumped near the 300 metres.

**BEAUTY DIVA** (A Calder) - Raced keenly through the middle stages when leading.

**THOUSANDKISSESDEEP** (M Coleman) - Held up approaching the 400 metres. Raced greenly shifting outwards abruptly making contact with BLACKROCKSDETOX near the 300 metres.

**CHIARETTA** (M Cameron) - Shifted ground under pressure in the final straight.

**BIT LIPPY** (D Danis) - Began awkwardly then further hampered when crowded. When questioned regarding performance rider advised that the gelding had not felt comfortable in today's track conditions.

**VIKTOR VEGAS** (M Cameron) - Crowded leaving the barriers.

**BACK IN A FLASH** (A Calder) - Crowded leaving the barriers.

**HOWBOWDAT** (J Riddell) - Slow to begin then raced in restricted room and steadied.

**O'ANGEL** (S Spratt) - Lay in across heels approaching the 1200 metres.

**RUBY LOVE** (L Innes) - Raced three wide without cover.

**SOROC** (T Yanagida) - When questioned regarding performance rider advised that the gelding had failed to handle today's holding track conditions.

<b>Race 4</b>	<b>Shaw's Wire Ropes Uncle Remus Stakes (1400 metres) Listed Race</b>

**IN A TWINKLING** (O Bosson) - Began awkwardly losing ground. When questioned regarding performance rider was unable to offer any excuse other than the gelding possibly not being entirely comfortable in today's track conditions. A post-race veterinary examination did not reveal any obvious abnormality.

**VERNANME** (M McNab) - Began awkwardly losing ground.

**MR UNIVERSE** (S McKay) - Began awkwardly losing ground. Clipped a heel and blundered near the 1100 metres losing ground.

**A Calder** - Admitted a charge of careless riding in that he permitted his mount TIGER SILK to shift inwards near the 1100 metres when not sufficiently clear of MR UNIVERSE which clipped a heel and blundered. After hearing submissions A Calder was suspended by the Judicial Committee from the conclusion of racing on Tuesday 1 January 2019 to the conclusion of racing on Saturday 12 January 2019, 8 national riding days.

**TIGER SILK** (A Calder) - Raced wide without cover.

**HYPNOS** (R Elliot) - Held up entering the final straight passing the 400 metres and did not obtain clear running until near the 250 metres.

<b>Race 5</b>	<b>Barfoot &amp; Thompson 1200</b>
<p><b>MONEY TRAIL</b> (M McNab) - Slow to begin.</p> <p><b>PRINCESS AMELIE</b> (J Parkes) - Began awkwardly. Raced in restricted room shortly after the start and was steadied. Raced wide without cover for the majority of the race.</p> <p><b>TOY KINGDOM</b> (V Colgan) - Raced ungenerously when being restrained in the early stages.</p> <p><b>PRETTY TO SEA</b> (L Innes) - Briefly held up entering the final straight.</p>	
<b>Race 6</b>	<b>Cambridge Stud Eight Carat Classic (1600 metres) Group 2</b>
<p><b>VAN IRVING</b> (M McNab) - Began awkwardly losing ground. Hampered having to be checked to avoid the heels of THE REAL BEEL near the 300 metres.</p> <p><b>MUSICAL BLUES</b> (T Yanagida) - Began awkwardly. Raced in restricted room near the 50 metres.</p> <p><b>THE REAL BEEL</b> (S Spratt) - Raced wide without cover. Ducked inwards abruptly near the 300 metres hampering VAN IRVING.</p> <p><b>MEDIA SENSATION</b> (M Coleman) - Eased down in the final straight when well beaten with the rider advising that the filly had travelled comfortably enough but had been quickly beaten when placed under pressure. A post-race veterinary inspection including an endoscopic examination did not reveal any obvious abnormality. Co-trainer D Williams indicated that consideration would be given to freshening the filly.</p> <p><b>PINMEDOWN</b> (J Bayliss) - Lost the left hind plate during the running.</p>	
<b>Race 7</b>	<b>Dunstan Feeds 1500 Championship Final</b>
<p><b>M McNab</b> - Fined the sum of \$200 under the Minor Infringement Schedule after failing to make the weight for MASTER PAINTON.</p> <p><b>MASTER PAINTON</b> (M Coleman) - Began awkwardly.</p> <p><b>SAVETTE</b> (S Rusof) - Began awkwardly then crowded losing ground.</p> <p><b>MAKTOUM</b> (S Spratt) - Began awkwardly.</p> <p><b>MONRECOUR</b> (R Elliot) - Raced wide without cover throughout. When weakening had to be steadied near the 100 metres when placed in restricted room.</p> <p><b>LINCOLN RAIDER</b> (O Bosson) - When weakening had to be steadied near the 100 metres when placed in restricted room. When questioned regarding performance rider was unable to offer any excuses with a post-race veterinary inspection did not reveal any obvious abnormality.</p> <p><b>D Danis</b> (MORRIE OCK) - Advised to exercise greater care after permitting his mount to shift out under pressure approaching the 100 metres dictating WALKIN' BY out onto MONRECOUR and LINCOLN RAIDER.</p> <p><b>O'HE CAN</b> (M Cameron) - When questioned regarding performance rider advised that the gelding had failed to quicken in today's track conditions after travelling well through the running. A post-race veterinary inspection did not reveal any obvious abnormality.</p>	

<b>Race 8</b>	<b>Hallmark Stud Handicap (1200 metres)</b>
<p><b>SHE'S A THIEF</b> (M Coleman) - Began awkwardly making heavy contact with BELLA GIOIA losing ground. When questioned regarding performance rider advised that the filly had failed to handle today's track conditions. A post-race veterinary inspection did not reveal any obvious abnormality.</p> <p><b>BELLA GIOIA</b> (S Collett) - Began awkwardly making heavy contact with SHE'S A THIEF losing ground.</p> <p><b>SHORT FUSE</b> (C Lammas) - Crowded approaching the 1100 metres to the outside of POWER DREAM which was dictated outwards by SANTA MONICA which had been forced out by ROCANTO which had shifted out despite the efforts of its rider.</p>	
<b>Race 9</b>	<b>Cambridge Stud Zabeel Classic (2000 metres) Group 1</b>
<p><b>DANZDANZDANCE</b> (O Bosson) - Restrained to the rear when leaving the barriers.</p> <p><b>JON SNOW</b> (L Innes) - Raced in restricted room passing the 450 metres.</p> <p><b>R Hannam</b> (AUTHENTIC PADDY) - Issued with a warning for his whip use prior to the 100 metres.</p> <p><b>NICOLETTA</b> (J Waddell) - When questioned regarding the performance the rider was unable to offer any excuse other than the mare racing a little too keenly early. A post-race veterinary inspection did not reveal any obvious abnormality.</p>	
<b>Race 10</b>	<b>Otakiri Reserve 1600</b>
<p><b>N Hanley &amp; K Whiting</b> (EL COOLIO) - Charged under the provisions of Rule 534(1) with failing to scratch EL COOLIO by the required time with the hearing being adjourned until a date to be set due to neither of the training partnership being in attendance at today's meeting.</p> <p><b>MY DAKOTA</b> (S Collett) - Began awkwardly making contact and losing ground.</p> <p><b>POPPY STAR</b> (M Coleman) - Crowded when leaving the barriers. Steadied approaching the 200 metres when improving onto the heels of EFFERVESCENT.</p> <p><b>TRIPLE DIAMOND</b> (M Cameron) - Eased down from near the 200 metres with the Rider reporting the mare had felt indifferent in its action. A post-race veterinary examination did not reveal any obvious abnormality.</p> <p><b>SWISS ELLE</b> (D Danis) - Lost the right front plate during the running.</p>
