RACE COMMENTS:

Race 1 McCALLUMS GROUP STAYERS HANDICAP (2130m)

LEILA EVE (K Selvan) – Very slow to begin. Raced keenly in the early stages with the saddle slipping well forward resulting in the mare improving very quickly to the lead and placing the rider in difficulty for the remainder of the event. Pulled up near the 100 metres.

CAIRNSVILLE (A Bohorun) – Over-raced in the early stages.

MAC MURDOCH (J Lowry) – Raced keenly and got its head up near the 1700 metres. Steadied momentarily passing the 450 metres when CAIRNSVILLE (A Bohorun) shifted in when only marginally clear. A Bohorun was advised to exercise greater

care.

Race 2 CENTRAL SOUTHLAND FREIGHT HANDICAP (2130m)

MR INTELLIGENCE (L Callaway) – Began awkwardly losing some ground.

QUEEN EL JAY (J Morris) – Restrained to the rear on jumping. Got its head up when racing keenly in the early stages. Improved wide from the 800 metres.

THE FLAGON (K Mudhoo) – Raced keenly in the early stages and had to be restrained off heels for a distance passing the 1400 metres when ZEDAAM (K Selvan) shifted inwards. Continued to over-race and again had to be restrained off heels passing the 800 metres. Held up passing the 400 metres. Held up again rounding the final bend and early in the run home.

K Selvan was issued with a warning under Rule 638(1)(d) in that he allowed his mount to shift inwards when only marginally clear of THE FLAGON who had to be restrained off heels passing the 1400 metres.

ROCK MASTER (B Murray) – Raced wide for the majority of the event. Crowded and had to be steadied passing the 500 metres when QUEEN EL JAY (J Morris) who was improving forward, was laying in at this point. Also contributing to this incident was outwards movement from POWER PUNCH who lay out at this point, dictating BEAM ME UP SCOTTY outwards on to ROCK MASTER. J Morris was advised to exercise greater care.

LUUKA (C Johnson) – Returned to the birdcage with blood present in its mouth after biting its tongue during the running. Rider reminded of his obligations to ride his mount out fully to the line when circumstances permit.

Race 3 McKNIGHT & BROWN MAIDEN (1600m)

MAH GIRL (K Mudhoo) – Got its head up when being restrained to take a trailing position racing into the bend near the 1400 metres.

OUR BOY BAZ (G Saejorhor) – Had to be steadied when improving on to the heels of the runner in front near the 800 metres. Held up for the majority of the run home and raced in restricted room passing the 75 metres.

Race 4 ILT FOUNDATION HANDICAP (1600m)

KAURI COVE (T Moseley) – Restrained shortly after the start to take cover. Lay in momentarily passing the 800 metres. Bumped with THE STYLE and unbalanced near the 75 metres when taken outwards by TICKETS ON HER who lay out at this point.

THE QUIET MAN (A Bohorun) – Slow through the early stages. Crowded and had to be restrained passing the 800 metres when KAURI COVE lay in momentarily. Held up rounding the final bend and had to be angled across heels near the 200 metres to find clear racing room.

THE STYLE (B Murray) – Slow through the early stages. Bumped and unbalanced near the 75 metres.

TICKETS ON HER (C Johnson) – Over-raced through the early to middle stages. Lay out near the 75 metres. Crowded in the shadows of the post by THE BUMPER (T Jonker) who lay out at this point. T Jonker was advised to exercise greater care.

KILOWATT (G Saejorhor) – Lay out over the concluding stages shifting wider on the track.

Race 5 PHILLIPS HORSE TRANSPORT (1200m)

STELLACANTO (K Selvan) – Bounded as the start was effected and lost ground.

HE'S MI BROTHER (A Bohorun) – Lay inwards and shifted in abruptly when struck with the whip having to be straightened passing the 125 metres. When questioned regarding the seemingly improved performance trainer S Blair-Edie advised that the gelding had been trapped wide throughout at it previous start which was on a Premiere day and was better suited by an economical trip in a smaller field today.

NON BLONDE (B Murray) – Lay inwards across heels passing the 50 metres and had to be straightened.

Race 6 DON'T MISS THE CAR DISPLAY ON CUP 16 FEB (1200m)

ROSIE GLOW (G Saejorhor) – Slow to begin.

LORD ZACFORD (J Lowry) – Slow to begin. Angled wider on the track at the 200 metres to find clear racing room.

PESHAWAR (D Prastiyou) – Began awkwardly. Over-raced through the middle stages. Crowded and checked, having to be heavily restrained passing the 900 metres.

Apprentice rider B Murray with the assistance of D Walsh admitted a breach of the Careless Riding Rule when he permitted his mount to shift inwards passing the 900 metres when insufficiently clear of PESHAWAR resulting in that runner being crowded and checked. After viewing replays and hearing submissions on penalty the JCA imposed a suspension of Mr Murray's riding licence from the conclusion of racing on the 10th of February up to and including the 21st February (7 days)

TIMES TIME (B Murray) – Lay inwards passing the 300 metres.

HURRICANE AUBERT (T Moseley) – Crowded when tiring passing the 300 metres when TAP TAP shifted outwards at this point and TIMES TIME lay inwards.

Race 7 NZB INSURANCE PEARL SERIES RACE (1400m)

REMARKABLE KATE (S Toolooa) – Bounded at the start and lost ground.

HIGHLY ROYAL (K Mudhoo) – Slow to begin. Made the bend awkwardly by the 900 metres. Returned to the birdcage with blood present in one nostril. A post-race veterinary examination revealed a cut to the inside of the nose and therefore was not a bleeder.

THE SELECTION (B Murray) – Crowded between runners shortly after the start and lost ground. Gave ground from the 500 metres and was not persevered with thereafter. A post-race veterinary examination revealed filly to be suffering shin soreness. Trainer R Dennis advised THE SELECTION would now be sent for a lengthy spell.

EAGER BEAVER (G Saejorhor) – Raced wide throughout.

CITY SLICKER (T Moseley) – Forced to race wider on the track passing the 600 metres when contacted by HAKA STAR (J Lowry) which shifted out at this point. J Lowry was advised to exercise greater care.

Race 8 SEE YOU AT GOLD CUP DAY FEBRUARY 16 (1400m)

ABBEY KAY (S Toolooa) – Slow to begin. Shifted in under pressure passing the 100 metres making firm contact with KARM 'N' EASY.

KNUTQUACKER (D Prastiyou) – Began awkwardly, making firm contact with an inside runner and losing ground.

MORRELLMAC (T Moseley) – Obliged to improved wide from the 600 metres.

KARM 'N' EASY (G Saejorhor) - Bumped passing the 100 metres.
