DRATINI (J Parkes) – Trainer F Auret advised that the colt would be sent for a spell, adding that connections were giving consideration to gelding DRATINI prior to racing next.

RACE COMMENTS:

 Race 1
 BRUCE SCOTT MEMORIAL 2200

 MONARCH CHIMES (M McNab) - Began awkwardly then raced in restricted room and was steadied. Lay in under pressure in the final straight making contact with the hindquarters of DESERT STORM near the 100 metres.

DESERT STORM (S Collett) - Slow to begin. Raced keenly when being restrained in the early to middle stages. Hindquarters contacted near the 100 metres.

MASTER PAINTON (O Bosson) - When questioned regarding performance rider advised that the gelding had been disappointing and in his opinion had failed to see out the 2200 metre distance of today's race.

Race 2 BRIAN HENSHILWOOD MEMORIAL 1215

AZAMOUR QUEEN (L Satherley) - Reluctant to load then becoming fractious having to be removed from the barriers to undergo a veterinary examination being passed fit to start. Trainer J Price was advised that a warning would be placed against the mare for its barrier manners. Began awkwardly. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

UNCLE ERN (S McKay) - Slow to begin then hampered.

ANHEDONIA (D Mansour) - A little slow to begin.

SHEBRINGSMERUBIES (O Bosson) - Hampered leaving the barriers.

CALL ME EVIE (A Goindasamy) - Raced ungenerously when being steadied in the early stages making the bend approaching the 800 metres awkwardly.

WILSON (D Danis) - Raced wide without cover.

HENRY HUDSON (C Lammas) - Inconvenienced near the 100 metres when ANHEDONIA (D Mansour) shifted outwards. D Mansour was advised to exercise greater care.

Race 3 COME ALONG 11TH MAY CUP DAY 3YO

UP 'N' GONE - Declared a late scratching on veterinary advice at 12.48pm requiring veterinary treatment for an allergic reaction.

J Bayliss (VANILLA CHINCHILLA) - Fined \$100 under the Minor Infringement Schedule after failing to make the weight for VANILLA CHINCHILLA. S Spratt replaced J Bayliss.

PRESTIGIOUS LAD (A Goindasamy) - Began awkwardly.

VANILLA CHINCHILLA (S Spratt) - Began awkwardly losing ground.

GLORIOUS OCEAN (T Yanagida) - Began awkwardly. Raced wide without cover.

SOCIALIGHTS (M McNab) - Had some difficulty obtaining clear running until shifting outwards passing the 100 metres.

Race 4 NZB INSURANCE PEARL SERIES RACE

AFTER FIVE (J Kam) - Trainer K Harrison reported that the mare had suffered superficial lacerations to a hip en route to the races. After undergoing a pre-race veterinary examination was passed fit to start.

CRESCENT (R Elliot) - Began awkwardly.

HETTY (M McNab) - Raced ungenerously when being steadied shortly after jumping away, then having to be further restrained when placed in restricted room going into the first turn near the 1200 metres. When questioned regarding performance rider advised that the filly had felt indifferent in its action. A post-race veterinary inspection did not reveal any obvious abnormality.

O Bosson (ENGLISH ROSE) - Issued with a warning after permitting his mount to shift inwards near the 1000 metres when not fully clear placing ONE WAY STREET in restricted room.

ONE WAY STREET (S Collett) - Over-raced when restrained approaching the 1000 metres then having to be further steadied shortly after when placed in restricted room to the inside of ENGLISH ROSE.

OUR STAR (S Spratt) - Had to be steadied for a distance rounding the final turn near the 300 metres and early in the straight to avoid the heels of AFTER FIVE (J Kam). J Kam was advised to exercise greater care.

Race 5 ISCL 1560

SODA (S Collett) - After being fractious in the barriers jumped away very awkwardly making contact with NONCHALANT losing several lengths. Hampered 1100 metres.

RUMOUR HAS IT (S Spratt) - Began awkwardly.

NONCHALANT (J Bayliss) - Contacted by SODA leaving the barriers then commencing to buck losing considerable ground and effectively its chance in the race. Trainer S Logan was advised that NONCHALANT would be required to barrier trial to the satisfaction of a Stipendiary Steward prior to racing again. Required veterinary treatment for an injury to the pastern on the left foreleg with a veterinary clearance also required.

ALADINA (R Elliot) - Improved onto the heels of VISCONTI which was being steadied approaching the 1100 metres having to be firmly restrained going back onto SODA which was hampered.

Race 6 RYDGES HOTEL ROTORUA 1560

ELEANOR RIGBY (O Bosson) - Slow to begin. When questioned regarding performance rider advised that the filly had never travelled overly comfortably in a race run at a strong tempo, and was also of the opinion it may not have been suited backing up from racing the previous Wednesday. A post-race veterinary inspection revealed abrasions to the left hind requiring veterinary treatment.

LA ACHIEVER (R Elliot) - Began awkwardly. Inclined to lay in under pressure in the final straight having to be steadied away from the heels of CRAFTYEVA just short of the finish.

SHADOWS (S Spratt) - Raced keenly in the middle stages.

FULL OF TALENT (A Goindasamy) - Raced wide without cover.

A Goindasamy (FULL OF TALENT) - Issued with a warning for his whip use on a runner out of contention.

Race 7 WAITOMO FUELS 1400

OCEAN BILLY (T Yanagida) - Began awkwardly.

COME DANCE WITH ME (S Collett) - Began awkwardly. Inconvenienced near the 500 metres by MAN OH MAN which shifted out to obtain clear running.

MAN OH MAN (O Bosson) - Had to steady away from heels when awkwardly placed passing the 900 metres.

CHOULEE (S Spratt) - Held up for a distance approaching the 400 metres.

O Bosson (MAN OH MAN) - Fined \$300 after admitting a charge in that he used his whip excessively prior to the 100 metres.

MIGHTY COLOMBO (D Mansour) - When questioned regarding the improved performance trainer C Mortimer advised that the gelding had been a slow maturing type which had also had injury issues earlier in its career, adding that it had not had much luck in recent runs being caught wide, but had been working and eating well and she had been very happy with its overall condition leading into today's race.
