<b>Race 1</b>	<b>PENINSULA BEACHFRONT RESORT MOOLOOLABA MDN HWT 2000</b>
<b>CURIOUS GEORGE</b> (S Fannin) – Began awkwardly.	
<b>KYZ KUUMAI</b> (M Cropp) – Slow away.	
<b>MEANT TO BE</b> (S Karnicnik) – Clipped heels near the 450 metres.	
<b>PADDINGTON</b> (S Phelan) – Lay in under pressure in the home straight.	
<b>JOSEY WALES</b> (K Veenendaal) – Checked near the 450 metres when MEANT TO BE improved rapidly on to the heels of	

PADDINGTON which was racing greenly and shifted out becoming awkwardly placed and clipping that runner's heels. This resulted in MEANT TO BE when being corrected shifting inwards on to JOSEY WALES which was improving to that runner's inside. Held up for a short distance passing the 200 metres.

<b>Race 2</b>	<b>RETURN 2 EARTH HWT 1800</b>

**NOBLE STAR** (S Fannin) – Jumped outwards at the start tightening ENSUITE and settled back. Held up rounding the home turn.

**MOFARA** (S Phelan) – Slow away then raced ungenerously in the early stages making the bend near the 1600 metres awkwardly. Returned to the enclosure with blood present in both nostrils. A subsequent veterinary inspection revealed the gelding to have bled and is now subject to a two month stand down from track work and three months from racing and must undergo the required protocols prior to racing next.

**EN SUITE** (S O'Malley) - When questioned into performance rider could offer no excuse.

**AFFLUENT** (D Hirini) – Raced three wide without cover throughout.

**MAL DEE** (L Hemi) – Lay inwards early in the home straight and had to be straightened.

**ENDURING LOVE** (C Grylls) – Raced keenly for a distance from the 800 metres then held up from the 600 metres gaining clear running entering the home straight.

**TORCHED** (H Andrew) – Reared as the start was affected and was slow away.

**MR ENTHUSIASTIC** (S Collett) – Restrained back from a wide draw.

**J Baillie** (EIGHT MILE) – Was spoken to with regard to his whip use prior to the 100 metres.

**ARAPAHO PRINCE** (S McKay) – When questioned into performance rider could offer no excuse other than the gelding may appreciate some easing in the track conditions. A subsequent veterinary inspection was clear.

**COVER DRIVE** (S McNab) – Raced keenly in the early to middle stages.

**TORQUE TIME** (S Collett) – Jumped the crossing near the 1500 metres inconveniencing COVER DRIVE.

**KIRKENES** – Awkwardly away settling back. Raced ungenerously for a distance in the back straight. Raced in restricted room near the 200 metres.

**MALO BIK** (S O'Malley) – Began awkwardly making contact with TORRE DEL GRECO with both runners losing ground. Raced keenly in the early to middle stages. When being restrained near the 1100 metres shifted inwards tightening TORRE DEL GRECO. Held up rounding the turn and in the home straight having to be restrained near the 200 metres before gaining clear running inside the final 100 metres.

**VIVA LILLI** (C O'Beirne) – Raced keenly approaching the 900 metres having to be angled off heels to race three wide without cover for the remainder.

**TORRE DEL GRECO** – Briefly held up near the 250 metres. Tightened near the 100 metres.

**HOVER** (J Parkes) – Lay in under pressure in the home straight. Rider had no excuse.

<b>Race 7</b>	<b>CHANCE TO WIN A FORD FOCUS SAT MAY 11<sup>TH</sup> MDN</b>
<p><b>WICKLOW</b> (Z Moki) – Underwent a pre-race veterinary inspection and was cleared to start after becoming fractious in the gates.</p> <p><b>SON OF ANNA KAY</b> (L Hemi) – Began awkwardly then raced keenly in the early stages having to be angled wide on the track approaching the 1100 metres, then improved wide to sit three wide on the pace for the remainder.</p> <p><b>MONKEY SHOULDER</b> (J Parkes) – Briefly tightened near the 800 metres when JUNIPER JEWEL made the bend awkwardly shifting out.</p> <p><b>JUNIPER JEWEL</b> (D Hirini) – Finished some distance last. Rider had no excuse. A subsequently veterinary inspection revealed a slow recovery rate.</p> <p><b>J Baillie</b> (BLACK ANASTA) – Issued with a warning under Rule 638(3)(b)(ii) with regard to the use of his whip prior to 100 metres.</p>
