Race 4 PYRAMID TRUCKING 1400

DAWN PATROL (M McNab) – Trainer F Ritchie advised Stewards that in the days following this race the gelding underwent a veterinary examination which reveal a minor bacterial infection which he has now received treatment for, adding it is his intention to continue on with its current preparation.

RACE COMMENTS:

Race 1 WAITOMO FUELS HWT

WINKLEBELLE (S Fannin) – Was declared a late scratching at 11:16 am on veterinary advice after injuring itself en route to the course.

INIGO MONTOYA (S Phelan) – Slow away.

MEANT TO BE (S Karnicnik) – Began awkwardly losing ground. Had to be firmly restrained after improving on to heels near the 1300 metres.

DANGERMAN (R Elliot) – Began awkwardly shifting out making contact with SHOCKOOL forcing that runner out on to JUNE ROSE which was hampered losing ground.

SHOCKOOL (A Kuru) – Contacted soon after start becoming briefly unbalanced.

JUNE ROSE (B Lammas) – Hampered shortly after start losing ground.

SEEMAX (M Gillies) – Raced wide without cover for the majority of the race.

Race 2 HIRE YOUR FUNCTION LOUNGES ARAWA PARK HWT

ARGYLL (S Fannin) – Began awkwardly shifting out hampering BRAWLER which clipped a heel and blundered.

BRAWLER (G Walsh) – Clipped a heel shortly after the start and blundered.

KOMRAD (D Turner) – Shifted out abruptly on jumping away badly hampering LINCOLN KING which was steadied losing ground.

LINCOLN KING (J Riddell) – Badly hampered shortly after the start having to be steadied and losing ground.

CASHEL (M Gillies) – Slow away.

NOTHINBRAXLYKAHART (B Lammas) – Slow away. Held up until near the 200 metres having to shift ground outwards to improve.

HATTIE BEE (E Farr) – Raced three wide without cover for the majority of the race.

MARBUZET (R Elliot) – When questioned regarding performance rider R Elliot advised that the gelding had struggled to stay the distance today whilst carrying 68 kgs along with a slow track. Co-trainer G Rogerson advised the gelding would now be spelled.

Race 3 PHELAN RACING STABLES HWT

HENRY TUDOR (E Farr) – Began awkwardly shifting out forcing RICH HABIT outwards crowding PERRY MASON and ROBUSTO with both those runners losing ground.

PERRY MASON (A Kuru) – Crowded shortly after the start losing ground.

ROBUSTO (J Riddell) – Crowded shortly after the start losing ground.

T Moki (MARKWOOD) – Issued with a warning for failing to claim her full allowance.

Race 4 COME TO ROTORUA CUP 11TH MAY HWT

GO GO GONZO (G Walsh) – Slow away.

LETMEBY (S Phelan) – Crowded and steadied shortly after jumping away losing ground.

GALLANTE (M Roustoby) – Raced keenly in the middle stages.

Race 5 NZB INSURANCE PEARL SERIES RACE

MISTER PRESIDENT (S McKay) – Badly hampered on jumping away losing ground.

MIRADELLO (L Innes) – Began awkwardly and then was further crowded losing ground. When questioned regarding performance rider L Innes advised the filly had failed to handle the existing track conditions.

WASP (J Bayliss) – Steadied when placed in restricted room passing the 750 metres, then commenced to hang outwards rounding the final bend placing the rider at a disadvantage. A warning was placed on the filly's racing manners. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 6 BDO ROTORUA 3YO

HETTY (S Collett) – Began awkwardly shifting out crowding UNCLE ERN which had to steady losing ground. Raced ungenerously in the early stages. When questioned regarding performance rider S Collett advised that the filly may be better suited to right hand racing with trainer S Marsh advising he will experiment with the addition of blinkers.

UNCLE ERN (S McKay) – Crowded shortly after the start having to be steadied. Held up when attempting to improve into a marginal run for a distance passing the 250 metres.

FIVE PRINCES (T Harris) – Began awkwardly shifting in crowding BABY FACE which had to steady losing ground.

BABY FACE (S Spratt) - Crowded shortly after the start having to be steadied.

WHIMSY (L Satherley) – Raced keenly in the early and middle stages. Steadied after being crowded to the outside of RELIABLE BELLE (C Lammas) which lay out when not fully clear passing the 500 metres. C Lammas was advised to exercise care.

SOCIALIGHTS (C Grylls) – Steadied when placed in restricted room approaching the 400 metres when runners on either side shifted ground slightly.

ROSA FIORE (T Thornton) – Had difficulty obtaining clear running early in the final straight and again near the 100 metres.

Race 7 FAULKNER DRAINAGE 1230

THE REVENANT (R Elliot) – Slow away.

ITS ALL FAKE NEWS (D Danis) – Slow away. When questioned regarding performance apprentice D Danis advised that in his opinion the gelding was unsuited by today's track conditions.

ANGELICA (C Lammas) – Briefly held up rounding the final bend.

Race 8 NZB INSURANCE PEARL SERIES RACE

CALL ME EVIE (J Bayliss) – Was late scratched at 3:43 pm after escaping riderless from the barriers. The connections were advised that the filly would be required to barrier trial to the satisfaction of Stewards prior to racing next. The connections advised that the filly would now be sent for a spell.

MISS BUMBLEBEE (C Lammas) – Underwent a veterinary examination at the start and was declared a late scratching at 3:46 pm after being fractious in the barrier.

LLANBERIS (S Collett) – Slow away.

CHEERS (A Goindasamy) – Began awkwardly shifting in making contact with INTO THE GROOVE which was crowded losing ground. Steadied when placed in restricted room passing the 400 metres.

INTO THE GROOVE (J Riddell) – Crowded start losing ground.

Race 9 RYDGES HOTEL ROTORUA 1400

MARKLE (L Innes) – Slow away. Steadied when placed in restricted room near the 250 metres to the outside of BEACHED AS BRO which was bumped and forced outwards by WITCHERY.

WITCHERY (O Bosson) – Began awkwardly losing ground.

BEACHED AS BRO (S Collett) – Began awkwardly losing ground. Bumped and forced wider 250 metres.

SHADOWS (S Spratt) – Held up entering the final straight after improving on to heels before shifting in near the 250 metres to obtain clear running.

LADY BLUE (M Cameron) – Co-trainer A Forsman reported that LADY BLUE returned to the enclosure with blood present in a nostril. Underwent a post-race veterinary examination, including an endoscopic examination, which revealed a minor laceration inside the left nostril.

O Bosson (WITCHERY) – Issued with a warning for allowing his mount to shift out passing the 200 metres forcing BEACHED AS BRO out into the line of MARKLE which had to be steadied when placed in restricted room.

MY DAKOTA (C Grylls) – When questioned regarding performance rider could offer no excuse. Underwent a postrace veterinary examination which revealed a slightly elevated heart rate.

Race 10 COME BACK FOR EASTER MONDAY 1400

LUDUS (S Collett) – Slow away. Commenced to over-race for a distance passing the 1200 metres when being steadied. Hampered passing the 250 metres. Held up over the final 100 metres.

OCEAN BILLY (C Burdan) – Slow away.

VERA DRAKE (L Innes) - Raced ungenerously in the early and middle stages.

O'BECKY (J Bayliss) – Steadied when placed in restricted room near the 250 metres when LOVE ME TENDER was dictated outwards by BIRDIE MAY (R Elliot) which shifted out when not sufficiently clear. Also hampered as a result was LUDUS.

R Elliot (BIRDIE MAY) – Issued with a warning for allowing his mount to shift out dictating LOVE ME TENDER out placing O'BECKY in restricted room which had to be steadied near the 250 metres.

VALHEXA (J Fawcett) – Had difficulty obtaining clear running for the majority of the final straight.
