Race 5 - NZB Finance Sprint (1200 metres)

VOLKS LIGHTNING (R Elliot) – Co-trainer G Rogerson advised that following the race VOLKS LIGHTNING had appeared to have swallowed a clod or clods of dirt during the running which had affected its performance.

Race 8 - #Gowinx Mile (1600 metres)

T Thornton (THE COSSACK) - Defended a breach in that she used the whip excessively when riding THE COSSACK. After hearing submissions the Judicial Committee found the charge proven, suspending T Thornton's licence to ride in races from the conclusion of racing on Saturday 20 April, up to and including racing on Thursday 2 May, 7 National riding days.

<p>SUPER BULLETT (S Spratt) – Slow away.</p> <p>SPEEDY GEE (R Norvall) - Slow to begin.</p> <p>SPIRITED (S McKay) - Began awkwardly losing ground.</p> <p>KRAKADEEL (J Riddell) – Held up early in the final straight and then shifted out passing the 350 metres making contact with TAKE A GAMBLE which became briefly unbalanced.</p> <p>TAKE A GAMBLE (T Thornton) - Bumped near the 350 metres becoming briefly unbalanced.</p> <p>J Riddell (KRAKADEEL) – Issued with a warning for angling his mount outwards passing the 350 metres making contact with TAKE A GAMBLE which became unbalanced.</p>	
Race 2	WEBSITE ANGELS 2200
<p>JUSTAMAIZ (S Spratt) - Lost a hind plate when making its way to the barrier which was unable to be re-fitted with Stewards granting permissions for JUSTAMAIZ to race partially shod.</p> <p>D Danis (CHA SIU BOA) - Issued with a warning for using his whip excessively.</p>

<p>SYLWEK (C Dell) – Began awkwardly shifting in making contact.</p> <p>ARITE GURU (R Jones) - Crowded and steadied leaving the barrier.</p> <p>GEORGETHEFIFTH (A Calder) – Raced wide without cover for the majority of the race.</p> <p>SO YOU SPARKLE (S McKay) – Held up passing the 200 metres when racing in restricted room to the outside of SYLWEK which shifted out under pressure.</p> <p>C Dell (SYLWEK) - Issued with a warning after permitting SYLWEK to shift out under pressure passing the 200 metres placing SO YOU SPARKLE in restricted from for a distance.</p>

<p>DAMA ZORRO (S Spratt) – Began awkwardly losing ground.</p> <p>CHICANE (A Goindasamy) - Made brief contact with AMARULA when placed under pressure near the 300 metres.</p> <p>KINGSGUARD (C Burdan) – When questioned regarding the performance apprentice rider C Burdan reported that the gelding had hung throughout. A post-race veterinary examination could find no obvious abnormalities.</p> <p>S Spratt (DAMA ZORRO) - Reminded of her obligations after shaking hands prior to weighing in.</p>	
Race 5	BOOK AN EVENT @TE RAPA & WIN 1600
<p>HESALLJAZZ (J Fawcett) – Began awkwardly losing ground. Raced without cover for the majority of the race.</p> <p>FRANCIS DRAKE (T Thornton) – Slow away.</p> <p>CUTTING UP ROUGH (A Goindasamy) – Over-raced in the middle stages. Lay in when placed under pressure from near the 300 metres having to be corrected by its rider on several occasions.</p> <p>S Spratt (LUCKY SWEEP) - Issued with a warning for using her whip excessively.</p> <p>D Danis (FARM BOY) – Issued with a warning for using his whip excessively.</p> <p>T Newman (JOCHEN RINDT) - Issued with a warning for using her whip on a horse that was out of contention.</p>	
Race 6	LODGE REAL ESTATE 1200
<p>BOLT FROM THE BLUE (V Colgan) – Began awkwardly making contact and becoming unbalanced.</p> <p>SIMOGRAMOR (S Johnson) – Began awkwardly making contact and becoming unbalanced. Raced wide without cover for the majority of the race.</p> <p>RIP EM UP (S Spratt) - Steadied from a wide barrier.</p> <p>LOOKS LIKE (J Fawcett) - Crowded leaving the barriers. Inconvenienced 400 metres when forced wide by RIP EM UP (S Spratt) which shifted out to obtain clear running. S Spratt was reprimanded by Stewards and advised to exercise greater care in a similar circumstance.</p> <p>M Hashizume (CENGHAR) – Admitted a charge in that he used his whip excessively when riding with the Judicial Committee imposing a fine of \$300.00.</p>	

SHEEZALLMINE (T Newman) – Shifted out under pressure from near the 250 metres impeding **QIJI EXPRESS** which was crowded and checked near the 150 metres.

QIJI EXPRESS (M Cameron) - Impeded when dictated wider on the track from near the 250 metres then crowded and checked near the 150 metres losing ground.

T Newman (SHEEZALLMINE) - Admitted a breach of careless riding in that she allowed SHEEZALLMINE to shift out under pressure from near the 250 metres impeding **QIJI EXPRESS** which was checked near the 150 metres with the Judicial Committee suspending her licence to ride in races from the conclusion of racing on Wednesday 17 April, up to and including racing on 1 May, 8 national riding days.

Following the race, the connections of the 2nd placed horse **QIJI EXPRESS** lodged a protest against the 1st placed horse **SHEEZALLMINE** alleging interference in the final straight. After considering submissions the Judicial Committee dismissed the protest.

BELLE FASCINO (S Collett) – Restrained from a wide barrier.

O’GUY (S Spratt) – Began awkwardly losing ground. Raced wide without cover for the majority of the race. Inconvenienced 100 metres by **STAR TREASURE** which shifted out slightly under pressure.

MARK TWO (M Cameron) - Began awkwardly then crowded.

STAR TREASURE (C Grylls) – Over-raced in the middle stages.

SHORT FUSE (T Thornton) - Shifted inwards approaching the 300 metres to obtain clear running.

A Goindasamy (MERLINI) - issued with a warning for using his whip excessively.
