<b>Race 1</b>	<b>LEVIN WOOL BUYERS/WOODVILLE SERVICE CENTRE 2200 (2200 Metres)</b>
<p><b>TELL ME MORE</b> (E Farr) – Slow away. Raced three wide without cover.</p> <p><b>CALL ME JACK</b> (T Johnson) - Jumped away awkwardly tightening MR ENTHUSIASTIC.</p> <p><b>MR ENTHUSIASTIC</b> (S Karnicnik) – Tightened at start.</p> <p><b>MASTER COURTSMAN</b> (B Lammas) - Held up rounding the home turn before shifting inwards to obtain clear running near the 300 metres.</p> <p><b>E Farr</b> (TELL ME MORE) - Spoken to regarding her whip use prior to the 100 metres.</p> <p><b>K Veenendaal</b> (WHO CAN TELL) - Spoken to regarding her whip use prior to the 100 metres.</p>	
<b>Race 2</b>	<b>MOTORCYCLE HQ/BEALE TRUCKING 2200 (2200 Metres)</b>
<p><b>IT'S A WONDER</b> (S Phelan) -Jumped away awkwardly.</p> <p><b>ZARTAN</b> (E Farr) – Raced three wide without cover until improving forward to lead near the 900 metres.</p> <p><b>YIPSON</b> (K Veenendaal) - Raced wide throughout. Crowded when commencing to give ground near the 600 metres when I'VE GOT THIS (G Walsh) was taken out by ZEDACE (D Turner), which shifted out slightly when looking to improve, with YIPSON making contact with the hind quarters of MAGIC WONDER, turning that runner inwards.</p> <p><b>D Turner</b> (ZEDACE) - Issued with a warning (Rule 638)(1)(d) after allowing his mount to shift outwards when not sufficiently clear of YIPSON near the 600 metres.</p> <p><b>S Fannin</b> (CLASS ABOVE) - Issued with a warning under rule 638(3)(b)(ii) with regards to his whip use prior to the 100 metres.</p> <p><b>E Farr</b> (ZARTAN) - Issued with a warning under rule 638(3)(b)(ii) with regards to her whip use prior to the 100 metres.</p> <p><b>L Douglas</b> (JUST ISHI) - Issued with a warning under rule 638(3)(b)(ii) with regards to his whip use prior to the 100 metres.</p>	
<b>Race 3</b>	<b>NAYLOR LAWRENCE &amp; ASSOCIATES/TARARUA HELIWORK 1200 (1200 Metres)</b>
<p><b>RED PEPPER</b> (J Parkes) – Underwent and passed a pre-raced veterinary inspection after making contact with a fence in the enclosure. Steadied leaving the barriers losing ground when crowded to the inside of AUTHENTIC CHARM, which jumped away awkwardly. Dictated 200 metres.</p> <p><b>AUTHENTIC CHARM</b> (R Hannam) – Jumped away awkwardly. Held up passing the 300 metres having to be angled outwards to improve approaching the 200 metres and when doing so dictated RED PEPPER (J Parkes), which shifted away from AUTHENTIC CHARM, inconveniencing AMPUIS (C O'Beirne). R Hannam was advised to exercise greater care when shifting ground.</p> <p><b>J Parkes</b> (RED PEPPER) – Admitted a breach of Rule 638(1)(d) in that he permitted his mount to shift outwards making heavy contact with the hind quarters of AMPUIS near the 350 metres. After viewing footage and hearing submissions the JCA suspended his licence to ride in races from the close of racing on Thursday, 25 April up to and including racing on Thursday, 2 May (5 national riding days).</p> <p><b>AMPUIS</b> (C O'Beirne) – Heavily contacted 350 metres. Inconvenienced 200 metres.</p>	

**RELIABLY PERKY** (L Hemi) - Slow away.

**YES BOY** (Z Moki) - Raced keenly in the early stages.

**STARWEKA** (H Andrew) - Raced three wide without cover throughout.

**HUTSEEGUA** (J Kam) – Held up approaching the 400 metres, continued to have difficulty obtaining clear running until near the 200 metres.

**TARABEEBEE** (D Bradley) - Held up passing the 400 metres having to be angled outwards to gain clear running approaching the 200 metres.

**RUSTY IN RONGOTEA** (R Elliot) – Held up from the 400 metres gaining clear running r entering the home straight.

**MI GOLD CARD** (L Allpress) - When questioned into performance rider could offer no excuse.

Track upgraded to Good (3) following Race 3.

**Race 4** | **DANNEVIRKE DAIRY SUPPLIES 1400 (1400 Metres)**

**R Myers** (LUCIDITY) – Was examined by St John paramedics and cleared to ride after being dislodged in the enclosure.

**HUNDYAMONTH** (M Singh) - Jumped away awkwardly and shifted out hampering WHOZTHEBOSS.

**WHOZTHEBOSS** (Z Moki) - Hampered start. Contacted 350 metres and again approaching the 300 metres.

**RHIZA** (J Riddell) - Blundered on jumping away crowding COLORADO MISS. When questioned into performance rider could offer no tangible excuse but noted that the mare had been disappointing. A subsequent veterinary inspection revealed a slightly slow recovery rate.

**COLORADO MISS** (C Johnson) – Crowded at the start.

**SCOTTISH STAR** (J Parkes) - Jumped away awkwardly and blundered.

**SO IT WAS** (H Andrew) – Crowded shortly after the start, losing ground, when DALLA MOSA lay out.

**MARLO BIK** (L Allpress) - Hampered shortly after start when LUCIDITY lay in.

**LUCIDITY** (R Myers) – Unbalanced when bumped approaching the 300 metres.

**DALLA MOSA** (D Bradley) – Became awkwardly placed making contact with the hind quarters of WHOZTHEBOSS near the 350 metres when attempting a run between WHOZTHEBOSS and COLORADO MISS, when both runners shifted ground, having to be restrained. WHOZTHEBOSS then shifted out making contact with the hind quarter of LUCIDITY, unbalancing that runner, approaching the 300 metres.

**Race 5** | **G SQUIRES BUILDING 1400 (1400 Metres)**

**ONE OF THE BEST** (L Hemi) - Slow away. Held up approaching the 400 metres gaining clear running entering the home straight.

**QJI CRYSTAL** (J Parkes) - Slow away.

**RIO STAR** (R Hannam) – Raced keenly in the early and middle stages. Held up from the 500 metres gaining clear running approaching the 250 metres.

**END OF STORY** (C Johnson) - Raced three wide without cover. When questioned into performance rider could offer no tangible excuse. Following the race END OF STORY was found to have bled. After undergoing a veterinary inspection, the filly was confirmed to have bled. END OF STORY is now unable to be in training for two months and is unable to trial or race for three months with a veterinary clearance required prior to racing or trialling next.

**Race 6** | **NZB INSURANCE PEARL SERIES RACE (1600 Metres)**

**Rider M Singh** was dislodged from FLORENCE O'REILLY after leaving the enclosure but was uninjured.

**STORMY WATERS** (J Riddell) – Late scratching on veterinary advice after becoming fractious in the barriers. Connections were advised that STORMY WATERS must barrier trial prior to racing next. Co-Trainer S Ramsay indicated that the mare was unlikely to be persevered with as a racing proposition from their stable.

**LADY VERAWOOD** (H Andrew) – Began awkwardly tightening GOLD FLAKE, which settled back.

**GOLD FLAKE** (R Hannam) – Tightened at start, settling back, then raced three wide without cover. Lay out under pressure in the home straight.

**MISS SHER NAN** (D Bradley) – Held up from the 500 metres gaining clear running approaching the 300 metres.

**FLORENCE O'REILLY** (M Singh) - Shifted out under pressure passing the 300 metres briefly tightening AFFLUENT (C Johnson).

**AFFLUENT** (C Johnson) – Briefly tightened 300 metres. Lay out under pressure inside the final 100 metres, having to be straightened.

**Race 7** | **IN TOUCH DECORATORS 1600 (1600 Metres)**

**SHEZ EKSTRA** (J Parkes) – Slow away. Held up early in the final straight and did not obtain clear running until near the 200 metres.

**WICKLOW** (Z Moki) – Raced three wide without cover.

**MOZAMBIQUE** (C O'Beirne) - Rider reported the filly had hung throughout.

**Race 8** | **SEEDS & CEREALS 1600 (1600 Metres)**

**LODI** (D Turner) - Refused to leave the barriers taking no part in the race. Co-Trainer H Wynyard was advised that given this is not the first occasion which LODI has refused to jump away, the mare will be required to barrier trial on multiple occasions to the satisfaction of a stipendiary steward prior to racing again.

**MISTER GERONIMO** (L Hemi) – Slow away.

**TIRO** (C Johnson) - Slow away. Contacted 100 metres.

**IN SEGRETO** (L Allpress) – Raced keenly in the middle stages.

**ALTIUS** (R Myers) - Held up approaching the 500 metres, continued to have difficulty obtaining clear running until passing the 200 metres.

**LADY ZERAPH** (C Burdan) – Shifted out abruptly near the 100 metres making contact with TIRO. Apprentice C Burdan was advised to exercise care.

**SACRED PARTY** (J Riddell) – When questioned into performance rider advised the gelding had raced keenly but otherwise could offer no excuse. A post-race veterinary inspection was clear.
