RACE COMMENTS:

Race 1	BURTON CONSTRUCTION 3YO

OCEAN BILLY (C Burdan) – Blundered leaving the barriers losing ground. Hampered 950 metres.

PATSYS LASS (S Collett) – Restrained soon after leaving the barrier. When questioned regarding performance rider advised that the filly had failed to handle today's track conditions.

SAVASTEP (C Grylls) – Hampered 950 metres after improving on to heels shifting back on to OCEAN BILLY which was also hampered.

RUBIRA (L Satherley) - Came together with ALASKAN GOLD near the 150 metres.

Race 2 CARTERS 2200

MAMBA (J Riddell) - Began awkwardly.

SCAGLIONI (R Scott) – Began awkwardly losing ground.

SUFFICE TO SAY (C Johnson) – Over-raced when being restrained in the early stages.

Race 3 ARAWA PARK LOUNGES FOR HIRE 1400

THE REVENANT (R Elliot) - Slow to begin.

JUST KATE (L Satherley) – Raced ungenerously in the early to middle stages. Hampered 1100 metres when forced wide by VALHEXA which was forced out by MEXICAN TYCOON (S Spratt).

VALHEXA (J Fawcett) – Hampered 1100 metres when forced wide.

OUR CRAFTSMAN (A Calder) – When questioned regarding performance rider advised that the gelding had failed to handle today's track conditions.

MASTER OAKLEIGH (A Goindasamy) – Permission was granted for the gelding to race without blinkers due to track conditions.

S Spratt (MEXICAN TYCOON) – Admitted a breach of careless riding in that she directed her mount outwards near the 1100 metres when not sufficiently clear of VALHEXA which was hampered. After hearing submissions the Judicial Committee imposed a suspension on S Spratt's licence from the conclusion of racing on Saturday 27 April until the conclusion of racing on 8 May, 7 national riding days.

Race 4 CAMPBELL INFRASTRUCTURE 1215

DONNA ANNE BILLY (C Burdan) – Permission was granted for the mare to race without blinkers due to track conditions.

CASAQUINMAN (C Johnson) – Began awkwardly then crowded losing ground. Raced keenly in the early stages.

TE TORO PEARL (C Lammas) – Held up entering the final straight and continued to have difficulty obtaining clear running until near the 100 metres.

MALAMBO (R Elliot) – Raced in restricted room for a distance approaching the 100 metres.

PROM QUEEN (S Collett) – When questioned regarding performance rider S Collett advised that the mare had been unsuited by today's track conditions.

C Grylls (YORKSHIRE DALES) – Issued with a warning for his whip use prior to the 100 metres.

Race 5 MACMILLAN ACCOUNTANTS 1950

VOLER POUR MOI (D Danis) - Began awkwardly losing ground.

COSSACK WARRIOR (D Mansour) – Slow to begin.

MENTAL TELEPATHY (C Grylls) – When questioned regarding performance rider advised that the gelding had failed to handle today's track conditions.

A Calder (AZABOY) – Issued with a warning for his whip use prior to the 100 metres.

Race 6 ISCL 1215

BEWITCHED (S Collett) – Crowded soon after leaving the barriers and steadied losing ground.

FAST AND FURIOUS (A Calder) – Crowded soon after leaving the barriers and steadied losing ground.

Race 7 RYDGES HOTEL ROTORUA 1400

BRING TO THE BLOCK (C Johnson) – Slow to begin. Raced keenly in the early stages making the bend near the 1250 metres awkwardly. When questioned regarding the performance the rider could offer no excuse.

Race 8 CUP DAY SATURDAY MAY 11TH 1400

FORT KNOX (L Satherley) – Slow to begin.

MOTUMAN (A Goindasamy) - Began awkwardly.

PLEEZE BEE (C Burdan) – Began awkwardly.

FORSEEABLE (A Calder) – Raced keenly when being steadied in the early stages.
