## RACE COMMENTS:

<b>Race 1</b>	<b>FORSYTH BARR HB SPORTS AWARDS MAY 25<sup>TH</sup> 2200 (2200 METRES)</b>

**ABBEY ROAD** (D Turner) – Began awkwardly then raced keenly in the early stages.

**HANK MOODY** (S O'Malley) – When questioned into performance rider could offer no excuse.

**Race 2** | **MULCASTER BLOODSTOCK 2YO (1200 METRES)**

**SEVEN SEAS** (A Goindasamy) - Began awkwardly settling back.

**SPRINGSTEIN (D Bradley)** - Jumped inwards at the start tightening CINZENTO and LETHAL, held up for a short distance near the 500 metres, bumped near the 350 metres and again passing the 250 metres becoming briefly unbalanced.

**CINZENTO** (C Johnson) - Tightened at the start, raced keenly in the early and middle stages. When question C Johnson advised that when trying to settle the filly it began to over-race when taken on, so elected to improve to lead near the 800 metres. C Johnson further advised that the filly had hung in the early stages when being restrained.

**LETHAL** (R Myers) - Tightened at the start.

**FREE TO SHINE** (T Johnson) - Raced three wide without cover throughout.

**MEDIA** (C O'Beirne) - Hung rounding the turn

**BRONTE BEACH** (D Turner) - Attempted to improve into a marginal run to the outside of PLATINUM SPIRIT at the 350 metres making contact with SPRINGSTEIN, clipping a heel and blundering, tightened approaching the 250 metres when PLATINUM SPIRIT shifted out and away from LETHAL also hampering SPRINGSTEIN.

**Race 3** | **HAWKE'S BAY OWNERS ASSOCIATION MILE (1600 METRES)**

**SPEED CALL** (A Jones) - Slow away.

**RIO STAR** (R Hannam) – Tightened at the start settling back, raced keenly in the middle stages, tightened and contacted when attempting to improve into a narrow run between VISCONTI which shifted in when struck with the whip and ST THERESA which lay out near the 250 metres. R Hannam was advised to exercise greater care when shifting ground.

**WAR OF WORDS** (M Singh) - Made the bend near the 1400 metres awkwardly going back onto LOUBOUTIN which was restrained, dictated and hampered near the 350 metres.

**LOUBOUTIN** (C Johnson) - Restrained off heels near the 1400 metres. A post-race veterinary inspection revealed the gelding had fibrillated. Connections were advised that the mare will require a veterinary clearance prior to racing next. Trainer J Bary advised that the mare would be sent for a spell.

**IMPECCABLE ONE** (D Bradley) - Raced ungenerously for a short distance near the 1400 metres.

**ST THERESA** (T Johnson) – Hung rounding the turn and lay out under pressure in the home straight.

**CHOLEE** (A Goindasamy) - Held up approaching the 350 metres for a short distance.

**D BRADLEY** (IMPECCABLE ONE) - Was issued with a warning under [Rule 638(3)(b)(ii)] with regards to his whip to the 100 metres.

**R MYERS** (TUIGIRL) – Admitted a breach of [Rule 638(1)(d)] in that she allowed her mount to shift out when not clear of WAR OF WORDS which was dictated and hampered near the 300 metres. After hearing submissions, the Judicial

Committee suspended her license to ride in races from the close of racing Wednesday 1st May up to and including racing on Thursday May 9<sup>th</sup> (6 days).

**Race 4** | **HB RACING THANKS MICK ORMOND MILE (1600 METRES)**

**PUZZLAR** (M Singh) - Raced three wide without cover throughout.

**CULLEN BOHANNON** (Z Moki) - Held up entering the home straight having to be angled outwards across heels approaching the 200 metres.

**MARQUITA MISS** (C O'Beirne) - Raced in restricted room when DAM RELIABLE lay out dictating THE COSSACK simultaneously as MISTER GERONIMO lay inwards approaching the 200 metres.

**CRAFTYEVA** (E McCall) - Lay out under pressure in the home straight having to be straightened.

**Race 5** | **PREFERMENT – FIRST YEARLINGS FOR SALE JAN 2020 MILE (1600 METRES)**

**THE HEIRESS** (L Satherley) – Slow away (2 lengths), raced in restricted room over the final stages.

**LADYNADEL** (Z Moki) – Jostled for a number of strides with PEP TORQUE approaching the 1000 metres.

**PEP TORQUE** (C O'Beirne) – Jostled near the 1000 metres.

**D BRADLEY** (TOMS) -Was issued with a warning under [Rule 638(1)(d)] in that he allowed his mount to shift in over the final stages tightening AWESOME AL near the finish.

**AWESOME AL** (C Johnson) - Tightened near the finish.

**A GOINDASAMY** (INSCRIPTION) - Was spoken to with regards to his whip use prior to the 100 metres.

**Race 6** | **PREFERMENT @ BRIGHTHILL FARM 1400 (1400 METRES)**

**UGU FOSCOLO** (D Turner) – Jumped away awkwardly, raced three wide without cover throughout, when questioned into performance the rider advised the gelding had raced keenly throughout. A subsequent veterinary inspection revealed slight lameness to the right fore, the gelding had also lost a right hind plate during the running.

**SCANDALO** (D Hirini) – Raced three wide early prior to being sent forward near the 800 metres, hung rounding the final turn, tightened over the final stages when CHICANE shifted out and away from RED SIERRA. A Goindasamy was advised to exercise greater care.

**CHICANE** (A Goindasamy) - Raced in restricted room approaching the 400 metres.

**RED SIERRA** (C O'Beirne) - Bumped with AMBITIOUS WINNER when both runners attempted to improve to the outside of SOUTHERN ICON approaching the 200 metres.

**AMBITIOUS WINNER** (L Satherley) – Lay in under pressure early in the home straight, bumped near 200 metres.

**Race 7** | **HAWKE'S BAY BREEDERS ASSOCIATION 1200 (1200 METRES)**

**WILD SEAS** (D Bradley) - Restrained from a wide draw.

**CHIQUITITA** (C Johnson) - Raced three wide without cover throughout.

**PARVINA** (A Goindsamy) - When questioned regarding performance the rider advised the mare had travelled well throughout but had been disappointing in the home straight. A post-race veterinary inspection revealed the mare had

suffered cardiac arrhythmia and a low grade lameness to the left hind. Connections were advised PARVINA would require a veterinary clearance prior to racing next.

**D BRADLEY** (WILD SEAS) - Admitted a breach of [Rule 638(3)(b)(ii)] Whip use prior to 100 metres. Suspended from close of racing Saturday 27<sup>th</sup> April up to and including Wednesday May 8<sup>th</sup> (6 days).

**Race 8** | **PREFERMENT – 13 WEANLINGS @ KARAKA 1400 (1400 METRES)**

**ROLL THE GOLD** (R Jones) - Began awkwardly, heavily contacting CHARLIE HORSE which settled back.

**CHARLIE HORSE** (T Johnson) – Heavily contacted at start, then raced ungenerously in the early stages.

**DEERFIELD** (S O’Malley) – Commenced to race fiercely down the back straight having to be restrained for some distance and when doing so went back onto MISS CONTESSA which had to be steadied near the 800 metres, continued to over-race rounding the turn.

**MISS CONTESSA** (Z Moki) – Restrained off heels near the 800 metres.

**MIKJENE** (D Hirini) -Raced three wide without cover throughout.

**AILEEN GRACE** (A Goindasamy) - Held up near the 500 metres before being angled inwards near the 300 metres.

**S O’MALLEY** (DEERFIELD) – Was issued with a warning under [Rule 638 (3)(b)(ii)] regarding his whip use prior to the 100 metres. Was spoken to after not being able to claim his full allowance. After discussion with stewards, Apprentice O’Malley agreed to amend his book weight in the short term.
