## GENERAL:

Rider M McNab was fined \$100 under the Minor Infringement Schedule after advising Stewards he was unable to make the weight for FULLINBLOOM and CRESCENT. M McNab further advised Stewards after riding in race two that he would be unable to make the contracted weight for HONFLEUR in race five.

Rider T Harris was fined \$200 under the Minor Infringement Schedule after advising Stewards he was unable to make the weight for LORD VALENTINE and CAMPING.

**SUPPLEMENTARY:**Avondale Jockey Club - 25 April 2019**Race 2 Auckland Alarms 1200**

**LET'S DO THIS** (L Innes) – Trainer N Tiley advised Stewards that he was satisfied with the recovery of the filly following this race and it is his intention to add blinkers to LET'S DO THIS for its next start.

**UGU FOSCOLO** (D Turner) – Trainer S Autridge advised Stewards in the days following this race the gelding was still showing signs of lameness, adding UGU FOSCOLO would undergo further veterinary examination before connections made a decision on the gelding's racing future.

<b>Race 1</b>	<b>SSANGYONG 2200</b>
<p><b>CLADDAGH</b> (R Elliot) – Slow to begin.</p> <p><b>HENRY TUDOR</b> (E Farr) – Raced three wide without cover for the majority of the race.</p> <p><b>COWBOYS DONT CRY</b> (M Roustoby) – Commenced to over-race in the early stages having to shift out near the 2000 metres to avoid the heels of TOP ACTRESS. COWBOYS DONT CRY then continued to over-race for a distance.</p> <p><b>NGATIRA GOLD</b> (J Seivwright) – Improved into a marginal run passing the 400 metres, and then raced in restricted room for a distance before having to be steadied and shift outwards to obtain clear running passing the 200 metres.</p>	
<b>Race 2</b>	<b>HAUNUI FARM 2100</b>
<p><b>DAWON</b> (L Satherley) – Began awkwardly losing ground.</p> <p><b>EAGLE FIFTY</b> (M McNab) – Slow to begin.</p> <p><b>TWIN SPINNER</b> (C Dell) – Shifted out abruptly to avoid heels near the 1300 metres, and was obliged to race three wide without cover for the remainder.</p> <p><b>NERVE NOT VERVE</b> (C Lammas) – Raced keenly for a distance passing the 1400 metres.</p> <p><b>M Cameron</b> (HEREMON) – Admitted a breach of Rule 638(3)(b)(ii) for excessive use of the whip on a horse that was out of contention, with his license to ride in races being suspended from the conclusion of racing on 8 May up to and including racing on 16 May, 6 national riding days.</p>	
<b>Race 3</b>	<b>SPLICE CONSTRUCTION 1600</b>
<p><b>MISHKA</b> (S Phelan) – Began awkwardly then was crowded shortly after losing ground.</p> <p><b>IPATCH</b> (J Seivwright) – Began awkwardly losing ground. Raced wide without cover throughout.</p> <p><b>ZENNTARI</b> (E Farr) – Crowded shortly after the start losing ground.</p> <p><b>SHACKELTONS EDGE</b> (M Gillies) – Shifted in passing the 400 metres to obtain clear running, then was held up when improving on to heels until passing the 250 metres.</p>	

**FLYINGWITHOUTWINGS** (N Downs) – Had to steady for a distance passing the 200 metres when attempting a marginal run to the inside of MICHIKO.

**H McNeill** (LADY AZAMOUR) – Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively on LADY AZAMOUR prior to the 100 metres and was fined the sum of \$300.

**N Downs** (FLYINGWITHOUTWINGS) – Admitted a breach under Rule 330(3)(c) for being unable to claim down to his riding weight and was granted permission to ride the horse as there was no suitable replacement rider available. N Downs was fined the sum of \$100.

**H McNeill** (LADY AZAMOUR) – Admitted a breach in that he was unable to claim down to his riding weight and was fined the sum of \$200. H McNeill was permitted to ride LADY AZAMOUR as there was no suitable replacement rider available.

<b>Race 4</b>	<b>BUFFALO &amp; CO 1200</b>

**SO WICKED** (M Cameron) – Began awkwardly then was crowded shortly after losing ground.

**QUANTUM** (A Goindasamy) – Slow to begin. Held up for clear running early in the final straight.

**INCA WARRIOR** (J Riddell) – Raced wide without cover throughout. Inconvenienced 75 metres.

**QUIZMASTER** (C Lammas) – Raced keenly for a distance making the bend near the 1000 metres awkwardly.

**BRUEGEL** (R Elliot) – Improved on to heels approaching the 200 metres having to be steadied, then shifted inwards in an attempt to obtain clear running and was held up then shifted out passing the 75 metres inconveniencing INCA WARRIOR.

**TRYFAN** (A Calder) – Inconvenienced over the concluding stages after improving on to heels.

**GOBONIEGO** (S Collett) – Rider dropped her whip approaching the 200 metres.

<b>Race 5</b>	<b>DUNSTAN HORSE FEEDS 1200</b>

**LITTLE SHIRLEY** (S Collett) – Began awkwardly losing ground.

**FLUOROBUS** (A Calder) – Briefly steadied when awkwardly placed on the heels of MAGNIFY which made the bend awkwardly passing the 1000 metres. Briefly inconvenienced passing the 50 metres when HONFLEUR shifted out under pressure.

**MAGNIFY** (L Innes) – Made the bend awkwardly passing the 1000 metres running wide and continued to until passing the 600 metres.

**OVERTHEMARK** (V Colgan) – Shifted out passing the 300 metres to avoid the heels of the weakening SUGGESTED.

**FIRE INCANTO** (B R Jones) – Raced wide without cover throughout.

**HONFLEUR** (D Mansour) Shifted out under pressure final 100 metres.

The connections of the third placed horse FLUOROBUS viewed Stewards video footage following the race, electing not to proceed with a protest.

<b>Race 6</b>	<b>SCHOLARS PRE SCHOOL 1200</b>

**THREE SIXTY** (S Collett) – Began awkwardly losing ground.

**ANN TALE** (A Jones) – Shifted outwards abruptly on jumping away making firm contact with MISS TAVI and as a result lost ground.

**LUVLUCY** (V Colgan) – Began awkwardly then crowded shortly after having to be steadied.

**HEART OF SOUL** (L Satherley) – Began awkwardly. Made the 1000 metre bend awkwardly running wide.

**ELLE CEE** (M Kareem) – Began awkwardly losing ground. Hung out around the final bend.

**JACINDERELLA** (M Cameron) – Made the 1000 metre bend awkwardly shifting out hampering ANGEL DIVINE.

**ANGEL DIVINE** (A Calder) – Hampered 1000 metres losing ground.

**HUMORESQUE** (C Grylls) – Had to be steadied passing the 400 metres when placed in restricted room between SNIP and CHOUX A STAR when both those runners shifted ground.

<b>Race 7</b>	<b>TUAKAU COSSIE RACING SECTION 1400</b>

**ROSA FIORE** (T Thornton) – Crowded shortly after the start having to be steadied.

**MATTER OF FACT** (M Cameron) – Began awkwardly and shifted out crowding ROSA FIORE. Commenced to race ungenerously passing the 1200 metres placing RELIABLE BELLE in restricted room.

**KNIGHT TEMPLAR** (J Fawcett) – Crowded shortly after the start losing ground. Commenced to over-race passing the 1200 metres then having to be firmly restrained off heels near the 1100 metres.

**PLEADINGGUILTY** (A Goindasamy) – Crowded shortly after the start losing ground.

**RELIABLE BELLE** (M Coleman) – Steadied when placed in restricted room for a distance passing the 1200 metres.

**BLADE** (L Satherley) – Commenced to over-race passing the 1000 metres and had to be firmly restrained when becoming awkwardly placed on the heels of KING KHALID. Briefly held up passing the 200 metres having to shift out to obtain clear running.

**LORD VALENTINE** (A Calder) – Raced wide without cover for the majority of the race. Inconvenienced 450 metres and again passing the 300 metres.

**SPOIL SPORT** (L Innes) – Briefly held up early in the final straight, then shifted out to obtain clear running inconveniencing LORD VALENTINE.

**COURAGEOUS BEAU** (B R Jones) – Shifted out near the 300 metres when awkwardly placed on heels forcing CHAPEAU out on to ROCKING ALONG which was briefly hampered.

**ROCKING ALONG** (V Colgan) – Hampered 300 metres.

<b>Race 8</b>	<b>FASTTRACK INSURANCE 1400</b>

**RELIABLE FRIEND** (C Dell) – Slow to begin.

**ANATOLIA** (A Calder) – Over-raced in the early stages.

<p><b>LORD POLONIUS</b> (C Lammas) – Commenced to over-race near the 900 metres making the bend awkwardly, then shifted out off heels approaching the 800 metres forcing ANGELICA wider.</p> <p><b>FOLSOM PRISON</b> (T Thornton) – Made the bend awkwardly passing the 1000 metres forcing LOOKS LIKE wider on the track.</p> <p><b>LOOKS LIKE</b> (E McCall) Forced over extra ground 1000 metres.</p> <p><b>ANGELICA</b> (C Grylls) – Forced wider approaching 800 metres. ANGELICA and PERSISTENCE made firm contact on two occasions over the final 100 metres. When questioned into the performance rider advised the filly may prefer more easing of the track.</p>	
<b>Race 9</b>	<b>THE WORKSHOP 1924 1400</b>
<p><b>CRAFTY JESS</b> (C Grylls) – Slow to begin then crowded shortly after, and then was obliged to race wide without cover for the majority of the race.</p> <p><b>LILLY THUNDER</b> (R Smyth) – Made the bend awkwardly having to steady when becoming awkwardly placed on heels near the 1000 metres.</p> <p><b>WINDY HEIGHT</b> (T Thornton) – Steadied when awkwardly placed on the heels of TOORAK TOWER dropping back on to DANGER DEE which also had to be firmly restrained passing the 450 metres.</p> <p><b>O’GUY</b> (C Lammas) – Had difficulty obtaining clear running in the final straight.</p>	
<b>Race 10</b>	<b>PATUMAHOE PLUMBING 1600</b>
<p><b>PATSYS LASS</b> (R Smyth) – Became fractious in the barrier stall rearing up, and when the start was effected rider R Smyth had not regained her left side stirrup iron, becoming unbalanced and dislodged the rider who was uninjured. A warning was placed against the filly’s barrier manners.</p> <p>Following this race the siren was sounded requesting a ruling from the Judicial Control Authority under Rule 632(1) as to PATSYS LASS being denied a fair start with the filly being declared a non-runner (late scratching).</p> <p><b>RODMAR</b> (T Thornton) – Began awkwardly losing ground. Raced wide without cover throughout.</p> <p><b>SUPER BULLET</b> (C Grylls) – Slow away.</p> <p><b>BAK DA MASTER</b> (J Kamaruddin) – Raced three wide without cover throughout.</p> <p><b>EXCELSIOR ISLAND</b> (D Mansour) – Hampered for a distance passing the 200 metres by the riderless horse.</p> <p><b>ANICETA</b> (V Colgan) – Held up for clear running early in the final straight until passing the 200 metres.</p>
