O Bosson was replaced on Race 3 PINULTIMATE, Race 6 OUT OF THE PARK and Race 9 ENGLISH ROSE due to being overweight. O Bosson was issued with a Minor Infringement Notice and fined \$200.

**M McNab** Admitted a breach in that he failed to make the contracted weight for SCORPZ and TIA CELESTE. After considering submissions the Judicial Committee imposed a fine of \$500.

#### RACE COMMENTS:

<b>Race 1</b>	<b>A P GOLAN REGISTERED VALUERS 1600</b>
<p><b>VALHEXA</b> (E McCall) – Began awkwardly shifting out, hampered near the 250 metres.</p> <p><b>DANCE AWAY</b> (M Cameron) - Held up for a distance approaching the 500 metres by the weakening <b>KONTACT</b>.</p> <p><b>OLD COUNTESS</b> (T Newman) - Had to be firmly restrained after improving onto the heels of the weakening <b>KONTACT</b> approaching the 400 metres.</p> <p><b>FLYING FANTASIA</b> (M Kareem) - Shifted out near the 350 metres making contact with <b>VALHEXA</b> which was forced wider. M Kareem was advised to exercise care. Raced in restricted room for a distance approaching the 250 metres when improving into a marginal run to the outside of <b>PLAYDAY</b> (D Danis) which shifted out. D Danis was advised to exercise care. Also hampered as a result was <b>JET SET</b> which was bumped outwards hampering <b>VALHEXA</b>.</p> <p><b>JET SET</b> (J Riddell) - Hampered and forced wider near the 250 metres.</p> <p><b>DEEGEEARE</b> (D Mansour) - Raced wide without cover throughout.</p> <p><b>A Goindasamy</b> (ONE WAY STREET) – Issued with a warning for his whip use prior to the 100 metres.</p>	
<b>Race 2</b>	<b>LUMINATEONE 1600</b>
<p><b>SIR MAGGIO</b> (E McCall) – Slow away (4L).</p> <p><b>FIGEAMEOUT</b> (R Jones) – Slow away. Shifted out slightly entering the final straight making contact with the hind quarters of <b>PAVLICHENKO</b> which was momentarily unbalanced.</p> <p><b>SODA</b> (C Lammas) - Began awkwardly.</p> <p><b>WHISPER ROCK</b> (A Calder) – Improved into a marginal run approaching the 1200 metres to the inside of <b>SEAFORTH LASS</b> which was taken in slightly by <b>PRESTIGIOUS LAD</b> before being corrected by its rider with <b>WHISPER ROCK</b> and <b>KIPLING</b> being hampered as a result. Raced in restricted room passing the 100 metres when <b>PRESTIGIOUS LAD</b> shifted in.</p> <p><b>KIPLING</b> (A Goindasamy) - Hampered near the 1200 metres, shifted out passing the 50 metres in an attempt to obtain clear running then raced in restricted room for the remainder of the race.</p> <p><b>JIMMY JAMES</b> (S Collett) – Had to shift out near the 1100 metres to avoid the heels of <b>BECAUSE</b> (D Danis) which was steady. Hampered as a result was <b>PINEAPPLE LUMP</b> which was racing keenly and <b>VERA DRAKE</b>. Riders D Danis and T Thornton (<b>NESLEY</b>) were reminded of their obligations in regards to easing the pace.</p>	

**PINEAPPLE LUMP** (O Bosson) – Hampered near the 1100 metres.

**VERA DRAKE** (L Innes) – Hampered near the 1100 metres. Raced three wide without cover throughout.

**PAVLICHENKO** (R Hannam) – Bumped and momentarily unbalanced entering the final straight.

**SEAFORTH LASS** (V Colgan) - Underwent a post-race veterinary examination which revealed no obvious abnormality.

<b>Race 3</b>	<b>PGG WRIGHTSON LTD 1200</b>

**LOCK IT IN** (D Danis) - Over raced in the early stages making the 800 metre bend awkwardly then ran off rounding the bend near the 600 metres and was not preserved with for the remainder of the race. A post-race veterinary examination did not reveal any abnormality. Trainer W Hillis was advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**KAINUI ROSE** (V Colgan) - Underwent a post-race endoscopic examination which did not reveal any abnormality.

**COINTREAU** (S McKay) – Slow away.

**JENNIFER ECCLES** (D Mansour) - Commenced to over race for a distance when being steadied passing the 1000 metres.

**QJI MELODY** (M Cameron) - Co-trainer A Forsman was advised that a barrier warning would be placed against the filly with A Forsman advising the filly would now be spelled. When questioned regarding the manner in which he rode rounding the final bend M Cameron advised that the filly had hung outwards throughout the running making the final bend awkwardly and that he had been conscious of ensuring that nothing was improving to his inside before correcting his mount when entering the final straight. M Cameron's explanation was noted.

**AMAZING TEAM** (R Elliot) – Over raced in the early stages then had to be firmly restrained away from the heels of JENNIFER ECCLES (D Mansour) which shifted in when becoming awkwardly placed on the heels of LOIRE (S Collett) which shifted in passing the 1000 metres. Riders S Collett and D Mansour were both advised to exercise care. AMAZING TEAM then continued to over race for a distance through the middle stages.

**LONG JACK** (J Riddell) - Had to steady passing the 1000 metres away from the heels of AVADANE (L Innes) which shifted in when not fully clear. L Innes was advised to exercise care. Had to shift out passing the 150 metres to obtain clear running.

**GLORY CHANCE** (D Danis) - Raced three wide without cover throughout.

**LOIRE** (S Collett) - Held up until near the 150 metres.

<b>Race 5</b>	<b>SLATTERY CONTRACTING 1400</b>

**LIVVY LASS** (S McKay) – Began awkwardly shifting out making contact with the hind quarters of SOUTHERN QUEEN losing ground.

**SOARING WYVERN** (A Calder) – Steadied shortly after the start when awkwardly placed on heels then commenced to over race for a distance in the early stages.

**MALIBU MAGIC** (J Fawcett) – Raced wide without cover throughout.

**SOUTHERN QUEEN** (R Elliot) - Held up between the 250 metres and 150 metres after improving onto heels.

**SCHERZO** (V Colgan) - Raced in restricted room for a distance entering the final straight having to be steadied then held up until near the 200 metres.

<b>Race 6</b>	<b>NZB INSURANCE PEARL SERIES RACE (1200 metres)</b>

**LITTLEMISSPUNKY** (L Satherley) – Began awkwardly then steadied when placed in restricted room shortly after the start losing ground, over raced in the early and middle stages making the 800 metre bend awkwardly.

**SWEET SURPRIZE** (S Collett) – Began awkwardly losing ground.

**OUT OF THE PARK** (L Innes) - Commenced to over race when being steadied for a distance passing the 1000 metres.

**WHOSHE’S GIRL** (A Goindasamy) - Hampered on jumping away losing ground.

**CRAFTYAFFAIR** (M Cameron) – Crowded near the 700 metres then further hampered passing the 600 metres and forced inwards.

**CHATELAINE** (C Grylls) – Crowded and checked near the 700 metres.

**M Cameron** (CRAFTYAFFAIR) - Admitted a charge in that he misconducted himself by using offensive language directed towards rider T Thornton following the finish of the race. After hearing submissions, the Judicial Committee imposed a fine of \$750.

**T Thornton** (GIRL OF STEEL) - Defended a charge of careless riding in that she permitted her mount GIRL OF STEEL to shift inwards when not sufficiently clear of CRAFTYAFFAIR which was dictated inwards crowding CHATELAINE which was checked near the 700 metres with GIRL OF STEEL again shifting inwards forcing CRAFTYAFFAIR inwards near the 600 metres. After viewing films and hearing relevant evidence and submissions, the Judicial Committee found the charge to be proved suspending T Thornton’s licence to ride in races from the conclusion of racing on Wednesday 15<sup>th</sup> May up to and including racing on 23<sup>rd</sup> May, 6 National days.

<b>Race 7</b>	<b>MURRAY WILCOX LTD 1200</b>

**THE FAME GAME** (T Thornton) – Over raced in the early to middle stages, hampered near the 800 metres.

**JEWEL OF PATCH** (C Grylls) – Raced in restricted room inside of PINK GRAFFITI which shifted in slightly and the outside of O’HE CAN which was forced outwards by CAMEAHOTFRIDAY which made the bend awkwardly near the 800 metres. As a result, JEWEL OF PATCH had to be firmly restrained and shifted out hampering VEINE D’OR. Also hampered as a result was THE FAME GAME.

**PINK GRAFFITI** (L Innes) – Raced in restricted room near the 800 metres then made the bend awkwardly running wider.

**VEINE D’OR** (D Danis) - Hampered near the 800 metres.

**O’HE CAN** (T Harris) - Raced in restricted room for a distance approaching the 800 metres.

**CAMEAHOTFRIDAY** (S Collett) - Made the bend near the 800 metres awkwardly and shifted out.

**C Burdan** (BLUETWENTYTWO) – Fined \$300 by the Judicial Committee after admitting a charge of excessive use of the whip prior to the 100 metres.

<b>Race 8</b>	<b>MATAMATA POST &amp; RAILS ITM 1200</b>
<p><b>OUR ELLIEMAY</b> (C Grylls) – Reared as the gates opened losing ground.</p> <p><b>ATA RANGI</b> (D Mansour) - Raced three wide without cover, shifted in under pressure making brief contact with DIDI BAY which was shifting out near the 150 metres. ATA RANGI then shifted out under pressure when racing greenly over the concluding stages.</p> <p><b>HOLSTY</b> (S Collett) – Had difficulty obtaining clear running early in the final straight.</p> <p><b>MR INCREDIBULL</b> (M Cameron) - Steadied when placed in restricted room over the concluding stages.</p> <p><b>CHUR CHING</b> (D Danis) - Lay out rounding the final bend.</p> <p><b>D Mansour</b> (ATA RANGI) - Admitted a charge of careless riding in that he permitted his mount to shift inwards when not sufficiently clear crowding KAJINO inwards onto VILLA NINE near the 800 metres. After viewing films and hearing submissions, the Judicial Committee suspended D Mansour’s licence to ride at race meetings from the conclusion of racing on Saturday 11<sup>th</sup> May up to and including racing on Wednesday 22<sup>nd</sup> May, 6 National days.</p> <p><b>VILLA NINE</b> (T Newman) - Crowded near the 800 metres.</p> <p><b>KAJINO</b> (M Kareem) – Crowded near the 800 metres.</p>	
<b>Race 9</b>	<b>MATAMATA TRACTORS &amp; MACHINERY 1600</b>
<p><b>CABOCHON</b> (A Goindasamy) - Slow away.</p> <p><b>MIGHTY COLOMBO</b> (J Fawcett) - Raced three wide without cover throughout.</p> <p><b>UNCLE BRO</b> (S Collett) - Raced wide without cover throughout.</p> <p><b>ENGLISH ROSE</b> (M Cameron) - Held up until near the 200 metres.</p> <p><b>CANCELLARA</b> (R Hannam) - Returned to the enclosure with blood in the nostril area and was confirmed as a bleeder following a veterinary examination. Trainer G Brick was advised that CANCELLARA would now be subject to a two month stand down from training, three month stand down from racing and would require a veterinary clearance prior to racing or trialing next.</p>	
<b>Race 10</b>	<b>DON GRIFFITHS TRENCHING LTD 2000</b>
<p><b>CRUISEO</b> (M Kareem) - Underwent a veterinary inspection behind the barriers after being kicked by another runner on its way to the start being passed fit to race.</p> <p><b>ANARCHY</b> (S McKay) – Slow to begin.</p> <p><b>JOE CARGO</b> (R Jones) - Raced wide without cover before improving forward to lead near the 1400 metres.</p> <p><b>RICHARD OF YORKE</b> (J Kamaruddin) - Commenced to over race near the 1600 metres with the saddle then shifting forward badly shortly after, then lost the use of his irons passing the 1200 metres being in severe difficulty for the remainder of the race.</p> <p><b>VICHY</b> (R Elliot) – Forced wider rounding the final bend by RICHARD OF YORKE which shifted out when the rider was in difficulty.</p>	

**VITTACHI** (C Grylls) - Held up rounding the final bend until early in the final straight.
