Race 3 - KIDSCAN 1600

PINEAPPLE LUMP (J Riddell) – Trainer A Forsman advised Stewards that the gelding would now undergo a wind operation following the results of a dynamic endoscopic examination.

Auckland Racing Club - 25 May 2019

Race 4 - White Refrigeration 1600

DREAM ON (M Coleman) – Trainer R James advised Stewards that the mare has now been sent for a spell.

Race 6 - Tuakau Cossie Racing Section 1200

KILLARNEY (V Colgan) – Trainer R James advised Stewards that he was satisfied with the recovery of the gelding and it is his intention to continue on with its current preparation.

Wellington Racing Club - 25 May 2019

Race 7 - NZB INSURANCE PEARL SERIES RACE (1400 Metres)

DO YA (C O'Beirne) – Trainer K Lawrence advised Stewards that on return to her stable the mare was showing signs of mild muscle soreness in the near hind leg which has since been treated, adding that mare has now recovered and it is her intention to continue on with its current preparation.

Egmont Racing Club - 26 May 2019

Race 5 - SILVER FERN FARMS MDN 3YO 1600M

AMUSEDANDCONFUSED (T Johnson) – Trainer N Quinn advised Stewards that the filly would not be persevered with as a racing proposition from his stable.

RACE COMMENTS:

Race 1 Barfoot & Thompson Chairman's Trophy (1400 metres)

LUCYINRIO (L Satherley) – Knuckled on jumping away.

ADMIRAL (E McCall) – Began awkwardly.

YORKSHIRE DALES (C Grylls) – Began awkwardly. Crowded for a distance approaching the 1200 metres and then steadied.

R Smyth (LILLY THUNDER) – Issued with a warning after permitting LILLY THUNDER to shift in approaching the 1200 metres when insufficiently clear of YORKSHIRE DALES which was hampered and steadied.

Race 2 Celebrating Santa Monica 1200

SASSO CORBARO (V Colgan) – Slow to begin. Over-raced in the middle stages. Inconvenienced for a distance approaching the 150 metres when attempting to improve to the outside of POWER O'HATA which was dictated wider.

SOLMIZATION (A Goindasamy) – Raced keenly in the early stages.

POWER O'HATA (C Grylls) – Crowded and steadied 1100 metres. Inconvenienced when forced wider 300 metres. Inconvenienced approaching the 150 metres when forced wider.

FIRE JET (R Scott) – Crowded and checked 1100 metres. Over-raced in the middle stages.

T Newman (IMBLAZE) – Admitted a breach of careless riding in that she permitted IMBLAZE to shift in approaching the 1100 metres when insufficiently clear of POWER O'HATA which was dictated inwards crowding FIRE JET which was checked losing ground with the Judicial Committee suspending her license to ride in races from the conclusion of racing on Thursday 6 June 2019 up to and including racing on Friday 14 June 2019, 5 national riding days.

IMBLAZE (T Newman) – Shifted out under pressure in the final straight.

Race 3 Celebrating Curraghmore Stud & Long Leaf's Victory at Ellerslie 2200

FLYING FANTASIA (M Kareem) – Underwent a veterinary inspection behind the barriers after making contact with the weigh in stall when leaving the enclosure and was cleared to start. Crowded shortly after the start having to be steadied. Crowded 1800 metres.

MASTER POET (D Danis) – Crowded shortly after the start having to be steadied.

PIERIAN SPRING (T Thornton) - Crowded 1800 metres making contact with the running rail.

EPAE ROAD (C Burdan) – Crowded and briefly hampered 1800 metres.

C Burdan (EPAE ROAD) - Reminded of her obligations with regards to her whip use on a horse out of contention.

J Kamaruddin (NEK MINNIT) – Issued with a warning after permitting NEK MINNIT to shift in near the 1800 metres crowding EPAE ROAD, FLYING FANTASIA and PIERIAN SPRING which made contact with the running rail and with EPAE ROAD being briefly hampered.

L Satherley (NOTHING TRIVIAL) – Reminded of her obligations with regards to her whip use on a horse out of contention.

COCHISE (M Coleman) – When questioned regarding the performance rider M Coleman advised that the gelding had failed to handle today's track conditions. Underwent a post-race veterinary examination which could not find any obvious abnormality.

Race 4 Celebrating Surely Sacred 1400

The start was delayed approximately 6 minutes due to **JUST KROOZIN** requiring farrier attention and then having to be re-saddled due to the breastplate being omitted.

Phillip Williams (JUST KROOZIN) – Fined \$100 by the Judicial Committee after failing to attach the breastplate when saddling JUST KROOZIN.

JUST KROOZIN (A Goindasamy) – Slow to begin. Trainer Phillip Williams was advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing again due to its uncompetitive nature.

MAC ATTACKA (S Collett) – Crowded shortly after the start having to be steadied.

BOOGIE EASY (D Danis) – Crowded shortly after the start having to be steadied.

SOCIALIGHTS (C Grylls) – Hampered and steadied passing the 1200 metres when crowded between FLUOROBUS which lay in when making the bend despite the efforts of its rider and SPOIL SPORT which was forced out slightly by HARBOURSIDE which had made the bend awkwardly with SPOIL SPORT also being hampered as a result.

SPOIL SPORT (R Smyth) – Crowded 1200 metres and hampered losing ground.

ANNIE OKAY (L Satherley) – When questioned regarding the improved performance Co-trainer S Clotworthy advised that at its most recent start at Waikato on 18 May 2019 the filly had not been suited by the sand kick back, further advising that today's track conditions had been beneficial.

Race 5 Celebrating Crown Prosecutor 1600

ANDOYAS (C Grylls) – Began awkwardly then crowded shortly after having to be steadied.

LUCKY SWEEP (T Thornton) – Raced keenly in the early and middle stages. When questioned regarding the performance Rider T Thornton advised that after leading in the early stages the gelding had been pressured through the middle stages which she believed had been detrimental to the gelding's chances, further advising that the addition of a tongue tie may benefit. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

VERRY FLASH (R Smyth) – Hampered approaching the 400 metres when attempting to improve to the outside of CRAFTY JESS (D Mansour) which shifted out slightly when making the bend. Rider D Mansour was advised to exercise greater care in a similar circumstance. Rider R Smyth reported that the gelding had not felt entirely comfortable

once asked for an effort in the final straight. Underwent a post-race veterinary examination which did not reveal any obvious abnormality.

Race 6 Thomsons Foodservice Cornwall Handicap (2200 metres)

ZACADA (J Riddell) - Began awkwardly.

THE HEIRESS (S Collett) – Began awkwardly then crowded shortly after.

L'ESCALIER ROSE (A Goindasamy) – Steadied passing the 800 metres when in restricted room after attempting to improve into a marginal run to the inside of YOUWANTMORE.

GOBSTOPPER (J Kamaruddin) – When questioned regarding the performance Apprentice Rider J Kamaruddin was unable to offer any excuse.

J Kamaruddin (GOBSTOPPER) – Issued with a warning for using his whip excessively on a runner out of contention.

ASSIGN (D Mansour) – Rider D Mansour advised that the gelding had felt disinterested, with the stable representative stating that the gelding is likely to be tried over fences at its next start.

AZABOY (K McCulloch) – Rider K McCulloch was of the opinion that the gelding may be better suited to racing in blinkers which had been removed for today's race.

Race 7 OMF 1400

THE POORMANZABEEL (V Colgan) – Late scratched at 3.45pm after refusing to load. Trainer C Cameron was advised that the gelding must barrier trial to the satisfaction of Stewards prior to racing again.

OBSESSIVE (M Coleman) – Began awkwardly then was crowded shortly after losing ground.

BREEZON (C Grylls) – Began awkwardly.

BLUETWENTYTWO (C Burdan) – Crowded shortly after the start having to be steadied.

BRUEGEL (J Riddell) - Slow to begin.

SWEET NINETEEN (S Collett) – Crowded passing the 1200 metres then hampered losing ground.

BR Jones (HAY TIGER) – Admitted a breach of careless riding in that he permitted HAY TIGER to shift in passing the 1200 metres when insufficiently clear of SWEET NINETEEN which was hampered losing ground with the Judicial Committee suspending his license to ride in races from the conclusion of racing on Saturday 8 June 2019 up to and including racing on Saturday 15 June 2019, 5 national riding days.

LADY SEQUOYAH (D Danis) – When questioned regarding the performance Rider D Danis advised that the mare had failed to handle the track conditions.

Race 8 Stella Artois 1600

PLEEZE BEE (C Burdan) – Slow to begin.

GLENDALOUGH (M Coleman) – Slow to begin. Raced keenly in the early to middle stages. Raced in restricted room over the concluding stages.

VAN DIAMOND (M Kareem) – Began awkwardly and shifted in making firm contact with FRIDAY WOOLFE.

LAGERTHA (J Kamaruddin) – Slow to begin.

FRIDAY WOOLFE (D Danis) – Hampered shortly after the start. When questioned regarding the improved performance, co-trainer P Williams advised that the filly had been better suited by today's 1600 metres after failing at her most recent start when stepping up to 2100 metres, 15 May at Whangarei.

TIPICAL (V Colgan) – Raced ungenerously when being steadied in the early stages.

THEE OLD COUGAR (C Grylls) – Briefly steadied 400 metres when in restricted room. When questioned regarding the performance, Rider C Grylls could offer no tangible excuse.

NULLI SECUNDUS (R Scott) – Commenced to race greenly when placed under pressure becoming awkwardly placed on heels near the 300 metres then raced in restricted room approaching the 200 metres and was briefly held up.

THE ICE KNIGHT (R Smyth) – Had some difficulty obtaining clear running in the final straight.
