Race 2 OPIHI RANGER – Late scratched vets advice 12.55pm.

RACE COMMENTS:

Race 1 MCKEOWN PETROLEUM MAIDEN 1200m

J Anderson (DIVINEXCUSE) – Was issued with a warning under Rule 638(1)(d) when allowing her mount to shift inwards passing the 1000 metres when not fully clear of EXCLAIM which had to be steadied away from heels.

LIAM (K Chowdhoory) – Hampered passing the 800 metres and had to be restrained off heels. Held up for some distance passing the 200 metres having to shift ground passing the 100 metres to find clear racing room.

ATAAHUADREAMSARFREE (BB Hong) - Raced 3 wide without cover throughout the event.

HAKA STAR (K Mudhoo) – Had to be steadied in the shadows of the post when EXCLAIM shifted in under pressure.

SHARP 'N' SILVER (J Lowry) – Fractious in barriers. Over raced for a distance passing the 800 metres and had to be continually steadied away from heels and in doing so shifted out and buffeted EXCLAIM who was also over racing and in restricted room to the inside of ATAAHUADREAMSARFREE. This resulted in the trailing LIAM and UNHINGED being hampered as a result and also having to be restrained.

ICEBREAKER (L Callaway) – Began awkwardly.

DECISION KEPT (C Barnes) – When questioned in regards to the performance rider C Barnes reported that the filly failed to respond when placed under pressure. Co-Trainer B Wilson advised Stewards that the filly will now be sent for a spell.

EXCLAIM (T Moseley) – Raced greenly early stages. Had to steady away from heels when over racing passing the 1000 metres. Continued to over race and passing the 800 metres was placed in restricted room and buffeted. Lost both hind shoes in the running.

UNHINGED (G Saejorhor) – Slow to begin. Hampered and had to be restrained off heels passing the 800 metres.

Race 2 COCHRANES FARM MACHINERY HCP 1400m

FINAL SAY (BB Hong) – Restrained to the rear after jumping. Held up early stages of the home straight and lay inwards passing the 250 metres.

A Bohorun (HE'S MI BROTHER) – Issued with a warning under Rule 638(3)(b)(ii) in that he used his whip excessively on his mount HE'S MI BROTHER prior to the 100 metres.

OPIHI RANGER (K Mudhoo) – Late scratched after becoming caste on the birdcage gate. Connection were advised a veterinary clearance will be required before racing next.

CARSON RIVER (K Chowdhoory) – Began awkwardly. Improved wide from the 600 metres.

WHACKOMACO (G Jogoo) – Late scratching due to transport difficulties when the float suffered a puncture.

Race 3 COUPLAND'S BAKERIES HCP 1400m

BB Hong (RED ROSE WARRIOR) - Admitted a breach of Rule 638(1)(d) in that he shifted inwards approaching the 200 metres when not clear of ZAKYNTHOS (K Chowdhoory) who was checked. The JCA imposed a suspension of his licence from the 8th January up to and including 16th January inclusive (6 riding days).

HOOFBEAT (A Bohorun) – Keen early stages. Rider dislodged post-race. Rider A Bohorun was checked by St. Johns ambulance staff and cleared to fulfil the remainder of his engagements.

ZAKYNTHOS (K Chowdhoory) – Fractious in his stall and began awkwardly after the rider had just remounted and only just regained his irons. Crowded and checked approaching the 200 metres.

HIGHLY XCITED (T Moseley) – Held up for the majority of the run home only gaining clear room inside the final 50 metres.

SPLENDIOR (C Campbell) – Placed in restricted room passing the 200 metres failing to gain clear racing room for the remainder of the straight and went to the line untested by its rider.

PERFIDIA (C Johnson) – Raced wide throughout.

STELLA DAZE (K Mudhoo) – Shifted out abruptly at the start and raced greenly in the early stages. Obliged to improve very wide around the final bend.

ZAYZAY (R Beeharry) – Steadied off heels passing the 400 metres. Was not afforded clear running for the majority of the straight.

Following the running of this race the connections of ZAKYNTHOS viewed replays of the start which showed that jockey K

Chowdhoory was only just had his feet back in the irons as the start was effected. Starter Mr R McAra was spoken to advisedly.

Race 4 OAMARU JOCKEY CLUB MAIDEN 1400m

JIMINY CRICKET (T Moseley) – Slow to begin. Steadied at the 1000 metres when racing keenly and on heels.

ACRE (J Anderson) – Raced wide throughout.

BILLABONG BILLY (K Mudhoo) – Trainer R McKay was fined \$150 under Rule 616(2) for failing to declare side winkers by the required time when presenting the gelding with the side winkers Mr McKay advised Stewards that the gelding had competed in all of its trials and work with side winkers on and fearing that the horse would race greenly without them.

EL CAMPEADOR (J Lowry) – Began awkwardly losing ground. Over raced through the early to middle stages.

RIDE THE STORM (K Chowdhoory) – Raced wide early. Contacted by CINNAMON KISS and unbalanced passing the 300 metres.

RIVALDO (L Callaway) – Crowded at the start losing ground.

HEY MICKEY (C Campbell) – Raced keenly early.

CINNAMON KISS (G Saejorhor) – Lay outwards at the 300 metres and made contact with RIDE THE STORM. Rider reported that the mare had made abnormal breathing noises during the event with a post-race veterinary examination revealing no abnormalities.

Race 5 COUPLAND'S WORKING DOG MAIDEN 1400m

ALL ABOUT ROY (L Callaway) – Raced wide early stages.

EL BEE JACK (K Mudhoo) – Slow to begin. Steadied short of the line when laying in across the heels of MOWENNA.

LUNAR LADY (K Chawdhoory) – Slow to begin. Improved wide from the 500 metres. When questioned in regards to the disappointing performance of this favoured runner, rider stated that in his opinion the mare may be feeling the effects of recent racing.

FIRESTARTER (C Barnes) - Slow to begin.

MOWENNA (E Wright) – Wide without cover through the early to middle stages. Lay inwards early in the run home and had to be straightened.

ABRAHAMS (C Johnson) – Over raced in the early stages.

BB Hong (RAFF) – Rider BB Hong was reminded of his obligations to ride his mount to the finish of the race when circumstances permit.

Race 6 PGG KUROW CUP 1400m

FIVE KINGS (R Beeharry) – Bounded at the start and then hampered by the rider less horse shortly after the start and got back.

HE KIN FLY (T Moseley) – Knuckled badly as the start was effected with the rider being dislodged. Rider T Moseley was attended to by St Johns ambulance staff and cleared to fulfil his remaining engagements.

WAIMATE BILL (A Bohorun) – Held up for several strides passing the 400 metres. Lay inwards early stages of the run home and had to be straightened.

STROWAN (C Johnson) – When questioned in regards to the performance of this favoured runner the rider advised that the gelding had been under pressure on the home turn and failed to respond to his urgings and had been disappointing.

Race 7 BENMORE MERINOS HANDICAP 1800m

SOUTHERN JAZZ (A Bohorun) - Wide early then restrained to the rear passing the 1300 metres getting its head up on a

number of occasions. When asked to comment about the performance rider could offer no tangible excuses.

TRANSCENDENT (T Moseley) – Slow to begin.

Race 8 COMMODORE HOTEL HANDICAP 1800m

LETSBRINGITON (C Barnes) – Crowded shortly after the start and lost ground. Lay inwards in the final straight and had to be straightened on a number of occasions having to be steadied off heels passing the 150 metres.

STELLACANTO (L Callaway) - Crowded at start and lost ground. Raced wide early stages.

RED RIVER ROCK (C Johnson) – Raced keenly through the early and middle stages.

BABAN (G Jogoo) – Began awkwardly and shifted in abruptly crowding STELLACANTO.

B Morgenrood (KEYBOARD WARRIOR) — Admitted a breach of Rule 610(2)(a) in that he rode in an unapproved body protector with the JCA fining him the sum of \$500.
