RACE COMMENTS:

Race 1 STELLA ARTOIS 1400 (1400metres)

SO GLORIOUS (W Pinn) - Began awkwardly.

ONE PRIZE ONE GOAL (L Hemi) – Raced keenly over the early stages.

KING KANE (D Turner) – When questioned into performance rider could offer no tangible excuse.

WISDOM PATCH (P Pilley) – Rider spoken to regarding the manner he used his whip early in the home straight.

Race 2 PHIL'S GARDEN 3YO 1200 (1200 metres)

CHALK (J Fawcett) - Slow away, raced greenly in the home straight.

VIGOR WINNER (T Harris) - Raced three wide on the pace throughout.

DUCK ROAD (D Turner) - Lay in near the 300 metres becoming awkwardly placed on the heels of FOGGY LYTTLE near the 200 metres before being angled outwards to improve.

SWEET ALIBI (M Singh) - Raced keenly for a short distance near the 700 metres, lay inwards early in the home straight having to be straightened.

PANGO (W Pinn) - When questioned into performance rider advised the gelding had raced greenly throughout. A post-race veterinary examination failed to reveal any abnormality.

Race 3 BEST TRAVEL 1100 (1100 metres)

ALMARIE (T Harris) – Began awkwardly and then tightened settling back.

MARIA DIOR (D Hirini) - Raced keenly in the early and middle stages.

CARILLION (H Durrant) - Made contact with the rail near the 600 metres.

MATT CAIN (J Fawcett) -Lay in under pressure in the home straight.

BITS AND PIECES (W Pinn) - When questioned into performance rider was of the opinion the mare may appreciate more rain affected going. A post-race veterinary examination failed to reveal any abnormality.

Race 4 JIMMY RURAL (2100 metres)

MOTIVATION (N Bakar) - Began awkwardly settling back, raced ungenerously in the early stages making the bend awkwardly near the 1700 metres.

KELIB (Z Moki) - Raced three wide without cover in the early and middle stages, tightened near the 450 metres when in restricted room.

CONSTANT BARRAGE (S O'Malley) - Briefly hampered by the tiring KELIB near the 600 metres.

Race 5 RUSSELL ROADS CITY OF HASTINGS CUP/FASTTRACK 5K (1300 metres)

BEEFEATER (Z Moki) - Underwent a pre-race veterinary inspection after kicking a rail in the parade ring and was cleared to start

YEARN (A Jones) - Raced without the off front plate.

HUGO THE BOSS (M Singh) - Began awkwardly settling back, before improving around the field to sit outside the leaders near the 600 metres.

SCANDALO (D Hirini) – Steadied off heels near 1100m. Hung rounding the final turn.

FLAMINGO (B Grylls) - Steadied near the 1100.

B GRYLLS (FLAMINGO) - Defended a breach of [Rule 636 (1)(b)] in that she failed to take all reasonable and permissible measures to allow her mount to finish in the best possible placing. After a Judicial hearing the charge was found proved and Miss Grylls had her licence to ride in races suspended from the conclusion of racing on 5th January, 2019 up to and including 2nd February (4 weeks)

ROCK MY SOUL (D Turner) D Turner was fined \$100 under the minor infringement scale after he was unable to make the carded weight and was replaced by S O'Malley on race morning.

Race 6 KAHUNGUNU KAPA (1600 metres)

SHE'S A RIPPER (M Singh) – Late scratched when dislodging the rider on the way to start and galloping for some distance. Rider M Singh was examined by St Johns and cleared to continue riding. Connections were advised the mare must trial prior to its next start.

AMORATA (D Turner) – Awkwardly away settling back.

ROLL THE GOLD (J Fawcett) - Raced keenly in the early stages having to be angled off heels near the 1300 metres, then raced ungenerously for a distance when being restrained, shifted out near the 550 metres making contact with AMORATA.

ANARCHY (W Pinn) - When questioned into performance rider could offer no tangible excuse. A post-race veterinary examination revealed an elevated temperature.

Race 7 NZB INSURANCE PEARL SERIES RACE (1400 metres)

LA SOEUR (A Jones) - Slow away.

HAVANA HEIGHTS (J Fawcett) - Raced keenly in the early stages when being restrained, disappointed for a run approaching the 200 metres when HONFLEUR shifted inwards bumping and unbalancing END OF STORY.

END OF STORY (M Singh) – Bumped and unbalanced near the 200 metres.

Race 8 ROGER RUSSELL/CHARLIE KEENEN MEMORIAL (1600 metres)

THE PUKETAPU LAD (L Satherley) - Jumped inwards losing ground.

ARCH RIVAL(S O'Malley) - Tightened at the start when RESURGENCE jumped outwards dictating RUN LEE, was not persevered with over the final stages when out of contention, rider advised the gelding had raced greenly throughout.

RESURGENCE (P Pilley) -Raced three wide without cover throughout.

CAMPING (D Bradley) - When questioned into performance rider advised the gelding never travelled comfortably during the running, not persevered with over the final stages when out of contention. A post-race veterinary examination revealed an elevated temperature.
