RACE COMMENTS:					
Race 1 VERMAIR RACING 2000					
ANICETA (S Collett) – Began awkwardly and was then steadied. Forced wider entering the final straight.					
<b>BUGS MORAN</b> (A Goindasamy) – Made the first bend awkwardly when being steadied and raced wide for a distance. Inconvenienced approaching the 100 metres when KONSTANTINA shifted out under pressure.					
<b>LAGERTHA</b> (M McNab) – Forced wider entering the final straight when MASTER PAINTON improved to the outside of JIMMY ROCKET which shifted out.					
<b>JIMMY ROCKET</b> (R Elliot) – Inconvenienced passing the 200 metres when BUGS MORAN (A Goindasamy) shifted out under pressure. A Goindasamy was advised to exercise care.					
AZABEAT (C Lammas) – Had some difficulty obtaining clear running early in the final straight.					
Race 2 NZB INSURANCE PEARL SERIES RACE					
VICHY (R Elliot) – Began awkwardly losing ground. Raced in restricted room to the outside of LADY BLUE which shifted out slightly when placed under pressure and SWINGING SKIRTS which lay in near the 250 metres, with VICHY then shifting out approaching the 150 metres to obtain clear running.					
SWINGING SKIRTS (L Satherley) – Slow to begin.					
<b>TAMING THE SHREW</b> (T Yanagida) – Inconvenienced approaching the 150 metres by VICHY (R Elliot) which shifted out to obtain clear running. R Elliot was advised to exercise care.					
LADY BLUE (M Cameron) – Lost the left hind plate during the running. Underwent a post-race veterinary examination which revealed the filly to be lame in the left foreleg. The connections were advised that a veterinary clearance would be required prior to racing next.					
Race 3 MAARA GRANGE REHABILITATION FACILITY 1400					
MAN POWER (J Fawcett) – Was a late scratching on veterinary advice at 1.24 pm after taking charge of its rider and galloping for a distance in its preliminary.					
ONLY THE BRAVE (M McNab) – Slow to begin. Hampered having to be steadied near the 1100 metres.					
AMEX (S Spratt) – Over-raced in the early and middle stages when racing wide without cover.					
SALTIRE (L Satherley) – Raced keenly in the early and middle stages.					
<b>PATCH MAN</b> (R Elliot) – Steadied when placed in restricted room when crossing on to the course proper near the 1200 metres when SHACKELTONS EDGE shifted out making contact, PATCH MAN then commenced to over-race for a distance. Crowded and checked passing the 1100 metres and shifted in forcing ZA ZA GABOR into the line of ONLY THE BRAVE which was hampered. Also inconvenienced as a result was VEE CECE.					
VEE CECE (M Cameron) – Inconvenienced near the 1100 metres.					

**O Bosson** (THE WHITE QUEEN) – Admitted a charge of careless riding in that he permitted his mount to shift in passing the 1100 metres when insufficiently clear of PATCH MAN which was checked. After hearing submissions the Judicial Committee suspended O Bosson's licence to ride in races from the conclusion of racing on 13 January up to and including racing on 20 January, 5 national riding days.

## Race 4 BROOKS RACING 1200

CHOULEE (A Goindasamy) – Was a late scratching at 1.48 pm on veterinary advice.

SHEEZNOTEASY (S Spratt) – Hampered leaving the barrier. Raced in restricted room over the concluding stages.

**REGAL ASSASSIN** (D Danis) – Hampered leaving the barrier. Raced three wide without cover throughout.

MR INCREDIBULL (S McKay) – Crowded leaving the barrier losing ground.

WAIWETU LASS (M McNab) – Began awkwardly then hampered losing ground.

**MANGAROA DIVA** (L Satherley) – Hampered passing the 300 metres when GOLDEN AGE shifted out to obtain clear running.

**GOLDEN AGE** (O Bosson) – When questioned regarding performance O Bosson advised that the gelding had raced greenly in the early stages, and in his opinion would benefit from the experience and a step-up in distance.

**O Bosson** (GOLDEN AGE) – Issued with a warning for permitting his mount to shift out when not sufficiently clear of MANGAROA DIVA which was hampered near the 300 metres.

### Race 5 KINGSCLERE STABLES 1100

**O Bosson** – Fined \$100 under the Minor Infringement Schedule after failing to make the weight for SIZZLER. O Bosson was replaced by M Coleman.

KEANO REEVES (S Collett) – Slow to begin.

TAKEMETOTHERIVER (L Satherley) – Raced wide without cover throughout.

CAITHNESS KID (S Spratt) – Had to be steadied passing the 750 metres after improving on to heels.

**SIZZLER** (M Coleman) – When questioned regarding performance M Coleman advised that the filly had raced greenly throughout and when presented with a run early in the final straight had been hesitant to take the gap.

#### Race 6 SPARTA RACING 1100

**ANYTHING BUT** (J Bayliss) – Declared a late scratching at 3.08 pm after becoming fractious in its barrier stall and rearing over. J Bayliss was attended to by ambulance personnel and cleared for his remaining rides. The connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

SHE'S OUR SASHA (M McNab) - Slow to begin. Inconvenienced near the 150 metres.

**FLYINGFLYNN** (S Spratt) – Steadied when placed in restricted room after SHE'S OUR SASHA was forced outwards by QUALITY PREVAILS which shifted out to obtain clear running approaching the 150 metres.

**QUALITY PREVAILS** (T Yanagida) – Held up early in the final straight having to shift ground outwards approaching the 150 metres to obtain clear running. T Yanagida was issued with a warning.

Race 7 BAKER RACING 1600

**HOT IN HIGH HEELS** (S Collett) – Slow to begin.

**TERRIFIQUE** (M Cameron) – Steadied when placed in restricted room to the inside of STACEY ANN (T Harris) which shifted in passing the 150 metres. T Harris was advised to exercise care.

**CLASSIC TOUCH** (M McNab) – Raced in restricted room momentarily approaching the 50 metres.

**STACEY ANN** (T Harris) – Lost the left hind plate during the running.

**MUTECHI** (J Bayliss) – When questioned regarding performance rider J Bayliss advised Stewards that the mare had not handled today's track conditions.

Race 8 PIKE RACING 2000

**STAGDO** (J Kam) – Jumped away awkwardly. Over-raced when the pace eased near the 1200 metres.

**SODA** (S Collett) – Jumped away awkwardly. Over-raced when the pace eased near the 1200 metres.

**TUPS** (J Bayliss) – Slow to begin.

**TEEN TITAN** (R Elliot) – Made the first bend awkwardly laying out.

MOIRAS TOWN (R Smyth) - Steadied when placed in restricted room near the 1700 metres.

BARZELLAR (T Yanagida) – Steadied when placed in restricted room near the 1700 metres.

**OUR BEESKEES** (O Bosson) – Over-raced when the pace eased near the 1200 metres. Denied a marginal run passing the 100 metres between SODA which shifted out slightly and TRUMPET which shifted in. OUR BEESKEES then went to the line untested.

**KANUMISS** (M Cameron) – Over-raced when the pace eased near the 1200 metres.

J Kam (STAGDO) – Issued with a warning for unnecessary use of whip on a runner that is out of contention.

**D** Danis (SURE HE CAN) – Issued with a warning for allowing his mount to shift in when not sufficiently clear of KANUMISS which was forced in placing BARZELLAR and MOIRAS TOWN in restricted room near the 1700 metres.

**S McKay** (WHEAO) – Reminded of his obligation regarding the manner in which he eased the pace for a distance shortly after entering the back straight placing the riders behind in some difficulty.

**R Elliot** (TEEN TITAN) – Reminded of his obligation regarding the manner in which he eased the pace for a distance shortly after entering the back straight placing the riders behind in some difficulty.
