<b>Race 1</b>	<b>FEILDING HOTEL 1400 (1400 Metres)</b>
<b>SECRET ALLURE</b> (J Parkes) – Awkwardly away settling back.	
<b>PIECE OF KATE</b> (C Johnson) - Tightened at start settling back.	
<b>JESSIEGEE</b> (D Hirini) - Held up for a short distance near the 400 metres.	

**HANDFULL** (S O'Malley) - When questioned into performance rider advised the gelding had felt reluctant to hit out. A subsequent veterinary inspection revealed a respiratory noise and elevated heart rate.

**SHADOW DANCER** (D Johnson) – When questioned into performance rider advised the mare had been disappointing and had no excuse.

Track downgraded to Dead 6 retrospective to Race 1.

**DEUCE COUP** (M Singh) - Bounded at the start settling back.

**THAT'S FUNNY** (L Hemi) – Slow away.

**EXHIBIT** (C Johnson) - Raced keenly in the early to middle stages

**DESTINY ONE** (L Allpress) – Shifted out abruptly shortly after the start then raced wide without cover throughout.

**ONE PRIZE ONE GOAL** (R Myers) – Raced keenly in the early to middle stages then shifted out near the 600 metres when being restrained, contacting LADY STYLE. Held up rounding the home turn.

**LADY STYLE** (W Pinn) – Raced keenly in the early staged. Contacted 600 metres.

**LINCOLN STAR** (T Johnson) - Held up approaching the 400 metres and when attempting a narrow run to the outside of MISS DOHERTY made contact with BATTLE CREEK, briefly unbalancing both runners.

**BATTLE CREEK** (C O'Beirne) –Briefly unbalanced 400 metres.

**MISS DOHERTY** (D Johnson) - Lay out under pressure in the final straight.

**PLATINUM WILD CARD** (J Riddell) – Raced ungenerously when being restrained in the early stages. When questioned into performance rider advised the gelding should take natural improvement from the race.

Track further downgraded to Slow (7) following Race 2

**PLATINUM VOLOS** (J Riddell) - Stood in the barriers at the start and refused to leave taking no part in the race. Connections were advised the gelding must trial on multiple occasions to the satisfaction of stewards prior to starting next. Connections advised they would be giving the gelding's racing future consideration.

**MISS CONTESSA** (M Singh) - Held up near the 500 metres gaining clear running entering the home straight.

<b>Race 4</b>	<b>POWER FARMING/OFFICE PRODUCTS DEPOT 1550 (1550 Metres)</b>

**KING COUGAR** (S O'Malley) – Began awkwardly. Lay out under pressure in the home straight.

**MISS MOO** (R Hannam) – Slow away.

**ANDOYAS** (L Allpress) – Slow away.

**PETITE EN JEU** (L Hemi) – Raced keenly in the early stages. Held up from the 400 metres having to be angled inwards to gain clear running early in the home straight.

**SLIMLINE** (C O'Beirne) – Ran up on to heels having to be restrained near the 800 metres. Held up near the 500 metres having to be angled outwards across heels to improve approaching the 200 metres.

**HUNTA PENCE** (W Pinn) - Ran up on to the heels of STRADIVARIUS near the 200 metres.

**STRADIVARIUS** (D Johnson) - Rider advised the gelding may be feeling the effects of recent racing.

**MAUNA KEA** (D Turner) - Raced wide without cover throughout.

**DETENTORE** (J Parkes) - J Parkes was of the opinion the gelding is better placed when leading but when racing greenly, was unable to obtain the lead on this occasion.

**CAFE CULTURE** (R Jones) – Bled. As this is the second occasion CAFÉ CULTURE has bled the gelding is no longer eligible to race in New Zealand and is retired.

**ROCK ON** (R Hannam) - Slow away.

**HENI** (D Hirini) - Awkwardly away settling back. Raced keenly in the early and middle stages. Held up approaching the 500 metres

**SHADOWS CAST** (L Allpress) - Bounded at the start settling back. Restrained off the heels of SCANDALO near the 700 metres and when doing so shifted out hampering ART DECO.

**ART DECO** (W Pinn) – Hampered 700 metres.

**SCANDALO** (C Johnson) – Raced three wide without cover throughout.

<b>Race 6</b>	<b>RATANUI DEVELOPMENT COMPANY 2100 (2100 Metres)</b>

**VERACIOUS** (M Singh) - Awkwardly away settling back.

**OBRIGADO** (J Riddell) – Raced keenly early. Held up behind the tiring CENTRE ATTENTION approaching the 500 metres having to be angled outwards across heels early in the home straight to gain clear running.

**R Hannam** (CAPE DU JEU) admitted a breach of Rule 638(1)(d) after allowing his mount to shift inwards shortly after the start when not sufficiently clear of ALL BLACK MAGIC which was checked near the 2000 metres. After hearing submissions R Hannam had his licence to ride in races suspended from the conclusion of racing on Thursday, 15 November 2018 up to and including racing on Friday, 23 November 2018 (6 days).

**ALL BLACK MAGIC** (J Parkes) – Checked near 2000 metres. When questioned into performance rider could offer no excuse. A subsequent veterinary inspection was clear.

**FIVE TO MIDNIGHT** (J Parkes) – Began awkwardly. Briefly held up approaching the 400 metres.

**STROLLING VAGABOND** (M Singh) – Slow away.

**RAYAS** (C Johnson) - Raced keenly throughout.

**NYMPH MONTE** (W Pinn) - Obligated to improve very wide rounding the turn.

<b>Race 8</b>	<b>IAN HUMPHREY MOTORS &amp; HUMPHREY FAMILY 1550 (1550 Metres)</b>
<p>Stewards were advised at 12.14pm that <b>ARIDITY</b> had got down on the float and was subsequently scratched. Connections were advised that a veterinary clearance is required.</p> <p><b>MASTER LINCOLN</b> (T Johnson) – Slow away.</p> <p><b>CYCLOPS</b> (L Allpress) – Raced keenly when wide in the early stages.</p> <p><b>KIT KAT</b> (D Turner) - Held up for a short distance near the 450 metres.</p> <p><b>PERCY’S GEM</b> (J Riddell) – Raced in restricted room for a distance near the 300 metres.</p> <p><b>DIAMOND DANCER</b> (R Myers) - Rider advised the mare may not have appreciated today’s rain-affected track conditions.</p> <p><b>ROSETTA</b> (W Pinn) – Tightened and steadied when attempting a marginal run to the inside of <b>DIAMOND DANCER</b> passing the 400 metres.</p>
