Late Scratchings: Race 10 DARCI MAC at 8.20 am on veterinary advice

GENERAL:

Rider **T Jonker** advised Stewards at 1.00 pm that she was feeling unwell, suffering the effects of wasting, and accordingly she was replaced on her riding engagements in races 7 and 9. T Jonker was advised she must provide Stewards with a medical certificate prior to riding next.

RACE COMMENTS:

Race 1	RICCARTON PARK FUNCTION CENTRE MAIDEN HURDLE (3100m)
KEYBOARD WARF	RIOR (B Lammas) - Slow to begin.

WENTWORTH (L Douglas) - Raced keenly while leading in the early stages, put in a poor jump at the fence near the 1950 metres, badly misjudged the fence passing the 1200 metres and blundered on landing then commencing to give ground, eased down after jumping the fence at the 800 metres being retired from the race. Co-trainer L Callaway advised that the gelding would be retired from their stable.

REVOLUTION (A Kuru) - Raced keenly through the early and middle stages.

SHEEZOFF (M Gibbs-Manssen) - Mixed its jumping throughout, put in a poor jump at the second last fence.

JAYLA MONET (M Cropp) - Put in a poor jump at the second last fence.

TITTLETATTLE (J Seivwright) - Put in a faulty jump at the second last fence and fell. J Seivwright was attended to by St John Ambulance personnel and stood down from his remaining rides with a collarbone injury. TITTLETATTLE underwent a post-race veterinary inspection including an endoscopic examination which did not reveal any obvious abnormality.

Race 2 CLASSIC VILLA RATING 82 (1500m)

TABARD (R Myers) - Restrained when jumping from the outside barrier.

PLATINUM COMMAND (K Asano) - Raced wide without cover throughout.

MONZA CIRCUITO (R Mudhoo) - Firmly restrained to avoid heels when over racing passing the 1000 metres after the pace eased.

BAKELA (B Murray) - Held up rounding the final turn until near the 300 metres.

Race 3 RACECOURSE HOTEL & MOTOR LODGE STEEPLECHASE (3200m)

MR INK (M Cropp) - Began awkwardly losing ground, got its head up on a number of occasions when over racing in the early stages, mixed its jumping throughout.

INFOXICATED (L Douglas) - Misjudged the first fence of the double near the 1200 metres.

EION (B Lammas) - Misjudged the last fence landing awkwardly unbalancing the rider for a short distance.

OOEE (A Kuru) - Put in a poor jump at the final fence.

WHO CAN TELL (K Veenendaal) - When questioned regarding performance the rider could offer no tangible excuse.

TELL ME MORE (S Fannin) - Required veterinary treatment post-race after the gelding was found to be lame in the right foreleg suffering a tendon injury. The connections were advised that a veterinary certificate of fitness will be required prior to racing again.

Race 4 NZB INSURANCE RATING 82 (2000m)

ALBUT ME (S Toolooa) - Slow to begin before being allowed to improve forward to lead passing the 1700 metres. When questioned regarding performance rider reported that the gelding was not suited to the holding nature of today's track.

PLATINUM RAPPER (K Asano) - Went off-stride near the 1600 metres.

SMILING ASSASSIN (L Allpress) - When questioned regarding performance the rider could offer no tangible excuse.

STRAD (J Lowry) - Rider reported in his opinion the gelding may be feeling the effects of recent racing.

Race 5 NAUTICAL BOAT INSURANCE GRAND NATIONAL AMATEUR CHAMPIONSHIP (1800m)

SIR RITCHIE (S MacNab) - Began awkwardly getting back as a result, raced keenly in the middle stages and had to be firmly restrained near the 800 metres when placed in restricted room to the inside of NATHAN DETROIT which shifted inwards to avoid the heels of KARM 'N' EASY which was being steadied.

MADAM DE SOIR (J McMath) - Began awkwardly losing ground.

RED MAJOR (C Orange) - Raced wide throughout, inconvenienced passing the 500 metres.

RICH HABIT (N Brown) - Raced wide throughout, lay in passing the 500 metres inconveniencing RED MAJOR.

NATHAN DETROIT (M Dunne) - Lay in away from RED MAJOR near the 300 metres and then clipped a heel of MRS GEE EYE and blundered, shifted out under pressure passing the 50 metres.

GLOSS (M Gestain) - Saddle shifted forward in the early stages placing the rider at a disadvantage for the remainder of the race.

D Frye (MRS GEE EYE) - Admitted a charge of excessive use of the whip prior to the 100 metres, with the Judicial Committee imposing a fine of \$250.

Race 6 ELMWOOD TRADING CO MAIDEN (1600m)

AJAY LINCOLN (R Hannam) - Began awkwardly making contact with FIGEAMEOUT losing ground as a result.

CEE SHARP (S Weatherley) - Slow to begin, contacted approaching the 400 metres when AJAY LINCOLN shifted out.

BROTHER WILL (S Toolooa) - Raced wide without cover throughout.

K Asano (POP DIVA) - Issued with a warning after permitting his mount to shift inwards passing the 1200 metres when not sufficiently clear of DIPLOMAT which had to be steadied.

DIPLOMAT (J Lowry) - Steadied to avoid heels passing the 1200 metres.

BEAUDEN BEE (K Chowdhoory) - Raced ungenerously shifting away from DONNATINA near the 450 metres.

J Lowry (DIPLOMAT) - Issued with a warning after permitting his mount to shift outwards near the 350 metres crowding ZANTE onto FIGEAMEOUT

ZANTE (S Collett) - Crowded 350 metres.

FIGEAMEOUT (T Moseley) - Bumped at the 350 metres.

Race 7 MCMILLAN EQUINE MAIDEN (1200m)

HEARTOHEART (L Allpress) - Blundered leaving the barriers.

VERSES (C Campbell) - Began awkwardly losing ground.

FAUX PAS (T Moseley) - Crowded at the start losing ground.

ARNAGE (K Asano) - Crowded at the start.

SHE'LL CAT CHOUX (R Elliot) - When questioned regarding performance the rider was unable to offer any excuse. A post race veterinary inspection did not reveal any obvious abnormality.

Race 8 HOSPITALITY NEW ZEALAND CANTERBURY 130TH GRAND NATIONAL HURDLES (4200m)

BAD BOY BROWN (I Lupton) - Got its head up on a number of occasions when over racing in the early stages.

NO CHANGE (A Kuru) - Jumped the first fence awkwardly, put in a hesitant jump at the fence near the 1900 metres, retired from the race prior to jumping the fence at the 800 metres when well beaten after mixing its jumping throughout.

EL DISPARO (S Phelan) - Made a poor jump at the fence passing the 3000 metres, put in a poor jump at the third last fence and was then retired from the race.

ALFIE DEE (B Lammas) - Hit the fence near the 150 metres on the first occasion, hit the final fence.

ADEQUACY (M Cropp) - Retired from the race after jumping the fence passing the 1200 metres. ADEQUACY was immediately attended to by the course veterinarian and found to have suffered a tendon injury to the left foreleg, with a veterinary certificate of fitness now required prior to racing again.

LAEKEEPER (E Farr) - Rider became unbalanced after jumping the fence near the 800 metres and was dislodged. E Farr was uninjured.

ADDITUP (S Higgins) - Made a poor jump at the third last fence.

GUY FOX (K Veenendaal) - Inconvenienced by the riderless horse passing the 500 metres.

Race 9 HOTELIERS CHALLENGE MAIDEN (2000m)

The start was delayed due to the two D Crozier stable runners being incorrectly saddled. **D Crozier** was charged with a breach of Rule 614(2) in that he had been neglectful in saddling these two runners. D Crozier was further charged with a breach of Rule 656(5)(b) after producing a breath alcohol result in excess of the allowed level. Both charges were adjourned to be heard at Riccarton Racecourse prior to Race 1 on Saturday 10 August.

TRICKY MICKEY (J Laking) - Reared at the start with the rider striking his head on the top of the barriers and TRICKY MICKEY losing ground. The gelding underwent a post-race veterinary inspection following its poor performance which was clear.

BARZELLAR (S Collett) - Raced wide without cover throughout.

BAHHGOOFY (BB Hong) - Over raced in the middle stages having to be firmly restrained near the 1200 metres when becoming awkwardly placed near the heels of STEELE CANYON.

SPECTRA (C Johnson) - Over raced for a distance passing the 1200 metres when the pace steadied.

INTERLLECTUS (K Asano) - Had to be firmly restrained to avoid heels near the 1000 metres when the pace steadied.

DIVINEXCUSE (K Williams) - Steadied when crowded rounding the final turn near the 450 metres when racing to the outside of LAST LETTER which was taken out by RED MAGICIAN which lay out.

RED MAGICIAN (S Weatherley) - Lay out rounding the final turn.

LAST LETTER (C Campbell) - Crowded to the outside of RED MAGICIAN which lay out near the 450 metres, then checked to avoid the heels of RAISE YOU FIVE (J Lowry) near the 375 metres. In this incident LAST LETTER was taken out by SPECTRA (C Johnson) which was improving into a marginal run to the outside of RED MAGICIAN which was continuing to lay outwards. Contributing was some inward movement from RAISE YOU FIVE when struck with the whip. Taking into account the contributing factors, C Johnson and J Lowry were both advised to exercise care.

Race 10 LINDAUER RATING 82 (1200m)

The start was delayed over 3 minutes due to **PLATINUM VOLOS** proving very difficult to load. The connections were advised that the gelding would be placed on a barrier manners warning.

PADDY BOURKE (L Allpress) - Raced keenly in the early and middle stages.

S Weatherley (TURNCOAT) - Charged with using his whip excessively prior to the 100 metres, with the matter adjourned until Saturday 10 August due to S Weatherley having left the course to catch a flight.
