<b>Race 7 - RSA TAUMARUNUI GOLD CUP (2200 metres)</b>
<b>KAHARAU</b> (V Colgan) – Trainer K Rae advised Stewards that the gelding underwent blood tests following this race which revealed a minor infection, further advising that KAHARAU has since received treatment for the infection and it is his intention to freshen the gelding prior to racing next.

**Race 3 - MCMAHON LIVESTOCK HANDICAP (1600 Metres)**

**ATLANTA PEACH** (R Myers) – Trainer G Cullen advised Stewards that in the days following this race it became apparent that the mare was suffering from boils which have since been treated, further advising that blood tests had been taken which did not reveal any abnormality and it is their intention to continue on with its current preparation.

<p><b>NUCLEAR FUSION</b> (S Spratt) - Made the bend awkwardly approaching the 800 metres.</p> <p><b>THE GOOD FIGHT</b> (T Yanagida) - Raced in restricted room shortly after the start losing ground. Made brief contact with <b>VIKTOR VEGAS</b> near the 75 metres when both runners shifted ground.</p> <p><b>VIKTOR VEGAS</b> (M Cameron) – Briefly unbalanced when making contact 75 metres.</p>	
<b>Race 2</b>	<b>WIN THE GROUP 2 WAIKATO GUINEAS 1100</b>
<p><b>THAT'S LIFE</b> (S Spratt) - Began awkwardly then placed in restricted room shortly after having to be steadied.</p> <p><b>MASCARPONE</b> (M Cameron) – Made the bend awkwardly approaching the 400 metres and shifted out abruptly hampering <b>CURVE</b> which was forced wider.</p> <p><b>CURVE</b> (S Johnson) - Hampered when forced wider approaching the 400 metres.</p>	
<b>Race 3</b>	<b>U S NAVY FLAG FOXBRIDGE PLATE 17 AUGUST 1200</b>
<p><b>COMEBACK</b> (J Kam) - Began awkwardly.</p> <p><b>BATTLE TIME</b> (C Burdan) - Began awkwardly losing ground.</p> <p><b>OTTAVIO</b> (T Thornton) – Raced in restricted room passing the 1000 metres to the inside of <b>RESURRECT</b> (E McCall) which lay in. Apprentice E McCall was advised to exercise care in a similar circumstance.</p>	
<b>Race 4</b>	<b>LODGE REAL ESTATE 1600</b>
<p><b>ROCKWITHATTITUDE</b> (D Danis) - Raced in restricted room passing the 1300 metres to the inside of <b>BEAUTY STAR</b> (M McNab) shifted in with <b>ROCKWITHATTITUDE</b> then commencing to race ungenerously when being steadied losing ground and hampering <b>DRAKE BAY</b> and <b>TWO OF US</b>.</p> <p><b>M McNab</b> (<b>BEAUTY STAR</b>) - Issued with a warning after permitting <b>BEAUTY STAR</b> to shift in passing the 1300 metres when insufficiently clear of <b>ROCKWITHATTITUDE</b> which was crowded and steadied.</p> <p><b>DRAKE BAY</b> (V Colgan) – Over-raced in the early stages and was further hampered passing the 1300 metres when awkwardly placed losing ground.</p> <p><b>JONNY RUSS</b> (L Satherley) - Began awkwardly. Hampered approaching the 400 metres by <b>MALIBU MAGIC</b> (A Goindasamy) which shifted out to obtain clear running. Inconvenienced as a result was <b>BEAUTY STAR</b>.</p> <p><b>A Goindasamy</b> (<b>MALIBU MAGIC</b>) – Issued with a warning after permitting <b>MALIBU MAGIC</b> to shift out approaching the 400 metres when insufficiently clear of <b>JONNY RUSS</b> which was hampered.</p>	

**BEAUTY STAR** (M McNab) – Inconvenienced approaching the 400 metres and forced wider.

**TWO OF US** (C Dell) - Hampered 1300 metres.

**AMARED ROSE** (S Spratt) – When questioned regarding the performance Rider S Spratt could offer no tangible excuse.

**BIG BEN** (J Baillie) - Raced in restricted room 1200 metres.

**PADRAIG** (M Cameron) – Inconvenienced 850 metres when in restricted room.

**DEEJAY MAC** (A Goindasamy) - Held up for a distance passing the 600 metres then shifting out to obtain clear running.

**J Baillie** (BIG BEN) – Issued with a warning for using his whip excessively prior to the 100 metres.

**TWEEDLEDEE** (T Yanagida) - Inconvenienced 125 metres.

<b>Race 6</b>	<b>ALLIED SECURITY 2100</b>

**THE HEIRESS** (M Cameron) – Slow to begin (3L).

**BEE TEE JUNIOR** (Y Chew) - Raced wide without cover throughout. Apprentice Rider Y Chew was spoken to in the presence of riding master N Harris after covering excessive ground through the early and middle stages.

**CHARLIE HORSE** (D Turner) - Raced keenly in the early and middle stages.

**FRANCIS DRAKE** (J Kam) - Raced ungenerously in the early stages.

**ANDOYAS** (D Danis) – When questioned regarding the performance of ANDOYAS Apprentice Rider D Danis advised that in his opinion the gelding had failed to see out the distance of 2100 metres.

<b>Race 7</b>	<b>BCD GROUP 2100</b>

**SCAGLIONI** (R Smyth) - Began awkwardly losing ground.

**POP ‘N’ ROCK** (A Calder) – Raced in restricted room shortly after the start. Hampered 1500 metres.

**EPAE ROAD** (S Spratt) - Raced in restricted room shortly after the start. Hampered 1500 metres.

**LADY AZAMOUR** (M Coleman) - Raced in restricted room shortly after the start. Hampered 1500 metres.

**KOKANEE GOLD** (E McCall) – Crowded soon after leaving the barriers and steadied.

**MISTER GERONIMO** (T Thornton) - Crowded 1500 metres clipping a heel and dislodging Rider T Thornton who was stood down by the course doctor. Rider T Thornton is to provide a medical clearance prior to riding next. Hampered as a result was LADY AZAMOUR, CENTURY MISS, POP ‘N’ ROCK, EPAE ROAD, THE MIDNIGHT SHIFT and PIERIAN SPRING.

**CENTURY MISS** (M Cameron) - Hampered 1500 metres.

**THE MIDNIGHT SHIFT** (L Satherley) – Hampered 1500 metres.

**PIERIAN SPRING** (C Lammas) – Hampered 1500 metres.

**A Jones** FREEWHEELER – Admitted a charge of careless riding in that she permitted FREEWHEELER to shift out near the 1500 metres when not sufficiently clear of MISTER GERONIMO which clipped a heel and blundered dislodging its rider. After considering submissions the Judicial Committee suspended A Jones’s licence to ride in races from the conclusion of racing on Saturday 10 August, until the conclusion of racing on Saturday 7 September, 4 weeks.

<b>Race 8</b>	<b>SVS 1200</b>

**TERRITORY** (V Colgan) – Crowded shortly after the start losing ground. Crowded 900 metres and hampered.

**NICE SHOT** (D Danis) - Began awkwardly then crowded shortly after the start losing ground.

**FAST AND FURIOUS** (L Satherley) – Began awkwardly.

**PERSWAYED** (C Burdan) – Began awkwardly making contact and then became unbalanced losing ground.

**NASHA RIVA** (A Goindasamy) - Crowded passing the 900 metres by TIN SOLDIER which lay out when making the bend with NASHA RIVA making contact with MRS RUMBLE which became unbalanced.

**MRS RUMBLE** (S Spratt) – Contact 900 metres becoming unbalanced.

**AERO DE PARIS** (C Grylls) – Over-raced when being steadied approaching the 900 metres shifting out and making contact with TERRITORY which was hampered losing ground. Held up passing the 200 metres when improving onto the heels of LOCK IT IN. AERO DE PARIS then steadied and shifted out to obtain clear running passing the 150 metres.

Following the race, the connections of the 2<sup>nd</sup> placed horse **AERO DE PARIS** wished to view Steward’s footage alleging interference by the 1<sup>st</sup> placed horse **WISDOM PATCH** near the 200 metres, electing not to proceed with the protest.
