Raced wide without cover.</p> <p><b>SACRED LAE</b> (S Collett) – Raced greenly when linking on to the Course Proper near the 800 metres.</p> <p><b>THE BUFFER</b> (R Smyth) – Raced wide without cover.</p> <p><b>POWER OF HOPE</b> (J Fawcett) – Had some difficulty obtaining clear running early in the final straight.</p> <p><b>S Weatherley</b> (GIGOLO GEORGE) - S Weatherley was spoken to with regard to his use of his whip on a runner out of contention.</p>   |   |

| <p><b>DROPS OF JUPITER</b> (J Riddell) – Slow to begin.</p> <p><b>SHARED DREAM</b> (S McKay) – Slow to begin.</p> <p><b>PAX VOBISCUM</b> (C Dell) – Slow to begin. Improved on to heels near the 800 metres and shifted out hampering EACH WAY.</p> <p><b>EACH WAY</b> (L Satherley) – Began awkwardly. Hampered and forced wider near the 800 metres.</p> <p><b>VALHEXA</b> (J Fawcett) – Steadied when placed in restricted near the 700 metres to the inside of DROPS OF JUPITER (J Riddell) which shifted in to avoid the heels of SWEET SEREIA with VALHEXA losing ground as result. J Riddell was advised to exercise care in a similar circumstance.</p> <p><b>SWEET SEREIA</b> (C Grylls) – Crowded and steadied near the 350 metres then inconvenienced near the 250 metres and was briefly steadied.</p> <p><b>GLOBAL DIAMOND</b> (S Johnson) – Steadied when placed in restricted room to the outside of EACH WAY (L Satherley) which shifted out near the 250 metres. L Satherley was advised to exercise care.</p> <p><b>J Riddell</b> – Admitted a charge in that he angled his mount DROPS OF JUPITER out when insufficiently clear of SWEET SEREIA which was crowded and steadied near the 350 metres with the Judicial Committee imposing a suspension on his licence from the conclusion of racing on 14 August up to and including racing on 30 August, 8 national riding days.</p> <p><b>M Cameron</b> – Issued with a warning for allowing his mount ANJAMEME to shift out when not sufficiently clear of SWEET SEREIA which was inconvenienced, having to be steadied near the 250 metres.</p> |   |

**BILLY THE KID** (S Weatherley) – Crowded when leaving the barriers then raced in restricted room for a distance having to steady.

**KEANO REEVES** (L Satherley) – Crowded and steadied approaching the 1100 metres. Made the bend awkwardly near the 800 metres running wide. Hampered near the 400 metres.

**ROMANTIC LADY** (A Calder) – Raced in restricted room passing the 1100 metres. Raced three wide without cover.

**SWEET PAINTED LADY** (S Collett) – Raced wide without cover throughout.

**DAISY GREY** (S McKay) – Made the bend near the 900 metres awkwardly running wide and then raced wide without cover for the remainder of the race.

**HOPEFUL** (S Spratt) – Crowded near the 300 metres when weakening.

**WHATSITALLABOUT** (C Dell) – Inconvenienced when crowded passing the 200 metres by FORGETZ (D Danis) which shifted out under pressure. Apprentice Rider D Danis was advised to exercise greater care in a similar circumstance.

**FORGETZ** (D Danis) – Lay out when placed under pressure passing the 200 metres hampering WHATSITALLABOUT.

**C Dell** (WHATSITALLABOUT) – Issued with a warning for allowing his mount to shift out near the 400 metres when not sufficiently clear of KEANO REEVES which was hampered.

**A Goindasamy** (TUMBLEWEED) – Issued with a warning in that he permitted TUMBLEWOOD to shift in approaching the 1100 metres when insufficiently clear of KEANO REEVES which was crowded and steadied.
