ĺ	Race 1	ROSSER UNDERWRITING AND LSJ 3000m		
	The start of this race was delayed approximately two minutes while an outside rail was replaced.			

**HEAVENLY GOLD (T Johnson)** – Slow to begin (10L). Jumped the first fence awkwardly unbalancing the rider and continued to jump indifferently in the early stages. Dislodged its rider after jumping the fence near the 600 metres when well beaten. Connections were advised that a warning has been placed against the mare's barrier manners. T Johnson was cleared by St John Paramedics, HEAVENLY GOLD underwent a posy-race veterinary inspection and was cleared of any injury.

AVE MARIA (K Veenendaal) – Landed awkwardly at the fence near the 1,800 metres.

MR DAVINCI (G Walsh) – Retired from the race prior to jumping the fence prior to the 600 metres.

KION (S Fannin) – Retired from the race prior to jumping the second last fence.

**STARBRO (L Douglas)** – Retired from the race prior to jumping the second last fence.

ZARTAN (M Cropp) - Hit the final fence losing momentum.

**T Johnson** - Was reminded of his obligations in relation to retiring his mount from the race when out of contention.

L Douglas - Was reminded of his obligations in relation to retiring his mount from the race when out of contention.Race 2PROPERTY BROKERS COMPLIANCE LTD 3000m

KANGAROO (T Moki) – Raced without ear covers after damaging them prior to the race.

**READY EDDIE (H McNeill)** - Slow to begin (3L).

**HERE'S TROUBLE (B Thomas-Rantall)** - Retired from the race prior to jumping the final three fences. Underwent a postrace veterinary examination which deemed the gelding to have bled. Given this is the gelding's second nasal bleed **HERE'S TROUBLE** is now ineligible to start in any race in New Zealand.

**ZENTANGLE (R Elliot)** - Hit the fence near the 1100 metres unbalancing its rider.

**COOL HAND DUKE (A Kuru)** - Had a poor jump near the 600 metres losing ground. Misjudged the fence near the 1,100 metres.

**TITTLETATTLE (E Farr)** - Got in close to the final fence landing awkwardly.

**R Elliot** - Was issued with a warning under Rule 638 (3) (b) (ii) regarding the manner in which he used his whip over the final stages.

Race 3 SPOONERS DRY CLEANERS MDN STPL 3800m

**KIRKENES (E Farr)** – Got in close to the fence at the 2,600 metres losing ground. Retired from the race prior to the fence near the 600 metres. When questioned into performance the rider advised the gelding had traveled keenly but had been disappointing. A subsequent veterinary inspection was clear.

**POROTENE MAGNUM (L Douglas)** – Made contact with **BREKY AT TIFFANYS** jumping the first fence becoming unbalanced on landing losing ground, then hit the second fence and raced keenly for a short distance. Jumped high at the fence near the 2,200 metres. Retired from the race after jumping the fence near the 1,350 metres.

**BREKY AT TIFFANYS (B Lammas)** - Contacted at the first fence. Retired from the race prior to the final round when out of contention.

**MRS TWINKLETOES (M Gillies)** – Hit the fence and blundered on landing at the fence near the 2,200 metres. Put in a poor jump at the final fence.

**MESMERIZE (I Lupton)** – When questioned into the performance rider advised the gelding may be feeling the effects of recent racing.

**EDDIE GILBERT (B Thomas-Rantall)** – Retired from the race prior to the second last fence.

**MANHATTAN STREET (S Fannin)** – Retired from the race prior to the second last fence.

**MY MAGICIAN (M Cropp)** - Retired from the race approaching the fence near the 1,350 metres.

MANDALAY (A Kuru) - Lost the off-fore plate in the running.

Race 4 JOLT COFFEE HOUSE WANGANUI STEEPLECHASE 4100m

**COCONUT (M Gillies)** – When questioned into the performance rider could offer no excuse. A subsequent veterinary inspection was clear.

WISE MEN SAY (I Lupton) - Got in close to the fence near the 200 metres losing ground.

**CRASH BANDICOOT (K Veenendaal)** - Misjudged the fence near the 600 metres losing ground.

**THE OYSTERMAN (T Johnson)** - Was retired from the race prior to the second last fence.

**INFOXICATED (L Douglas)** – Was retired from the race prior to the second last fence.

Race 5 EZI-FINANCE 1200m

QUEEN OF VENLO (B Ansell) - Contacted after jumping out of the barrier losing ground.

BUBBLE GUM (R Myers) - Slow to begin.

**MAGNESS (L Allpress)** – Slow away. Rider reported the saddle slipped during the running placing her at a disadvantage.

**M Singh (COOGA DOON)** - Issued with a warning under Rule 638(1)(d) after angling his mount out when entering the home straight when not entirely clear of MODRIC which was inconvenienced.

MODRIC (C Grylls) – Inconvenienced 350 metres.

**C Johnson (REGAL REWARD)** - Issued with a warning under Rule 638 (1) (d) after allowing his mount to shift in near the 900 metres when not the required distance clear of **COOGA DOON** which was steadied.

COOGA DOON (M Singh) - Steadied near the 900 metres.

Race 6 LOWE SCHOLLUM JONES 1200m

NUBIAN SMILE (J Baillie) – Slow to begin. Raced keenly in early stages making the bend awkwardly near the 900 metres.

HARRY HARRISON (C O'Beirne) – Slow to begin then crowded shortly after, losing ground.

**SPIDERMAN (D Turner)** – When questioned rider advised the gelding would appreciate more ground and would take natural improvement from the run.

J Baillie (NUBIAN SMILE) - Issued with a warning under Rule 638 (3) (b) (ii) regarding his whip use prior to the 100 metres.

#### Race 7 WANGANUI RACEHORSE OWNERS ASSOCIATION 1360m

**SANCTUM (R Hannam)** - Slow to begin. Rider dropped whip near the 150 metres.

**MR FLYNN (T Johnson)** - Crowded shortly after the start, losing ground. Made the bend awkwardly near the 900 metres shifting out hampering **BLADE RUNNER**. Bumped **SHE'S GOT THE LOOK** passing the 200 metres then tightened having to be restrained near the 150 metres when **LINCOLN DREAMER** lay in simultaneously as **SHE'S GOT THE LOOK** shifted out and away from **SEQUIOA DAWN** which was racing greenly.

BLADE RUNNER (A Goindasamy) – Hampered near the 900 metres.

**GREAT NORTH ROAD (C Johnson)** - Steadied near the 250 metres when **SANCTUM** shifted inwards abruptly before being straightened. R Hannam was advised to exercise care.

SHE'S GOT THE LOOK (R Myers) - Contacted 200 metres.

**SEQUOIA DAWN (H Andrew)** - Raced greenly in the home straight.

**IRISH FLARE (C Grylls)** - When questioned into the performance rider could offer no excuse. A subsequent veterinary inspection was clear.

Race 8 SPORTZ BAR 2060m

Trainer **K Myers** (WHOPPER'S) was questioned regarding the late declaration a rider for WHOPPER'S. K Myers explanation was accepted on this occasion.

**VACATION (D Turner)** - Slow to begin. When questioned regarding performance rider could offer no excuse. Connections advised that the gelding would now be sent for a spell.

**BRASSY BOY (C Grylls)** - Crowded shortly after the start having to be steadied.

PERRY MASON (H Andrew) – Crowded shortly after the start.

ZAC BROWN (B Ansell) - Crowded shortly after the start.

**TIPPERARY MARY (L Allpress)** - Crowded shortly after the start.

**TABOO (C Johnson)** - Raced keenly in the early stages becoming awkwardly placed on the heels of **CORNERSTONE** near the 1,700 metres.

**T Johnson (NO TIP)** - Was spoken to regarding his whip use prior to the 100 metres.

**NO TIP (T Johnson)** - Lay in under pressure in the home straight having to be straightened.

**FINDING NEMO (R Myers)** - When questioned regarding the gelding's performance, rider could offer no excuse. Connections advised that the gelding would now be sent for a spell.

Race 9 OFFICE SMARTS 2060m

J Baillie (PRINCESS JENNIE) – Was examined by St John Paramedics and cleared to ride after being dislodged in the enclosure.

**ZEEDA (M Singh)** - Slow to begin. Raced keenly in the early stages.

**IN DREAMLAND (C O'Beirne)** - Began awkwardly then shifted out clipping the heel of **MAKOURA LODGE** and blundering.

TYCOON ZED (T Johnson) – Slow to begin.

**COUNTRY BUMPKIN (M Hudson)** - When questioned into the performance rider could offer no tangible excuse.
