RACE COMMENTS:

Race 1	CHRIS HAY FARMING LTD (2200 Metres)
The start of Race 1 was delayed approximately 2 minutes due to the position of the starting gates having to be adjusted.	

MATARO (B Ansell) – Awkwardly away, settling back. Raced keenly in the early stages having to be restrained off heels near the 1700 metres.

KION (S McKay) – Hampered and tightened at the start when RELDA shifted outwards abruptly. Also inconvenienced were DO THE TWIST and TYCOON ZED, which settled back.

RELDA (R Myers) – Began awkwardly. Contacted shortly after the start.

DO THE TWIST (L Hemi) – Inconvenienced start, settling back. Held up for a short distance passing the 600 metres and again approaching the 250 metres before being angled outwards across heels gaining clear running over the final stages.

TYCOON ZED (T Johnson) – Inconvenienced start, settling back.

DERECHO (D Hirini) - Tightened and restrained shortly after the start when PASSWORD became awkwardly placed on heels and when being restrained shifted in contacting and dictating RELDA onto DERECHO.

PASSWORD (R Elliot) - Awkwardly placed on heels shortly after the start.

PRINCESS JENNI (J Baillie) - Raced wide without cover in the early stages before being allowed to improve forward to lead near the 1400 metres.

MAKOURA LODGE (D Turner) - Held up approaching the 200 metres going to the line not fully tested.

L Hemi (DO THE TWIST) – Admitted a breach of Rule 638(1)(d) in that she allowed her mount to shift outwards when not clear of WHOLETTHEFOXOUT (C O’Beirne), which was checked near the 50 metres. After hearing submissions, the JCA suspended her licence to ride in races from the close of racing on Sunday, 1 September up to and including Wednesday, 11 September (5 days).

WHOLETTHEFOXOUT (C O’Beirne) – Checked 50 metres.

Race 2	ULTRA SCAN 1100 (1100 Metres)

POWER ‘N’ PASSION (C O’Beirne) – Awkwardly away settling back. Shifted in abruptly approaching the 200 metres, having to be straightened. Continued to lay in under pressure over the final stages.

CROWNING STAR (L Allpress) - Lay inwards early in the home straight. Briefly held up near the 150 metres.

Following the running of Race 2, **L Allpress** on weighing in, failed to draw the correct weight for CROWNING STAR, which placed second, being 1kg under the carded weight. Stewards requested a ruling under Rule 648(3) and after hearing submissions CROWING STAR was disqualified.

L Allpress (CROWNING STAR) defended a breach of Rule 649 (3) in that she weighed in under the carded weight, after hearing submissions the JCA upheld the charge and imposed a fine of \$1,000.

Race 3	MURDOCH CONTRACTING 1100 (1100 Metres)

FIANO (S Weatherley) – Late scratching at 1.21pm on veterinary advice after making contact with the outside fence suffering a laceration to the right hind pastern.

A LITTLE VAGUE (L Hemi) – Began awkwardly.

ZYTHEPSARY (D Hirini) - Hung rounding the turn inconveniencing ELLIA MAY RAHTWO. Continued to hang for the remainder and was not persevered with over the final stages when out of contention.

Race 4 | **SUMMIT HAULAGE 1400 (1400 Metres)**

ANGEL IN DISGUISE (B Ansell) - Slow away then tailed the field throughout. Connections were advised that a warning has been placed against the mare's racing manners.

PARIS COUTURE (D Turner) - Awkwardly away settling back.

MR FLYNN (T Johnson) - Restrained off heels near the 900 metres.

SYNNEFO (C O'Beirne) – Hung throughout, running off the track when in front approaching the 600 metres, inconveniencing DARCINSKY PRINCE. Also affected were COLORADO STAR and DETONATE, which were forced wider on the track near the home straight. SYNNEFO was not persevered with in the home straight and connections were advised the gelding must trial to the satisfaction of stewards prior to starting next. Underwent a post-race veterinary examination which was clear.

DARCINSKY PRINCE (L Allpress) – Inconvenienced 600 metres.

COLORADO STAR (L Hemi) – Inconvenienced 600 metres. Lay in under pressure in the home straight.

DETONATE (M Hudson) - Inconvenienced 600 metres.

OUT TO IMPRESS (S McKay) - Held up approaching the 100 metres and had some difficulty obtaining clear running for the remainder.

J Baillie (NUBIAN SMILE) – Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres and had his licence to ride in races suspended from the conclusion of racing on Thursday, 12 September up to and including racing on Saturday 21 September (6 days).

Race 5 | **GRANGEWILLIAM STUD (1400 Metres)**

GORBACHEV (R Elliot) – Slow away.

LA LANDONNE (R Myers) - Raced three wide without cover throughout making the first bend awkwardly.

Race 6 | **TREADWELL GORDON 1650 (1650 Metres)**

RETZENA (M Singh) - Hung throughout.

MIDNIGHT COUNTESS (M Hudson) - Over-raced early.

GREYSTONE (L Allpress) - Held up approaching the 100 metres having to be angled outwards across heels to improve.

Following the running of this race D Turner who had received a thumb injury earlier in the day requiring treatment by paramedics, advised stewards that he would be unable to fulfill his remaining engagements. D Turner was advised he is to provide a medical clearance prior to his next ride.

Race 7 | **MOORE STEPHENS MARKHAMS 1650 (1650 Metres)**

MAIPE - D Bradley replaced D Turner (injured).

ALBERTO THOR (J Baillie) – Very slow away.

WORDZ (R Elliot) – Slow away.

GO VICTORIA (E McCall) – Tightened at start, settling back.

NELLIE JEAN (Z Moki) - Restrained off heels near the 900 metres.

GREAT NORTH ROAD (C Burdon) - Raced three wide without cover throughout.

MONKEY TOWN (S Weatherley) shifted in when struck with the whip near the 350 metres

KEEPIN HARMONEE (R Myers) - Shifted in and away from MONKEY TOWN near the 350 metres.

Race 8

BRUCE CLIFTON BUILDER 1650 (1650 Metres)

T Johnson (RAISE THE PHANTOM) - Was reminded of his obligations when accepting rides and was replaced by D Turner on Wednesday, after advising stewards he was unable to make the weight. Z Moki then replaced D Turner who was injured.

RAISE THE PHANTOM (Z Moki) –Raced three wide without cover throughout.

THAT’S FUNNY (R Hannam) – Slow away.

HYPATIA (D Hirini) – Held up early in the home straight, gaining clear running near the 200 metres.

CASINO EL JAY (L Hemi) - Raced keenly in the early stages.

MAGIC IVAN (C O’Beirne) – Slow away. Shifted in under pressure in the home straight.

J Baillie (WONDER LASS) - Was spoken to regarding his whip use prior to the 100 metres.
