<b>Race 1</b>	<b>PILET CONTRACTING / PIONEER SEEDS MAIDEN (1400 Metres)</b>
<p><b>HASLER LAD</b> (R Hannam) - Tightened at the start when runners either side shifted ground.</p> <p><b>MINNIE MOUSE</b> (C Johnson) - Raced three wide without cover throughout.</p> <p><b>KIPLING</b> (A Goindasamy) - Held up for a distance near the 500 metres.</p> <p><b>SEQUOIA DAWN</b> (H Andrew) - Held up rounding the final turn.</p> <p><b>HARRY HARRISON</b> (C O'Beirne) – Checked near the 1250 metres, then commenced to race fiercely. Shifted in under pressure passing the 200 metres, having to be straightened.</p> <p><b>M Singh</b> (ROCK WITH CHOUX) – Admitted a breach of Rule 638(1)(d) in that he angled his mount inwards near the 1250 metres when not clear of HARRY HARRISON, which was checked. M Singh had his licence to ride in races suspended from the conclusion of racing on Saturday, 21/9 up to and including racing on Saturday, 28/9.</p>	
<b>Race 2</b>	<b>WATERFORCE / FARMERS TRANSPORT HANDICAP (1200 Metres)</b>
<p><b>R Hannam</b> (DEERFIELD) – Issued with a warning under Rule 638(1)(d) after shifting in shortly after the start dictating SALAMANCA inwards, which resulted in tightening to GRAND MAYSON and PROSECCO.</p> <p><b>SALAMANCA</b> (D Hirini) - Dictated inwards shortly after the start.</p> <p><b>GRAND MAYSON</b> (C O'Beirne) – Tightened shortly after the start. Raced keenly in the early to middle stages.</p> <p><b>PROSECCO</b> (L Hemi) –Tightened shortly after the start. Made the bend awkwardly near the 800 metres then held up for a short distance approaching the 400 metres. Lost the off fore plate during the running.</p> <p>Track upgraded to Slow (9) after Race 2.</p>	
<b>Race 3</b>	<b>JOHN TURKINGTON LTD / MANAWATU TOYOTA HANDICAP (2200 Metres)</b>
<p><b>HAMILTONIAN</b> (A Goindasamy) – Slow away. Raced keenly in the early to middle stages.</p> <p><b>HI I'M NIKKITA</b> (H Andrew) - Raced three wide without cover throughout.</p> <p><b>HIGH QUALITY</b> (C Johnson) - Raced in restricted room for a short distance near the 250 metres.</p> <p><b>MY GIFT</b> (S Collett) - When questioned into performance rider advised the gelding, after being taken on in the lead, had little left at the finish but in her opinion would take natural improvement with the run.</p>	
<b>Race 4</b>	<b>FPA NZ / NUFARM HANDICAP (2200 Metres)</b>
<p><b>EM KAY POPS</b> (M Hudson) - Underwent and passed a veterinary examination after becoming fractious in the barriers. Began awkwardly, settling back. Held up passing the 200 metres having to be angled outwards across heels to improve.</p> <p><b>SPEED CALL</b> (L Hemi) - Slow away.</p> <p><b>HYPATIA</b> (D Hirini) - Raced three wide without cover throughout. Lay in under pressure in the home straight.</p> <p><b>VERACIOUS</b> (M Singh) - Raced keenly in the early stages.</p>	

**MIZZENA** (R Myers) - Raced ungenerously for a short distance passing the 1900 metres, then continued to race keenly in the middle stages. Checked 450 metres when unable to avoid the tiring REDESDALE.

**REDESDALE** (S McKay) – Gave ground quickly from the 600 metres checking MIZZENA near the 450 metres. When questioned into performance rider advised the gelding may appreciate more rain-affected track conditions. A subsequent veterinary inspection was clear.

**TIPPERARY MARY** (L Allpress) – Rider reported she considered something may be amiss with the mare. A subsequent veterinary inspection was clear.

<b>Race 5</b>	<b>H&amp;T AGRONOMICS / AGRICOM HANDICAP (1300 Metres)</b>

**OBRIGADO** (D Hirini) - Restrained from a wide draw. Raced in restricted room over the final stages when ROCK ISLAND LINE (R Hannam) shifted out simultaneously as WHENHARRYMETSADDLE rolled in. R Hannam was advised to exercise care.

**PLAY THE FIELD** (R Elliot) - Raced ungenerously in the early stages.

**TONADILLAS** (A Goindasamy) - Raced wide without cover throughout.

**ROCK ISLAND LINE** (R Hannam) - Lay out under pressure over the final stages.

**J Kamaruddin** (METEORIC LASS) – Admitted a breach of Rule 638(3)(b)(ii) for excessive use of the whip prior to the 100 metres and had his licence to ride in races suspended from the close of racing today up to and including racing on Sunday, 29 September 2019 (10 days).

<b>Race 6</b>	<b>CP WOOL / CARRFIELDS LIVESTOCK HANDICAP (1400 Metres)</b>

**NUCLEAR FUSION** (C Grylls) - Raced ungenerously in the early stages.

**COLORADO STAR** (L Hemi) - Raced wide without cover throughout. Went off stride, becoming briefly unbalanced near the 350 metres. Shifted in under pressure over the final stages.

**NOTHINGLEFTTOLOSE** (K Asano) - Became awkwardly placed on the heels of FLORAL ART passing the 200 metres having to be angled outwards, making contact with FULL SWING, which shifted in.

**FULL SWING** (D Turner) – Contacted 200 metres.

**BAE CORP** (B Ansell) - When questioned into performance rider advised that after being caught wide throughout the mare had little left at the finish.

**FLORAL ART** (C Johnson) - Was inclined to lay out under pressure over the final stages.

**YOUNG SQUIRE** (R Myers) When questioned into performance rider could offer no excuse.

<b>Race 7</b>	<b>BOEHRINGER INGELHEIM METRIC MILE (1600 Metres) (Group III)</b>

**WAIT A SEC** (S Collett) - Slow away. When questioned into performance rider advised that after being slow away the gelding had been unable to make any discernible ground but in her opinion would take natural improvement from the run and would be better suited to a longer distance.

**ROSEWOOD** (L Allpress) - Slow away.

**HERENGAWA** (D Bradley) - Raced three wide without cover throughout.

**NYMPH MONTE** (L Hemi) – Hampered 1200 metres. Hung out rounding the final turn, becoming awkwardly placed on the heels of HERENGAWA near the 350 metres.

**R Elliot** (AUTHENTIC PADDY) – Was issued with a warning under Rule 638(1)(d) after angling his mount out near the 1200 metres when not clear, dictating MAUNA KEA outwards into the line of NYMPH MONTE, which was hampered.

**CR GRACE / MARSH INSURANCE BROKER HANDICAP (1600 Metres)**

**SMOKIN'OAK** (C Johnson) - Began awkwardly settling back.

**DE GAULLE** (D Turner) – Slow away. Lay in under pressure early in the home straight.

**KIRKLAND** (M Hudson) - Raced keenly in the early stages.

**DURHAM** (D Bradley) - Raced three wide without cover throughout.

**MOHAKA** (R Hannam) - Held up when disappointed for a run near the 250 metres prior to being angled inwards and again being disappointed for a run near the 200 metres when BECKIDBOO (A Goindasamy) was angled in in search of a run. A Goindasamy was issued with a warning under Rule 638(1)(d).
