### RACE COMMENTS:

Race 1 TEAM WEALLEANS HURDLE (3500 metres)

WHO CAN TELL (B Thomas - Rantall) - Slow away.

AVE MARIA (K Veenendaal) - Misjudged the fence near the 1900 metres.

HENRY TUDOR (R Cole) - Hit the fence near the 1050 metres. Misjudged the fence near the 900 metres.

JUST GOT HOME (S Phelan) - Hit the fence near the 1050 metres and blundered on landing unbalancing its rider.

CABALLO NOIR (T Moki) - Misjudged the fence near the 1050 metres and the fence near the 200 metres.

**AIGNE** (M Roustoby) – Put in a poor jump at the final fence.

# Race 2 FARMLANDS CO-OPERATIVE HURDLE (3000 metres)

**SIGNOR DAL** (M Cropp) – Raced keenly in the early to middle stages. Pulled up after jumping the fence near the 900 metres. A post-race veterinary examination did not reveal any obvious abnormality.

PRESS MY BUTTONS (M Roustoby) - Jumped indifferently throughout. Pulled up prior to jumping the final two fences.

**MARKWOOD** (T Moki) - Misjudged the fourth fence and landed awkwardly with its rider losing the use of her left iron for some distance.

ALI BABA (R Cole) - Steadied when placed in restricted room passing the 800 metres on the first occasion.

LOOK OUT (A Kuru) - Hit the fence near the 900 metres. Lay out when placed under pressure in the final 100 metres.

MANHATTAN STREET (B Lammas) - Pulled up prior to jumping the final two fences.

MANDALAY (S Fannin) - Held up for a distance passing the 400 metres.

**M Cropp** (SIGNOR DAL) - Reprimanded after continuing to jump the three fences in the back straight, being reminded of his obligation that he must retire his mounts from the race once out of contention.

## Race 3 SWEENY TOWNSEND INSURANCE BROKERS & ROTORUA BOP HUNT CUP (3000 metres)

**HESALLJAZZ** (L Douglas) – Slow away.

FLORENCE IVY (T Moki) - Jumped indifferently throughout.

**SENASSY** (M Roustoby) - Put in a pour jump at the third fence landing awkwardly. Hit the fence near the 1100 metres and near the 900 metres. Pulled up prior to jumping the final two fences. Rider reported that the mare had jumped indifferently throughout and was of the opinion that it may have been in season.

**ZENTANGLE** (R Elliot) - Misjudged the fence near the 1900 metres.

**CLASS ABOVE** (S Fannin) - Raced wide without cover. Pulled up prior to jumping the final two fences.

**HE'S DAN** (E Nicholas)- Misjudged the second to last fence.

### Race 4 T.W. MOORE LTD HWT (2200 metres)

**GUY FOX** (K Veenendaal) – Very slow away (4L).

MONDORANI (B Thomas-Rantall) - Slow away (2L).

**WAGNER** (E Nicholas) - Stumbled leaving the barriers losing ground.

**RODMAR** (R Cole) - Began awkwardly.

**K Veenendaal** (GUY FOX) - Issued with a warning for her whip use prior to the 100 metres.

**R Cole** (RODMAR) – Admitted a charge in that he used his whip on his mount when it was clearly winning the race with the Judicial Committee imposing a fine of \$500.

# Race 5 ROTORUA DISTRICT RDA – FLAIR AMATEUR RIDERS SERIES (1950 metres)

**SIR RITCHIE** (O Helagi) – Slow away.

**ASCOMANNI** (M Northcott) - Began awkwardly losing ground. Raced keenly in the middle stages. Held up for a distance passing the 400 metres.

**TEAPOT** (L Petersen)- Slow to begin. Not preserved with from near the 600 metres. A post-race veterinary examination revealed no obvious abnormality.

**HANDSOME BLUE** (S MacNab) – Raced keenly in the early to middle stages. A post-race veterinary examination revealed no obvious abnormality.

**CARNABY** (S Fannin) - Raced keenly in the early to middle stages. Shifted out when racing keenly near the 1400 metres making contact with DR VELOCIOUS.

**DR VELOCIOUS** (J Grundy) - Contacted and forced wider near the 1400 metres. Raced three wide without cover throughout.

GOODWILL (B Rogerson) - Made the bend awkwardly near the 1400 metres then shifted out.

**C Isdale** (TOORAK TOWER) - Admitted a charge in that he used his whip excessively prior to the 100 metres with the Judicial Committee imposing a fine of \$300.

**NEW YORK JAZZ** (J Fawcett) - Began awkwardly.

### Race 7 FOLLOW THE SIMON'S AND WHEELER'S TO ASCOT 1400

**INTO THE DEEP** (A Goindasamy) - Raced keenly in the early stages. Lay in under pressure passing the 200 metres making contact with MAKING WAVES.

CHARRED (A Calder) - Briefly held up near the 400 metres.

**MAKING WAVES** (C Burdan) – Made the bend awkwardly near the 1200 metres when racing keenly.
