Race 3 NZB INSURANCE PEARL SERIES RACE (1400 metres)
ONE MADISON (O Bosson) – Trainer A Scott advised Stewards that he was satisfied with the recovery of the gelding and it is their intention to continue on with its current preparation.
Race 5 AMBER GARDEN CENTRE 1400

SOKITOME (J Fawcett) – Trainer T Autridge advised Stewards that the gelding would not be persevered with as a racing proposition.

Race 8 VALACHI DOWNS 1200

QUEEN OF THE AIR (M McNab) – Trainer J Richards advised Stewards that in the days following this race the mare underwent blood tests which did not reveal any abnormality, adding it is his intention to continue on with its current preparation.

Auckland Racing Club - 7 September 2019

Race 4 Hyland Race Colours 1400

RUKUHIA (T Thornton) – Trainer G Old advised Stewards that the gelding underwent an operation in the days following this race after a fracture in the right knee was diagnosed by veterinarians, further advising that the gelding would now be sent for a spell to recover.

Wanganui Jockey Club - 7 September 2019

Race 4 THE O'LEARYS FILLIES STAKES 1200

FLAUNTING (S Spratt) – Trainer D Greene advised Stewards that he was satisfied with the recovery of the filly and it is his intention to continue on with its current preparation.

RACE COMMENTS:

Race 1 GCM FEEDS LTD 1600

WHISPER ROCK (A Calder) – Slow away.

TEEN TITAN (C Burdan) – Stumbled badly then was further crowded losing ground. Raced keenly for a distance passing the 1000 metres.

SHARWING (T Thornton) - Raced ungenerously in the early stages. Raced three wide without cover throughout. Was not persevered with from near the 600 metres. Underwent a post-race veterinary examination which did not reveal any abnormality. Trainer L Greer was advised that the mare would be required to trial to the satisfaction of Stewards prior to racing next.

BIRDIE MAY (R Elliot) - Steadied off heels approaching the 1000 metres.

IAN'S LEGACY (C Lammas) - Raced in restricted room for a distance passing the 350 metres.

Race 2 RBC RACING 1600

EL COOLIO (R Smyth) – Slow away then hampered shortly after.

TAREE (A Goindasamy) - Began awkwardly shifting out abruptly hampering EL COOLIO. Held up until passing the 200 metres.

CRITICS CHOICE (C Dell) - Over raced when being restrained in the early stages.

TED WILLDOIT (M Hashizume) - Raced wide without cover for the majority of the race.

GRAND ARIANA (M McNab) - Checked passing the 200 metres.

LILY THE PINK (M Cameron) - Returned to the enclosure with blood present in both nostrils. Underwent a post-race veterinary examination which confirmed the mare to have bled. Connections were advised LILY THE PINK would be stood down from training for two months and racing for three months with a veterinary clearance being required prior to racing or trialing next.

A Goindasamy (TAREE) - Admitted a charge of careless riding in that he permitted TAREE to shift out passing the 200 metres when insufficiently clear of GRAND ARIANA which was checked. After considering submissions his licence to ride in races was suspended by the Judicial Committee from the conclusion of racing on Sunday 22nd September up to an including racing on Friday 4th October 2019, 7 National days.

Race 3 | **THE CLOTHIER FARMS 1400**

DIOGENES (L Innes) – Crowded and steadied shortly after the start. Held up over the concluding stages.

SAILOR JERRY (C Grylls) - Raced keenly in the early to middle stages. Held up rounding the final bend then had some difficulty obtaining clear running for the remainder of the race.

DON'T LIE TO ME (T Thornton) - Raced three wide without cover throughout.

ZAREEBA (D Johnson) – Held up for a distance passing the 350 metres.

Race 4 | **TRANSPORT MECHANICAL WAHAROA LTD 1400**

MARIOTA (J Fawcett) – Began awkwardly losing ground (3L). Declared a non-runner under Rule 632(1), after it was established by the Judicial Committee that the mare had been denied a fair start due to the barrier attendant still having hold of MARIOTA after the start was effected.

JOHNNIE REDMOND (T Yanagida) - Held up until near the 200 metres.

ENJOY THE SHOW (M Cameron) - Rider dropped his whip passing the 300 metres.

GLENHOPE (C Lammas) - Lay in when placed under pressure in the final straight making contact with JOHNNIE REDMOND passing the 200 metres. When questioned regarding performance, rider advised that the gelding had felt flat during the running and had failed to run on. Trainer P Gerrard advised Stewards that the gelding would now be sent for a spell.

Race 5 | **WAHAROA TRANSPORT CO (1995) LTD 1200**

LUCKY SHARK (M McNab) - Crowded and steadied shortly after jumping away.

SUPER SID (O Bosson) - Over raced in the early stages.

HUGH GLASS (T Harris) – Jumped away awkwardly.

HAPPINESS FOREVER (A Goindasamy) - Checked near the 325 metres.

LUSTFUL LADY (A Calder) - Checked near the 325 metres when weakening.

SCORPZ (J Riddell) – Held up for a distance passing the 200 metres having to shift in near the 150 metres to obtain clear running.

FONTS DE L'ALGAR (M Coleman) - Inconvenienced having to shift out passing the 350 metres.

O Bosson - Admitted a charge in that he permitted SUPER SID to shift out when not sufficiently clear of HAPPINESS FOREVER and LUSTFUL LADY which were both checked with the Judicial Committee imposing a suspension on O Bosson's licence to ride in races from the conclusion of racing on Sunday 22nd September up to and including Thursday 3rd October 2019, 6 National days.

Race 6 | **THE ROBERT BRUCE CLOTHIER MEMORIAL**

PRIOR ENGAGEMENT (C Burdan) – Slow away.

Race 7 | **WAHAROA INDUSTRIAL PARK 2000**

KAJINO (M Hashizume) - Underwent a veterinary inspection after being kicked by another runner at the start and was declared a late scratching at 4:04pm.

HOWMUCH TOOMUCH (T Yanagida) - Raced wide without cover for the majority of the race.

KIPLING (A Goindasamy) - Raced keenly in the middle stages.

C Lammas (CAPTAIN RISKY) - Issued with a warning for his whip use prior to the 100 metres.
