## RACE COMMENTS:

<b>Race 1</b>	<b>BAY FORD NZ PUNTER OF THE YEAR 5 OCT (2100 METRES)</b>
<b>CHAMPAGNE BRIDE</b> (L Innes) - Slow away, when questioned regarding performance rider advised that in his opinion the mare may not have backed up from racing seven days ago and would appreciate some easing of the ground.	
<b>YAMUNA</b> (S McKay) - Had to be heavily restrained to avoid heels passing the 1200 metres.	
<b>SOLESEIFEI</b> (C Grylls) - Restrained off heels passing the 600 metres going back onto JONNY RUSS.	
<b>JONNY RUSS</b> (M Singh) - Restrained off heels 550 metres.	
<b>Race 2</b>	<b>FASTTRACK INSURANCE 2000 (2000 METRES)</b>
<b>JACKSSTAR</b> (S McKay) - Slow away.	

**MY GIFT** (C Grylls) - Raced three wide without cover before being allowed to improve forward to lead passing the 1000 metres.

**HELLO M'LADY** (T Thornton) - Raced keenly in the middle stages. Was not persevered with in the final straight after becoming tailed off, with the rider reporting that the mare had felt short in its action on pulling up. A post-race veterinary inspection found the mare to be mildly lame in the right foreleg.

**IN A TWINKLING** (O Bosson) - Contacted near the 300 metres, lay out under pressure inconveniencing **SENTIMENTAL MISS** near the 200 metres.

**SENTIMENTAL MISS** (L Allpress) - Shifted inwards when struck with the whip contacting **IN A TWINKLING** near the 300 metres, inconvenienced 200 metres. Returned to the enclosure with blood present in the right nostril which upon veterinary inspection was found to be from a small laceration.

<b>Race 3</b>	<b>WINDSOR PARK STUD STALLIONS 3YO (1200 METRES)</b>

**ANNA CECELIA** (D Johnson) - Slow away.

**CINZENTO** (D Mansour) - Jumped away awkwardly making contact with **DOUBLE IMPACT**, disappointed for a run between **WITHOUT FLAW** and **SERENA** near the 300 metres when **SERENA** lay in, then striking a heel of **WITHOUT FLAW** and blundering when **WITHOUT FLAW** shifted outwards slightly away from **SERENA**.

**DOUBLE IMPACT** (T Harris) - Contacted start, had to be heavily restrained after improving and becoming awkwardly placed near the heels of **ANNA CECELIA** when the pace steadied near the 900 metres then over-raced for a distance, lay inwards in the final straight making contact with **SERENA** near the 250 metres when that runner shifted outwards after bumping with **WITHOUT FLAW**, continued to lay in for the remainder of the race and could not be fully ridden out.

**WITHOUT FLAW** (S McKay) - Raced ungenerously for a distance when being restrained passing the 1000 metres.

**SERENA** (V Colgan) - Lay inwards early in the final straight bumping with **WITHOUT FLAW** approaching the 250 metres then shifted outwards making contact with **DOUBLE IMPACT**.

<b>Race 4</b>	<b>HASTINGS - HEART OF HAWKE'S BAY 1300 (1300 METRES)</b>

**UNCLE ERN** (D Johnson) - Tightened at the start when **SWORDS DRAWN** began awkwardly making heavy contact with **SAGUNTO** becoming unbalanced, over-raced when being restrained in the early to middle stages, placed in restricted room near the 600 metres when **SENZABEEL** was attempting to gain cover with those two runners making contact and **SENZABEEL** being bumped out onto the hindquarters of **RAZOR**. Apprentice S Johnson was advised to exercise more care.

**RAZOR** (D Turner) - Hindquarters contacted near the 600 metres.

**SENZABEEL** (S Johnson) - Contacted near the 600 metres.

**SAGUNTO** (S McKay) - Contacted and unbalanced at the start, over-raced passing the 1000 metres.

**GERMANICUS** (T Harris) - Hampered shortly after leaving the barriers when **SENZABEEL** shifted away from **WILLY AWAY**.

**CALLSIGN MAV** (C Grylls) - Raced greenly under pressure in the home straight.

**MOTLEY CRUE**(R Elliot) - Lay in under pressure early in the home straight becoming awkwardly placed on the heels of **WILLY AWAY** near the 250 metres.

<b>Race 5</b>	<b>TE AWA WINERY RESTAURANT 1400 (1400 METRES)</b>

**DANGER DEE** (D Johnson) - Hampered leaving the barriers when **FATTORE OTTO** jumped away awkwardly shifting inwards forcing **DANGER DEE** onto **ALLACCIATO**.

**ALLACCIATO** (R Myers) - Contacted leaving the barriers, had to be steadied when placed in restricted room to the inside of **JOE'S LEGACY** approaching the 900 metres. V Colgan was advised to exercise more care. Steadied when placed in restricted room over the concluding stages.

**FATTORE OTTO** (R Hannam) - Jumped away awkwardly, bumped near the 250 metres, briefly held up passing the 200 metres.

**MOTIVATION** (L Innes) - Jumped away awkwardly crowding **HOLY LOCH**, had difficulty obtaining clear running in the home straight making contact with **FATTORE OTTO** near the 200 metres then being held up passing the 200 metres before being angled back to the inside to improve, shifted outward over the final stages inconveniencing **IVAN KANE** just short of the finish. L Innes was advised to exercise more care.

**HOLY LOCH** (L Satherley) - Crowded at the start.

**RIPLEY** (O Bosson) - Shifted outwards to avoid the heels of **MOTIVATION** when over-racing near the 1000 metres, steadied when placed in restricted room over the final stages.

<b>Race 6</b>	<b>HAWKE'S BAY BREEDERS GOLD TRAIL STAKES (1200 METRES)</b>

**JENNIFER ECCLES** (D Mansour) - Steadied when racing in restricted room near the 900 metres, hampered approaching the 300 metres then shifting outwards to attempt a tight run between **BAVELLA**, which had rolled in, and **LOIRE** which then lay in making contact with **JENNIFER ECCLES** which was crowded for a distance.

**HASSTOBEGOOD** (R Elliot) - Had to be firmly restrained when becoming awkwardly placed near the heels of **TRIFOLIUM** near the 850 metres losing ground going back onto **APELLANT** which was hampered near the 800 metres.

**APELLANT** (D Johnson) - Hampered near the 800 metres.

**FIRST ROCK** (R Hannam) - Raced three wide without cover.

**RUBY NEGRONI** (A Jones) - Raced wide without cover.

**KALI** (T Harris) - Held up rounding the final turn and early in the straight, when shifting outwards in an attempt to obtain clear running approaching the 300 metres hampered **JENNIFER ECCLES** which was attempting to improve to its outside, badly held up near the 200 metres and did not obtain clear running until inside the final 100 metres.

**LOIRE** (M Coleman) - Lay in passing the 300 metres becoming unbalanced when making contact.

**RIVA CAPRI** (C Grylls) - Held up rounding the final turn and then was unable to obtain clear running over the final 200 metres going to the line without being fully tested.

Following the race a protest was lodged by the connections of the 4<sup>th</sup> placed horse **JENNIFER ECCLES** alleging interference by the 3<sup>rd</sup> placed horse **LOIRE** passing the 300 metres. After viewing films and hearing submissions the Judicial Committee dismissed the protest.

<b>L INNES</b> (BAVELLA) - Issued with a warning for his whip use prior to the 100 metres.	
<b>Race 7</b>	<b>LI REDSHAW MEMORIAL (1200 METRES)</b>
<p><b>MISS CONTESSA</b> (C O'Beirne) - Dislodged its rider commencing the preliminary and escaped, after being recaptured MISS CONTESSA underwent a veterinary being passed suitable to race. As a result the race started approx. 4 minutes late.</p> <p><b>THE MITIGATOR</b> (S McKay) - Jumped away awkwardly and shifted outwards hampering HUGO THE BOSS and SCANDALO.</p> <p><b>HUGO THE BOSS</b> (C Grylls) - Hampered start, raced wide without cover.</p> <p><b>SCANDALO</b> (D Hirini) - Hampered start.</p> <p><b>SANTA MONICA</b> (M Hashizume) - Restrained in the early stages to shift to a position closer to the running rail after jumping from an outside barrier.</p> <p><b>JESSIEGEE</b> (L Allpress) - Held up passing the 300 metres.</p> <p><b>S McKay</b> - After reviewing film footage a charge in that S McKay used the whip excessively on his mount THE MITIGATOR prior to the 100 metres was issued with the matter to be heard at Te Rapa Racecourse on Wednesday 25 September 2019.</p>	
<b>Race 8</b>	<b>WINDSOR PARK PLATE (1600 METRES)</b>
<p><b>WYNDSPELLE</b> (D Bradley) - Slow away.</p> <p><b>DARK PRINCESS</b> (L Allpress) - Tightened at the start when CROWN PROSECUTOR jumped outwards being forced onto SULTAN OF SWING, crowded and checked near the 1400 metres, held up near the 300 metres.</p> <p><b>C LAMMAS</b> - Defended a charge of careless riding in that he permitted his mount HELLO IT'S ME to shift inwards when not sufficiently clear crowding SULTAN OF SWING onto DARK PRINCESS near the 1400 metres. After viewing films and hearing evidence the Judicial Committee found the charge to be proven suspending C Lammas from the conclusion of racing on Wednesday 25 September until the conclusion of racing on Wednesday 9 October, 9 national riding days.</p> <p><b>SULTAN OF SWING</b> (S Weatherley) - Hampered at start, crowded near the 1400 metres.</p> <p><b>ATLANTA PEACH</b> (T Harris) - Tightened start when runners to either side jumped away awkwardly.</p> <p><b>VIGOR WINNER</b> (S Spratt) - Raced three wide without cover before improving to sit outside the leader near the 800 metres, bumped near the 250 metres when MONGOLIAN MARSHAL attempted a marginal run to the outside of SHADOWS CAST. When questioned into performance rider S Spratt could offer no tangible explanation. A post-race veterinary inspection did not reveal any abnormality.</p> <p><b>HELLO IT'S ME</b> (C Lammas) - Held up rounding the final turn and continued to have difficulty obtaining clear running for much of the straight.</p> <p><b>CROWN PROSECUTOR</b> (C Grylls) - When questioned regarding performance rider C Grylls could offer no tangible excuse. A post-race veterinary inspection did not reveal any abnormality.</p>	
<b>Race 9</b>	<b>FAREWELL AND THANKS BARRY HOWES 1400 (1400 METRES)</b>

**TIGHTLIGN** (C Grylls) - Reared when the start was affected unbalancing the rider for a short distance and settling back.

**O BOSSON** (FELAAR) - Issued with a warning after permitting his mount to shift inwards passing the 1200 metres placing AWESOME AL, which was over-racing, in restricted room for a distance.

**AWESOME AL** (C O'Beirne) - Crowded for a distance when over-racing passing the 1200 metres.

**JUSTAMAIZ** (S Spratt) - Held up rounding the final turn then again being held up near the 175 metres.

**LINCOLN HILLS** (R Hannam) - Briefly steadied near the 250 metres when SIR NATE shifted outwards to obtain clear running.
