RACE COMMENTS:

Race 1	SELLAR & SELLAR CHARTERED ACCOUNTANTS MAIDEN 2050 (2050 Metres)

WHOLETTHEFOXOUT (C O'Beirne) – Was declared a late scratching at 12.23pm on veterinary advice after dislodging the off-fore plate and was found to be lame with a puncture on the sole. Connections have been advised that the gelding will require a veterinary clearance prior to racing next. The start of Race 1 was delayed by approximately 4 minutes while WHOLETTHEFOXOUT was returned to the enclosure.

E McCall (CRISTAL BUBBLE) – Was issued with a warning for her whip use on the mare when it was proving reluctant to load.

PARIS COUTURE (D Turner) - Bounded at the start, contacted PONDERING. Hampered 1800 metres.

PONDERING (B Ansell) – Contacted start. Hung in the early stages, making the bend near the 1800 metres awkwardly, hampering PARIS COUTURE and OVERDUE which were forced wider on the track, then raced wide without cover for the remainder.

OVERDUE (J Parkes) – Hampered 1800 metres. Lay in under pressure in the home straight. When questioned into performance rider could offer no excuse.

DUNDEE STREET (J Riddell) - Briefly held up near the 300 metres having to be angled outwards across heels to gain clear running passing the 200 metres.

ROX (L Allpress) – When questioned into performance rider advised the mare may not have appreciated today's track conditions.

Race 2	NZB INSURANCE PEARL SERIES RACE (1000 Metres)

AMOSIA (R Hannam) – Began awkwardly settling back. Briefly inconvenienced 900 metres.

ROMMEL (D Mansour) – Slow away. Raced greenly across the junction on to the course proper, briefly inconveniencing AMOSIA.

KUASA KUDA (D Hirini) - Shifted out abruptly shortly after the start making contact with the hind quarters of BABY CHEESES, briefly unbalancing that runner.

BABY CHEESES (C Lammas) – Contacted shortly after the start.

D Mansour (ROMMEL) – Was spoken to regarding his whip use prior to the 100 metres.

Race 3	PGG WRIGHTSON MAIDEN 1000 (1000 Metres)

OUTA CASH (R Hannam) - Tightened shortly after the start when POKURU'S GIFT (R Myers) shifted in when not entirely clear, also inconveniencing MRS BROWN. R Myers was advised to exercise greater care.

MRS BROWN (D Turner) – Inconvenienced shortly after the start. Returned to the enclosure with a superficial laceration to the hip area and was attended to by the veterinary surgeon.

SCHOONER O'CEIRIN (M Hudson) - Raced keenly in the early stages having to be restrained near the 800 metres.

POKURU'S GIFT (R Myers) - Shifted out near the 200 metres briefly inconveniencing TRANSITORY.

TRANSITORY (C O'Beirne) – Briefly inconvenienced 200 metres.

HERE COMES TROUBLE (L Allpress) - Rider reported that something may be amiss with the filly. A post-race veterinary examination was clear.

SARAH SARAH (B Ansell) – Returned to the enclosure with blood present in the nasal area. After undergoing a veterinary inspection including an endoscopic examination, the mare was confirmed to have bled. SARAH SARAH is now unable to be in training for two months and is unable to trial or race for three months with a veterinary clearance required prior to racing or trialling next.

R Hannam (OUTA CASH) – Was spoken to regarding his whip use prior to the 100 metres.

Race 4	NZB INSURANCE PEARL SERIES RACE (1000 Metres)

FIANO (B Ansell) - Slow away.

RUBY ROCKS (R Goldsbury) – Tightened at the start, clipping a heel and dislodging the rider when SUPER GIRL (J Riddell), which knuckled leaving the barriers, shifted in tightening CAN I GET AN AMEN (D Mansour), OHMS (M Singh) and BLOODWOOD (L Hemi), simultaneously as FINE LEG (H Andrew) shifted out dictating BELLA (L Allpress). R Goldsbury was tended to by St John paramedics and cleared to ride.

SUPER GIRL (J Riddell) - Knuckled leaving the barriers.

CAN I GET AN AMEN (D Mansour) - Tightened at the start.

OHMS (M Singh) - Tightened at the start, losing ground, then inconvenienced by the rider less RUBY ROCKS near the 800 metres.

BLOODWOOD (L Hemi) – Tightened at the start.

BELLA (L Allpress) – Dictated start.

Race 5	JOHNSON BROTHERS MAIDEN 3YO 1400 (1400 Metres)

FIDDYAFORTNIGHT (L Allpress) - Contacted at the start when LA MIA SIRENA began awkwardly.

LA MIA SIRENA (D Bradley) - Began awkwardly. Inconvenienced 350 metres.

C O'Beirne (POWER 'N' PASSION) – Issued with a warning under Rule 638(1)(d) after allowing her mount to shift out abruptly early in the home straight inconveniencing LA MIA SIRENA.

LADY GODIVA (H Andrew) - Disappointed for a run passing the 200 metres.

EXCITONIC (R Myers) – When questioned rider could offer no excuse.

T Johnson (CLOWNIN AROUND) - Was spoken to regarding his whip use prior to the 100 metres.

Race 6	WAIRARAPA ELECTRICAL MAIDEN 1400 (1400 Metres)

ALBARON (J Riddell) – Slow away.

R Myers (MANINTHESKY) – Was issued with a warning under Rule 638(1)(d) in that she allowed her mount to shift in near the 1200 metres tightening CAPELYN and THIS LADY ROCKS.

THIS LADY ROCKS (M Singh) - Raced keenly in the early stages. Tightened 1200 metres then contacted near the 1000 metres.

RIPEMGINI (D Bradley) – Hampered 1000 metres. Held up for a distance rounding the turn behind the tiring **BLUE DANN**.

BLUE DANN (E McCALL) - Tightened near the 1000 metres making contact with the running rail losing ground when **CAPELYN** lay in making contact with **THIS LADY ROCKS**, which contacted **BLUE DANN**, which went back on to **RIPEMGINI**.

CAPELYN (D Mansour) – Raced three wide without cover. Tightened 1200 metres then steadied when placed in restricted room approaching the 400 metres.

EMPOWER (H Andrew) - Raced wide without cover.

BERRY DELIGHTFUL (D Turner) – Steadied near the finish when **MANINTHESKY** shifted out.

RELIABLY PERKY (L Hemi) – Rider reported she felt something may be amiss with the mare. A subsequent veterinary inspection revealed the mare to be lame in the right hind and will require a veterinary clearance prior to racing next.

Race 7 | **MOBIL CARTERTON MAIDEN 1600 (1600 Metres)**

RAUCOUS (C Lammas) -Slow away, then raced ungenerously in the early stages, making the bend near the 1000 metres awkwardly with a tendency to get its head in the air.

AFTER YOU (J Riddell) - Began awkwardly contacting **PLATINUM BORDEAUX**, then tightened having to be restrained shortly after when **PLATINUM BORDEAUX** shifted out and away from **CARDINAL O’CEIRIN**.

PLATINUM BORDEAUX (D Bradley) - Contacted start. Briefly inconvenienced 250 metres.

CARDINAL O’CEIRIN (M Hudson) – Raced keenly for a distance in the back straight.

MANHATTEN AFFAIR (D Hirini) - Shifted out under pressure in the home straight briefly inconveniencing **PLATINUM BORDEAUX**.

THE FONZE (H Andrew) – Raced wide without cover throughout.

DOUBLE ACT (J Parkes) – Lay inwards early in the home straight having to be straightened.

GOLD STRIKE (C O’Beirne) - When questioned into performance rider could offer no excuse.

Race 8 | **LIQUORLAND MASTERTON R65 1400 (1400 Metres)**

STORMY HABIT (B Ansell) – Underwent a pre-race veterinary inspection after making contact with a rail leaving the enclosure and was cleared to start. Returned to the enclosure with blood present in the left nostril. A subsequent veterinary examination revealed a superficial laceration.

ARTAXERXES (L Hemi) - Had to be steadied when awkwardly placed on heels near the 1000 metres, going back on to **SAVANAH BELLE**, which had to be steadied.

SAVANAH BELLE (L Allpress) – Had to be steadied 1000 metres.

HUNDYAMONTH (M Hudson) – Wide without cover throughout.

VEUVE CLICQUOT (H Andrew) – Raced wide without cover.

R Goldsbury (DON'T KNOW JAKK) – Issued with a warning under Rule 638(3)(b)(ii) with regard to her whip use on a runner out of contention.
