<b>Race 1</b>	<b>BAYLEYS TARANAKI 1600M</b>

**THAT'S FUNNY** – Slow away.

**SO IT WAS** – Slow away.

**TIRO** (H Schofer) – Awkwardly away settling back.

**ZEEFA ZED** (D Turner) – Restrained off heels near the 1100 metres.

**IVAN KANE** (C Grylls) – Raced keenly in the middle stages.

**MAV** (D Danis) – Raced three wide without cover throughout.

**KIT KAT** (M Singh) – Raced three wide without cover throughout.

**BRIAN BORU** (J Parkes) – Inconvenienced near 350 metres.

**VERY APPEALING** (J Riddell) – Held up for a short distance approaching the 400 metres, then when shifting out to obtain clear running inconvenienced BRIAN BORU near the 350 metres. Came together with DUKE OF PLUMPTON making brief contact near the 200 metres.

**LINCOLN DREAMER** (R Elliot) – Ran up on to the heels of SO IT WAS and had to be steadied passing the 200 metres. R Elliot was of the opinion the gelding is more suited to more rain affected going.

**H Andrew** (ZENA BELLE) – Was spoken to advisedly regarding her whip use prior to the 100 metres.

**Trainer C Cole** – Fined \$50 under the Minor Infringement Schedule after failing to declare a rider for MAV by the required time.

<b>Race 2</b>	<b>ROUGH HABITS/HUB CATERING 1600M</b>

**BLANCO BELLE** (L Hemi) – Underwent a veterinary examination behind the barrier after receiving a kick and was cleared to race.

**RIPCORD** (R Myers) – Slow away. Was unable to be ridden out fully to the finish and went to the line untested after ROCK ISLAND LINE shifted out when not clear. K Asano subsequently admitted a charge of careless riding under Rule 638(1)(d) and had his licence to ride in races suspended from the conclusion of racing on 13/10 – 20/10 inclusive (5 days)

**LORDE HAVE MERCY** (D Danis) – Slow away.

**HANK MOODY** (J Riddell) – Slow away.

**WAISAKE** (D Turner) – Restrained from an outside draw settling back.

**BIG BEN** (H Schofer) – Raced wide without cover.

**ROCK ISLAND LINE** (K Asano) – Shifted out under pressure over the final stages.

**NOT SANTA** (L Allpress) – When questioned regarding performance rider advised that the mare had been inclined to over race in a fresh state and had been unable to finish the race off, adding that it would derive benefit from the run.

**Z Moki** (LORD TURBO) – Was issued with a warning under Rule 638(1)(d) after allowing her mount to shift in near the

800 metres when not fully clear of RIPCORD which was steadied.	
<b>Z Moki</b> (LORD TURBO) – Issued with a warning under Rule 638(3)(b)(ii) in that she used her whip excessively prior to the 100 metres	
<b>Race 3</b>	<b>MARK FROST ELECTRICAL 1200M</b>
<b>DARCI PALMER</b> (C Grylls) – Knuckled at the start settling back.	
<b>BRING TO THE BLOCK</b> (L Hemi) – Restrained from a wide draw.	
<b>Race 4</b>	<b>TOMMO'S TYRES 2100M</b>
<b>DA JIN CHAN</b> – Was a late scratching behind the barriers at 1.45 pm acting upon veterinary advice after making contact with the wheel of the starting gates resulting in a laceration to the right stifle.	
<b>HYPATIA</b> (L Allpress) – Awkwardly away settling back. Lay in under pressure in the home straight.	
<b>SPEED CALL</b> (L Hemi) – Began awkwardly settling back.	
<b>FULLY CHARGED</b> (B Ansell) – Raced wide without cover throughout.	
<b>RUFFY RAHTWO</b> (H Schofer) – Had difficulty obtaining clear running in the home straight going to the finish not fully tested.	
<b>HUMBLE PIE</b> (A Calder) – Raced keenly in the early to middle stages. Briefly tightened near the 200 metres when FULLY CHARGED shifted in marginally	
<b>Race 5</b>	<b>SOUTH TARANAKI CLUB EGMONT CUP OPN HCP 2100M</b>
<b>DR WATSON</b> (B Ansell) – Slow away.	
<b>CHARLIE HORSE</b> (D Turner) – Began awkwardly settling back.	
<b>THE POORMANZABEEL</b> (A Goindasamy) – Raced ungenerously early and again for some distance near the 1500 metres making the bend into the back straight awkwardly.	
<b>ITALIAN LOVER</b> (M Singh) – Raced keenly in the middle stages.	
<b>HI I'M NIKKITA</b> (R Hannam) – Rider dropped whip near the 300 metres.	
<b>GORBECHEV</b> (R Elliot) – Held up rounding the final turn. Continued to have some difficulty obtaining clear running early in the home straight.	
<b>NYMPH MONTE</b> (L Hemi) – When questioned into performance rider could offer no excuse	
<b>IN A TWINKLING</b> (C Grylls) – Rider could offer no excuse. D Bradley was of the opinion the mare was better suited to more rain affected going.	
<b>Race 6</b>	<b>MCCURDY TRUCKS 1400M</b>
<b>PLATINUM INVADOR</b> (K Asano) – Began awkwardly settling back.	
<b>MARS BARS</b> (A Goindasamy) – Slow away.	

**TIGHTLIGN** (C Grylls) – Restrained off heels near the 1000 metres.

**RESURRECT** (D Dannis) – Lay in under pressure early in the home straight.

**BEAUDEN** (R Elliot) – Had some difficulty obtaining clear running early in the home straight before being angled outwards across heels to improve near the 200 metres.

**Race 7** | **RICH HILL STUD TARANAKI BREEDERS STAKES WFA 1400M**

**MYRTLE** (R Goldsbury) – Raced three wide without cover throughout. Made the home straight corner awkwardly after receiving a bump from LIVIN' ON A PRAYER to its inside. This resulted in MYRTLE shifting out hampering QUEEN OF DIAMONDS, TUTORO PEARL, ART DECO and DARSCAPE PRINCESS.

**JESSIEGEE** (L Allpress) – Held up entering the home straight gaining clear running approaching 100 metres.

**SECRET ALLURE** (R Myers) – Held up entering the home straight before being angled inwards to improve near the 250 metres.

**HENI** (D Hirini) – Held up near the 500 metres having to be restrained entering the home straight before angling inwards across heels to improve approaching the 100 metres.

**LUPELANI** (D Turner) – Held up rounding the final turn gaining clear running approaching the 200 metres

**NICOLETTA** (J Riddell) – Disappointed and finished well back. J Riddell had no tangible excuse but was of the opinion the mare would take natural improvement with the run.

**TE TORO PEARL** (D Bradley) – Reported the mare over raced throughout and had little left at the finish. D Bradley was of the opinion the mare was better suited to more rain affected going.

**Race 8** | **SEAVER CYCLES/MASPORT MOWERS 1400M**

The start of this race was delayed after BELLA PADOZA (B Ansell) dislodged its rider during the preliminary taking some time to be recaptured. BELLA PADOZA under-went a veterinary inspection and was cleared to run.

**VEGA** (D Turner) – Gave ground quickly approaching the 800 metres and was not persevered with in the home straight when well out of contention. VEGA underwent a veterinary examination which was clear. Connections were advised the gelding must trial to the satisfaction of stewards prior to its next start.

**MISS FREELOVE (D Bradley)** – Raced three wide without cover. Rider dropped whip near the 150 metres.

**SKY HI RAHTWO** (L Hemi) – Held up approaching the 400 metres gaining clear running entering the home straight.

**Race 9** | **CARRFIELDS LIVESTOCK 1400M**

**Z Moki** (VENCEDORA) – Was fined \$100 under the Minor Infringement Schedule for failing to claim down to declared riding weight.

**ROSCHANA** (B Ansell) – Tightened at the start settling back.

**GO JAMES** (T Taiaroa) – Had a tendency to over race in the middle stages shifting outwards to avoid the heels of HARRY HARRISON near the 800 metres hampering WILLY AWAY.

**WILLY AWAY** (A Calder) – Hampered when forced three wide passing the 800 metres.

**WHATA RED PRINCE** (J Parkes) – When questioned J Parkes said the gelding was disappointing. A subsequent veterinary examination did not reveal any abnormality.

**GOBUYIT** (H Andrew) – Raced wide without cover throughout.

**MY FATHER'S GUN** (D Turner) – Held up approaching the 400 metres having difficulty obtaining clear running until near the 100 metres.

**H Andrew** (GOBUYIT) – Was spoken to about her whip use in the final straight.

**RHAPSODY IN BLUE** (C Grylls) – Held up near the 300 metres. When questioned into performance rider had no tangible excuse.
