# **GENERAL:**

C Lammas did not attend the meeting due to personal circumstances.

## RACE COMMENTS:

Race 1 CARLTON EVENTS 2200

**DEEJAY MAC** (A Goindasamy) - During the preliminary the left iron became detached with the rider then in some difficulty before being dislodged towards the end of the 2400 metre chute and DEEJAY MAC making slight contact with the outside fence. DEEJAY MAC was passed fit to run following a veterinary inspection behind the barriers with the saddle being adjusted. Apprentice Goindasamy was reminded to thoroughly check his gear prior to weighing out as the buckle had not been properly attached. When questioned regarding performance rider advised that the gelding had found today's track conditions too firm and would be better to some easing of the ground. A post race veterinary inspection did not reveal any abnormality.

**DOUGIE** (A Calder) - Dropped its head as the start was effected and was slow away as a result. Commenced to over race shortly after the start improving quickly inside the heels of SULIMAN (V Colgan) when that runner was shifting in with DOUGIE then racing in restricted room briefly before V Colgan immediately relieved the pressure.

## Race 2 CHEVALIER PRODUCE 1600

PLUSHENKO (J Fawcett) - Slow to begin.

THE LAST TSUNAMI (C Burdan) - Slow to begin.

**LEITRIM LAD** (T Thornton) - Raced in restricted room shortly after the start and was steadied. Held up behind the weakening WILD LIKE passing the 300 metres.

**CAPTIVE** (S Spratt) - Inconvenienced rounding the final turn passing the 450 metres then had difficulty obtaining clear running throughout the final straight. Lost the front left plate during the running.

LOUIS FOURTEEN (S Collett) - Raced three wide without cover.

**CLEVER APPROACH** (C Grylls) - Had to be restrained when improving onto heels passing the 600 metres and shifted outwards inconveniencing CAPTIVE near the 450 metres.

GRAVITELLE (L Innes) - Held up near the 250 metres and did not obtain clear running until near the 100 metres.

**WILD LIKE** (V Colgan) - Lay out rounding the bend. When questioned regarding performance rider advised the gelding had never travelled comfortably with a post race veterinary inspection found the gelding to have suffered from cardiac arrhythmia with an appropriate veterinary clearance required prior to racing again.

**NOT USUAL DREAM** (T Harris) - Held up from near the 350 metres until near the 200 metres.

Race 3 AUCKLAND CO-OP TAXIS 2400

WHERE ARE YOU (S Weatherley) - Began awkwardly.

**DELUXE EDITION** (R Scott) - Contacted shortly after leaving the barriers and steadied.

**HESALLJAZZ** (A Goindasamy) - Over raced in the early to middle stages.

**EACH WAY** (R Myers) - Held up rounding the final turn and was unable to obtain clear running until near the 100 metres.

Race 4AGROWQUIP JOHN DEERE 1200GREYVEE (R Myers) - Lost the left hind plate during the running.

**BIT LIPPY** (E McCall) - Began awkwardly then further hampered when crowded. Had some difficulty obtaining clear running in the final straight until inside the final 100 metres.

**SAINTLY WAY** (S Weatherley) - Restrained in the early stages from a wide barrier. Contacted passing the 200 metres.

**MUSSOLINI** (V Colgan) - Restrained in the early stages from a wide barrier. Unbalanced when receiving contact to its hind quarters by BIT LIPPY rounding the bend near the 400 metres.

**A Goindasamy** - Defended a charge of careless riding in that he permitted his mount DESTINATION to shift inwards when not sufficiently clear of ERIDANI which was checked near the 800 metres going back onto KYLIE BAX which was also hampered having to shift outwards to avoid that runners heels. After viewing films and hearing submissions, the Judicial Committee found the charge to be proven suspending A Goindasamy's licence to ride at race meetings from the conclusion of racing on Saturday 9th November until the conclusion of racing on Thursday 21<sup>st</sup> November 2019, 9 National days.

**ERIDANI** (S Collett) - Had to be checked to avoid the heels of DESTINATION approaching the 800 metres. Required Veterinary attention following the race for two small wounds to a hind leg after being gallop on during the running.

**KYLIE BAX** (O Bosson) - Hampered having to shift outwards to avoid the heels of ERIDANI approaching the 800 metres. When questioned regarding performance rider advised that the mare had failed to finish the race off over the concluding stages and in his opinion maybe better suited to some easing of the ground. A post race veterinary examination did not reveal any obvious abnormality.

**SWEET NINETEEN** (J Waddell) - Hampered having to be steadied away from the heels of KYLIE BAX near the 800 metres.

**SOCIALIGHTS** (C Grylls) - Hampered near the 800 metres having to shift outwards to avoid the heels of SWEET NINETEEN hampering CIN CIN which was forced wider. Made contact with SAINTLY WAY when attempting to obtain clear running passing the 200 metres.

CIN CIN (C Burdan) - Hampered and forced wider passing the 800 metres.

LOOKSEASY (T Yanagida) - Raced wide without cover throughout.

DAWN JESSIE (S Spratt) - Raced three wide without cover throughout.

**DESTINATION** (A Goindasamy) - Had a tendency to lay out throughout the race making the final turn awkwardly.

Race 5 POWERSAFE ELECTRICAL WHOLESALERS 1200

JUSTACANTA (R Myers) - Slow away. Had to shift ground outwards across heels to obtain clear running near the 250 metres.

**ON POINT** (J Fawcett) - Raced three wide without cover.

SPRING HEAT (C Grylls) - Held up until near the 200 metres

CAMPARI (L Innes) - Had difficulty obtaining clear running until passing the 100 metres.

**CYBER ATTACK** (V Colgan) - When questioned regarding performance rider advised that the gelding had travelled well enough but had been unable to finish the race off over the concluding stages and in his opinion would be better suited by some easing of the ground. A post race veterinary examination did not reveal any abnormality.

## Race 6 CARBINE CLUB TROPHY (1400 meters)

**BEAUDEN** (R Elliot) - Made contact with the running rail leaving the birdcage being declared fit to run after undergoing a veterinary inspection behind the barriers.

AIM SMART (O Bosson) - Began awkwardly losing ground.

**FINAL SUGGESTION** (C Burdan) - Raced three wide without cover. Received veterinary treatment post-race after showing signs of lameness in front with a veterinary clearance required prior to racing again.

JAKKALBOMB (R Myers) - Made the final turn awkwardly running wide.

Race 7 OMF STAKES (2000 meters)

ZACADA (J Riddell) - Restrained leaving the barriers.

**CONCERT HALL** (M Cameron) - Restrained leaving the barriers. Inconvenienced passing the 200 metres having to steady and shift outwards across the heels of PESO to obtain clear running. Lost the right hind plate during the running.

**RED SIERRA** (S Collet) - Steadied near the 200 metres when VIN DE DANCE shifted in slightly. When questioned S Collett advised that she had felt the gap she was attempting between SAINT EMILION and VIN DE DANCE was closing adding that her instructions had been that RED SIERRA performs best when ridden in clear space so she had opted to shift outwards across the heels of VIN DE DANCE but had then had to correct her mount to avoid causing interference to CONCERT HALL. RED SIERRA was then unable to obtain clear running for the remainder of the race.

**FISCAL FANTASY** (L Innes) - Raced in restricted room and contacted when ROGER THAT sifted inwards under pressure near the 150 metres before being corrected.

J Waddell - Issued with a warning after permitting his mount to shift inwards making contact with FISCAL FANTASY near the 150 metres.

**L Innes** - Admitted a charge in that he used the whip excessively prior to the 100 metres being nine strikes consisting of three strikes consecutively followed by another six consecutive strikes following a pause. After viewing films and hearing submissions the Judicial Committee imposed a fine of \$1500.

Race 8 HALO CONSULTING 1600

CHERRY LANE (R Smyth) - Began awkwardly then crowded losing ground.

**PAISLEY PARK** (T Thornton) - Began awkwardly then crowded losing ground. Held up approaching the 200 metres and was unable to obtain clear running for the remainder of the race.

ORAKEI OVERLORD (R Myers) - Restrained from a wide barrier.

**PINMEDOWN** (R Kozaki) - Got its head up when being restrained in the early stages. Held up early in the straight having to be checked when improving onto the heels of ALIGNS WITH ME near the 250 metres and continuing to have difficulty obtaining clear running until near the 50 metres.

**CONTESSA VANESSA** (R Elliot) - Crowded approaching the 120 metres.

**ALL ROADS** (C Dell) - Hampered when crowded approaching the 1200 metres. Raced three wide without cover for the majority of the event.

ALIGNS WITH ME (S Weatherley) - Crowded approaching the 1200 metres. Lost a right front plate during the running.

**POKER FACE** (S Spratt) - Steadied when awkwardly placed near the heels of ALL ROADS rounding the bend near the 400 metres.

**C Burdan** - Issued with a warning after permitting her mount to shift inwards approaching the 1200 metres when not fully clear of ALL ROADS.

Race 9	CORPORATE SCAFFOLDING 1400

**RENDITION** (R Myers) - Slow to begin (3L).

**WOODHILL ROAD** (J Waddell) - Steadied passing the 1200 metres when awkwardly placed inside the heels of HUMBUCKER which was steadied. Inconvenienced when weakening near the 250 metres when BLACKROCKSDETOX shifted outwards. V Colgan was advised to exercise greater care.

**BLACKROCKSDETOX** (V Colgan) - Began awkwardly. Over raced passing the 900 metres having to be firmly restrained for a distance when improving onto the heels of SILVER LAKE making contact with the hind quarters of RIVERFALLS near the 700 metres.

ALL THE RAGE (T Thornton) - Raced three wide without cover.

**RIVERFALLS** (L Satherley) - Hindquarters contacted 700 metres. Held up entering the final straight. When questioned regarding performance, rider was of the opinion that the filly was not entirely comfortable on today's firmer track conditions.

V Colgan - Spoken to regarding his whip use on consecutive strides.

Race 10 BARFOOT & THOMPSON 1600

Trainer **S Ralph** - Fined \$50 under the minor infringement schedule after presenting MANRICO without items of notified gear.

LIVVY LASS (R Elliot) - Slow to begin. Held up in the straight until obtaining clear running near the 200 metres.

**DEELS DONE** (M Coleman) - Began awkwardly.

MALIK (J Riddell) - Began awkwardly.

**GALWAY BRO** (R Myers) - Shifted away from MANRICO when placed in restricted room to the inside of that runner crowding RUSAVY near the 1300 metres.

**RUSAVY** (T Yanagida) - Crowded 1300 metres.

**O Bosson** - Issued with a warning after angling his mount SWORDS DRAWN to shift outwards to obtain clear running near the 400 metres forcing VAN DIAMOND out onto MALIK which was unbalanced.

VAN DIAMOND (C Grylls) - Forced outwards 400 metres,

MALIK (J Riddell) - Unbalanced when contacted and forced outwards 400 metres.

MORRIS LASS (S Spratt) - Was unable to obtain clear running throughout the final straight.

**GERMANICUS** (T Harris) - Hung outwards throughout and was unable to be ridden out in the final straight with the rider advising in his opinion the gelding is better suited to racing on left handed tracks . Trainer D Guy was advised that GERMANICUS would be required to trial satisfactorily right handed before racing right handed again.

**EL COOLIO** (T Thornton) - Held up rounding the final turn and early in the straight before obtaining clear running near the 300 metres.

ANATOW (S McKay) - Had to steady and shift outwards to obtain clear running passing the 350 metres

M Coleman - Issued with a warning for his whip use prior to the 100 metres.

T Thornton - Spoken to regarding her whip use in consecutive strides prior to the 100 metres.
